

Several digital photographs were taken of Elliot Rodger's injuries and booked into Forensics as evidence.

C.)Narrative:

On 07-21-13, at approximately 1221 hours, Cpl. Pierce and I were dispatched to Goleta Valley Cottage Hospital for a report of a battery that occurred on Del Playa Dr. the night prior. Upon our arrival, I contacted Elliot Rodger in the lobby of the Emergency Room. Upon speaking with Rodger, he informed me of the following:

On 07-20-13, at approximately 2330 hours, he was at a party, which was later determined to be at 6644 Del Playa Dr., when he got into a verbal alternation with four male subjects. He said during the alternation he called one of the subjects "Ugly" prior to being pushed off a 10 foot high ledge. He said he fell off the ledge onto the sidewalk and then stumbled his way into the front yard of 6632 Del Playa Dr.

He said when he walked into the front yard he found a chair and sat down. He said several minutes later approximately ten male subjects approached him and said, "Get the fuck out of here." He said the subjects then grabbed him and dragged him toward the driveway kicking and punching him. He said while the subjects were attacking him one of them called him a "Faggot." He said he was able to punch one of the subjects before they stopped attacking him. He said he then walked back to his apartment located at 6598 Seville Rd. #7.

I asked Rodger if he had gone out in Isla Vista by himself and he said, "Yes." I asked Rodger how much alcohol he had been drinking when the altercation began and he said, "I drank two beers." I asked Rodger why he had been attacked and called a "Faggot" and he said, "I don't know why." I asked Rodger why he didn't call law enforcement after he was assaulted and said, "I didn't know who to call."

I asked Rodger if he could describe any of the subjects who attacked him and he informed me of the following:

Narrative

The first suspect was described as an Asian male, approximately 18-22 years of age, 5'09", average build, with black hair, wearing blue jeans, and dark blue sweatshirt.

The second suspect was described as an Hispanic male, approximately 18-22 years of age, 6'02", skinny build, short black hair, and unknown clothing description.

During my contact with Rodger he appeared to not be forth coming with me. He appeared timid and shy and would not go into great detail about what had occurred.

I advised Rodger that when he was released from the Hospital to contact me at the Isla Vista Foot Patrol Office and bring me a copy of his medical paper work. Rodger stated he would contact me and provide me with a copy. At this time, I have not heard back from Rodger.

I spoke with Rodger's father, Peter Rodger, who stated he had spoken to the tenants who live in the upstairs apartment of He said the tenants were very cooperative and polite and stated they were not at their residence at the time of the assault.

I observed Rodger had the following injuries:

On 07-20-13, he was at his friend's residence with a group of friends when a subject stood up and began to push two females. He said he caught one of the females who was pushed, preventing her from falling off a 10 ft. ledge. He said the subject then pushed the second female who fell into a cradle position to prevent herself from falling off the ledge. He said the subject pushed two more people before jumping off of the 10 ft. ledge and running eastbound on Del Playa Dr.

I asked Isoda if he could describe the subject and he informed me of the following:

White male adult, skinny build, 18-19 years old, with dark colored hair.

I asked Isoda if he knew what provoked the subject and he said, "No." I asked Isoda if he observed the subject with anyone at the party and he said, "No." Isoda stated the subject's demeanor was strange and he did not appear to be socializing with people at the party.

It is my professional opinion the subject Isoda described was Rodger.

At approximately 1335 hours, Cpl. Pierce and I went to tenants of the residence but were unable to get a hold of anyone.
