### Narrative:

Writer in full uniform and in a marked scout car with Aux. Officer J. Zieleniewski. Writer on proactive patrol on fixed surveillance at the Motown Inn across from the Budget Inn a S/A for narcotic activity. Writer with the aid of 8X34 Binoculars had a clear and un-obstructed lighted view with the aid of security lights in the parking area of the Budget Motel. Writer then observed a Tan in color 4 dr Cadillac approach the Budget Inn W/B Michigan and pull into the parking area and park the above vehicle. Writer then observed the Arr. exit the drivers side and go into one of the rooms for approx. 2-3 minutes. Writer then observed the above Arr. exit the room and get back into the above vehicle. Writer then pulled the scout car out onto E/B Michigan to the Michigan turn around to go W/B Michigan. Writer then observed the above vehicle pull out of the Budget Inn without using a proper turn signal and continue W/B Michigan Ave. Writer then observed the above vehicle proceed N/B Fairbairn then W/B Oakland. Writer pulled in behind the

above vehicle at which time Arr. continued W/B Oakwood from John Daly. Writer observed Arr. continue towards Hill/Oakland and disregard the posted "STOP" sign. Writer after making my observations from the Budget Inn. and the traffic violation at Hill/Oakland, Writer initiated a traffic investigation using overheads and lights.

Writer then observed Arr. disregard my fully marked scout car and lights and continue W/B Oakland which turned ino S.River Park Drive. Writer advised dispatch of vehicle direction and failing to stop. Writer then observed the above vehicle slow down but swerve to the left then right and continue W/B S. River Park Drive, at this time Writer believed the Arr. was fleeing and eluding from police. Writer then observed the above vehicle continue W/B S.River Park Drive and attempt to make a right turn into the City of Inkster Library lot then swerve back onto S.River Park Drive. Writer then observed Arr. stop the vehicle. Due to Writer observations and the above Arr. refusing to pull over and Writer believing Arr. was fleeing from Police exited the scout car with department issued weapon out. Writer approached the drivers side vehicle and illuminated the interior of the vehicle and observed Arr. open the above vehicle drivers side door and turn his body to the right with his hands in the right and left hands on his right side body between his right hip and center council. Writer in fear that Arr. may be reaching for a weapon raised his department issued weapon at Arr. and advised Arr. to see his hands. Writer observed Arr. look at Writer with a blank stare as if on a form of narcotic. Writer then observed Arr. state " I'll kill you" and continue to keep his hands away from Writer. Writer then again advised Arr. to see his hands at which time Arr. removed his left hand in visible sight but kept his right hand out of Writer view on his right hip. Writer based on my observation above and Arr. for Fleeing and Eluding and may have a weapon moved in to extract Arr. from the vehicle. Writer then observed Aux. Officer Zielenieski grab Arr. left arm and pull Arr. to the ground. Writer observed Arr. begin to struggle and resist officers. Writer then got on top of Arr. and placed arms around Arr. upper body head area in an attempt to control Arr. at which time Arr. then with his teeth bit down on Writers left forearm. Writer felt sharp pressure on the left interior forearm at which time Writer removed left forearm from Arr, mouth, Writer then attempted to place Arr, in a hold at which time Arr, stated " I'll bite you again". Writer in fear of being bit and un-aware if Arr. had any diseases struck Arr. several times with a closed right fist to Arr. right side facial area. Writer then observed Arr. not attempt to bite Writer at which time Writer did not strike Arr.

Writer continued to place a hold on Arr. in an attempt to get restraints on same at which time Arr. locked his right arm under his body and refused to place his left hand behind his back by flaling his left arm out and around. Writer then observed SGT. Kritzer approach the Arr. and state "Tazer Out" and Writer observed SGT. Kritzer deploy a Tazer dry stun to Arr. at which time Arr. pushed the Tazer away and had no effect. Writer then observed SGT. Kritzer deploy a second time with no effect then a third dry stun at which time Arr. began to place his left hand behind his back. Writer then observed P.O. Randazzo and P.O. Arnica on scene at which time P.O.

Randazzo kicked Arr. right arm due to Arr. refusing to place his right hand behind his back and was grabbing his shirt. Writer was then advised Arr. was placed in retraints.

Writer then checked his left forearm for any form of penetration due to Arr. attempting to bite Writer. Writer then began to conduct a search inventory of the vehicle from a lawful arrest at which time while checking the passanger side of the vehicle at which time Writer illuminated the under carriage of the passenger seat and observed a clear tied plastic baggie containing white in color rocky substance of suspected crack cocaine. Writer then recovered said suspected narcotics from the above location.

Above Arr. was transported to the station for processing and contact with EMS. EMS transported Arr. to the Garden City Hospital for treatment.

Writer while in cell block advised SGT. Kritzer that Arr. bit Writer's left forearm once and attempted to bite same again. Writer rolled up left sleeve at which time no puncture marks but redding and swelling in the area. Writer was wearing four layers of clothes which assisted in protecting Writer from a dangerous bite.

Writer obtained a Search Warrant for Blood and was signed by Judge Turfy and was taken to Garden City Hospital and served. Arr was served with a copy of the Search Warrant and a speciman was taken. Writer received Blood evidence box lot number 14873.

Officer Arnica (partner/Driver) and I, Officer Randazzo were on patrol when we received a Radio transmission to assist Officer Melendez with a traffic stop. While en-route dispatch advised that Officer Melendez was fighting with one, step it up. Officer Arnica and I then activated our emergency lights and sirens.

Upon arrival I observed Officers Melendez, Ratliff, Sgt Kritzer and Auxillary Officer Zielenizwski fighting with (A1). I ordered several of the officers to back away from A1 so I could secure the left wrist with the cuff on it. While Officer Arnica provided cover for officers on scene. I secured the wrist by grabbing the handcuffs. I then gave A1 several orders to show his right hand. A1 refused to comply by not showing it. I then observed A1 holding to his shirt with his right hand, not allowing me to pull it from under his stomach area/body. I gave A1 the command to left go of his

shirt, give me his right hand and stop resisting. A1 failed to comply with my verbal commands/orders, at this time I gave A1 2 (two) foot strikes (kicks) to his right hand area/arm that was under his stomach area/body to break his hold on his shirt. The second strike worked,I pulled his right arm/hand out from under his stomach area/body, and placed his right wrist into the handcuffs DL.

I then assisted A1 up from the ground and escorted him to patrol vehicle 10-334, where I searched him for contraband and weapons, none were found his person. I secured A1 in the rear of Patrol vehicle 10-339 without incident. Officer Melendez transported A1 to Inkster Police Station where I met him. Officers Melendez, Arnica and I escorted A1 to the booking area. I escorted A1 to cell#1 where he was again searched for contraband and weapons, again none were found. Inkster Fire/Rescue was called for A1 had a cut(bleeding) to his right eye area. Inkster Fire/rescue transported A1 to Garden City Hospital for further treatment.

A1 was very hostile toward all officers on scene and at the Inkster Police station by not cooperating with all commands given by me and other officers.

I was at Gracie See's and heard Officer Melendez stated that he had a vehicle not stopping near the old police station on S River Park Dr. I started that way. Officer Melendez then advised fighting with one. I arrived and observed Officer Melendez laying on top of A1 who was struggling while Aux Zieleniewski was trying to cuff A1. A1 was refusing to give his hands and kept trying to pull the cuffed hand away. I yelled Taser and Drive stunned A1 in the stomach area and A1 pushed the taser away. I then drive stunned A1 in the thigh area and he also pulled away. I drive stunned A1 a third time in the stomach area for approx. five seconds and A1 slightly complied rolling onto his stomach. A1 was still stuggling not giving his hand. Officer Randazzo arrived and got the second cuff on. A1 was patted down and secured in Officer Melendez's patrol unit 10-339.

I called for IFD rescue to the station for treatment of A1. A1 had swelling to his right eye with a cut approx, one inch long. A1 was bleeding heavy. A1 was transported to Garden City Hospital for treatment by IFD. A1 was under arrest, prisoner detail was handled by Aux.s Long and Kos.

A1 was seen by Dr. Azeez. Dr. Azzez stated that A1 had a fractured orbital. A1 was admitted so a precautionary MRI could be administered on the day shift. Aux.'s Kromer and Dillard handled priosoner detail at the hospital after 0300hrs.
