
开字公司主要的加工设备有日本 KURAKI 加工中心,韩国 DAWOO 数控镗铣床,以及数台大型海天龙门加

To guarantee the processing precision to all kinds of large key parts and components, Kaiyu introduced high precision processing equipment from Japan and Europe, including machining center from Japan Kuraki, CNC boring-milling machine from Korea Dawoo, Haitian gantry machining center and NC drilling machine and NC lathe, etc.







产品

柳州开宇面向家用电器、电子、玩具、建材、汽车配件、通讯器材等行业,主要生产 LK 通用系列 100~2450 注塑机共 15 种机型, LKU 系列专用电木机 100~450 共 7 种机型, LKD 系列单缸式注塑机 100~250 共 7 种机型,以及高速、伺服系列注塑机等。

To meet the market demand on household electrical appliances, toys, building materials, auto components and communication equipment, KaiYu Launched three series of injection machine, including 15 models from 100T to 2450T in "LK" general-purpose series, 7 models from 100T to 450T in "LKU" Bakelite machine series and 7 models from 100T to 250T in "LKD" Single cylinder series. Core components are imported, such as Voith oil pump from Germany, Sino-italian joint venture melt motor, Yuken directional valve from Japan, Valqua oil seal from Japan, Keba from Austria, Gefran electronic ruler from Italy. Kaiyu holds a number of patents on plastic injection machine.

注塑行业在中国及东盟各国飞速发展,各种不同行业对注塑设备需求激增,柳州开宇无论从产能还是产品功能、质量距离满足市场需求都还有很大差距。仅柳州本地,就因为是汽车产业基地,客户具有急需自动换模系统、低压注塑成型及无人化注塑车间等方面的需求。柳州开宇有天时地利的优势,希望能够通过开展与德国企业的合作,更好地为市场服务。

Located in Liuzhou city, an automobile industry base, Liuzhou Kaiyu have geographical advantages.
