The following events occurred on Wednesday, January 27, 2021 at approximately 1335 hours in Washington DC, First District, at the intersection of Second St & Washington Ave, SW.

Reporting Officer (RO) (Carll, Seth #5372) was parked and observing traffic flow in the 200 Blk Washington Ave, SW near the Global Fence line that had been erected for the Presidential Inauguration. RO observed a white Mazda sedan that had parallel parked in the middle of the intersection of Second St & Washington Ave, SW. The Northbound and Southbound lanes of the 100 Blk Washington Ave were shut down by orange traffic barrels due to the perimeter of the Global fence line.

D1 exited the car and walked Northbound in the roadway of the 100 Blk Washington Ave, SW. As RO was pulling up behind the car, D1 was facing the fence line. D1 was animated and RO could hear him shouting to the Guardsmen that were inside the fence line.

RO asked D1 what he was doing. D1 said "I wanted to see the fence that was around "my Capitol". RO asked if the car was his. D1 said "Yes, I drove here from Charleston, West Virginia at 530am." RO requested ID. D1 said, "I lost my driver's license, but I have my birth certificate and social security card." D1 produced his registration and insurance card. The car registration identified D1 as the registered owner. D1 was identified by his social security card as (Westover, Dennis Warren). RO asked D1 if he had a gun on his person. D1 said "no." RO asked D1 if there was a gun in the car. D1 said "yes, in the center console, a P365." RO asked D1 if it was loaded, D1 said "there's nothing in the chamber, but there's a magazine in it." "I have a WV permit and I was told my permit was transferable to DC."

RO detained D1 in handcuffs and called for assistance. Officers Matt Shelfo #5028 and Hans Hirsh #4702 responded and verified there was a pistol in the center console. Crime Scene Search Officer Doug Luckel #5206 responded and removed the gun from the center console, cleared it in the grass, and placed it in a secure box in the crime scene truck . The weapon and ammunition were taken to the Crime Scene lab located at 119 D St, NE for secure storage. CSES #21-0050.

Further investigation revealed, a black Sig Sauer 9mm P365 pistol bearing serial #66A860256 and one inserted magazine containing 10 'live' 9mm rounds. The chamber was empty. One loose 9mm magazine was also in the center console containing 10 'live' 9mm rounds. The gun had a barrel less than 12 inches, appeared to be operational and able to be fired one handed, expelling a projectile by means of explosion.

D1 was the sole occupant and registered owner of the car. A WALES/NCIC check on D1 returned no wants/ no warrants. The pistol has never been registered in DC and D1 did not have a DC license for it.

D1 was placed under arrest for CPWL, Unregistered Firearm, and Unregistered Ammunition at 1358 hours. D1 was transported to USCP Headquarters located at 119 D St, NE where he was processed.

USCP CID Special Agents K. Rivera #4953 and G. Stith #6509 conducted an interview with D1 after he waived his Miranda Rights. D1 admitted the gun was his and it was not registered in DC. The ammo was not registered in DC. The car is his and no one else uses it. D1 got the gun for protection for his fiancée and him. The vehicle D1 was driving was towed by AnA Towing to 1913 Bladensburg Rd, NE. D1 was transported to CCB for lockup.

The event and acts described above occurred primarily in the District of Columbia and were committed as described by defendant(s) listed in the case caption.
