Dear Chief Justice and Associate Justices:

We write to urge the California Supreme Court to order a transfer of causes between the Courts of Appeal pursuant to rule 10.1000(a)(1)(C) of the California Rules of Court for the purpose of alleviating a critical backlog of long-pending appeals in the Court of Appeal for the Third Appellate District.

Attached is a partial list of fully briefed appeals in the Third Appellate District which have not yet been scheduled for oral argument or submitted for decision but have been pending for periods of time between nearly two years to more than five years since they became fully briefed. Of the 57 listed appeals, 42 are criminal cases and thus have calendar preference.

In the interests of justice, we respectfully suggest that the Court should transfer these appeals – or, alternatively, an equivalent number of other appeals in the Third Appellate District – among the other districts of the Courts of Appeal as this Court determines to be appropriate, for the purpose of ensuring that these long-pending appeals are adjudicated expeditiously.
