Operation Report - The Center for Medical Progress

12 April 2014

Introduction

The Center for Medical Progress (CMP) is a 501(c)3 non-profit organized for the purpose of "monitoring and reporting on medical ethics and advances." Since early 2013, CMP has been conducting a long-term, comprehensive investigative research project on the illegal trafficking of aborted baby parts by the abortion industry and its allies. The project has logged thousands of research hours, recorded dozens of hours of undercover video and audio, obtained hundreds of pages of evidence and hours of interviews from inside sources.

The project is building a body of evidence that will be strong enough to trigger criminal prosecution and civil litigation against Planned Parenthood and to precipitate pro-life political and cultural ramifications when the revelations become public. We have established a front organization (*BioMax Procurement Services*) that purportedly supplies medical researchers with human biological specimens, and this organization is discussing potential arrangements for fetal tissue harvesting with a variety of abortion providers.

In February 2014, several generous donors contributed \$12,050 to CMP to fund our infiltration of the National Abortion Federation (NAF) Annual Meeting at the start of April. BioMax was to attend the NAF meeting as an exhibitor in order to network with Planned Parenthood affiliates and other abortion providers and identify the specific entities interested in selling aborted fetal tissue. The infiltration would serve two main purposes: 1) network with the upper echelons of the abortion industry to identify the best targets for further investigation and ultimate prosecution, and 2) gather video and documentary evidence of the fetal body parts trade and other shocking activities in the abortion industry.

Results

The infiltration was successful, and BioMax is now a known and trusted entity to many key individuals in the upper echelons of the abortion industry. The operation collected ~30 hours of video over the four-day meeting, recording interviews with abortion doctors, clinic staff, and Planned Parenthood/NAF officials, as well as key conference sessions. CMP spent approximately \$11,974.34 of the \$12,050 budgeted (breakdown in **Appendix C**).

Review and analysis of the recordings, materials, and events of the conference are ongoing. This overview presents a preliminary inventory of them as *Contacts* established with key targets, *Video Highlights*, and *Other Evidence* gathered.

Dr. Nucatola identifies herself (and other abortionists identify her) as the top-level medical director at PPFA overseeing all the other Planned Parenthood affiliates. Nucatola wants to help connect BioMax to the various PP affiliates who are prepared to do baby parts harvesting. She indicates that PPFA does expect affiliates to be compensated for providing tissue, and that she herself alters her abortion procedures in order to provide better specimens.

Matthew Reeves, MD

Medical Director, NAF

Abortionist, PP Metropolitan Washington, D.C.

Dr. Reeves has experience supplying aborted specimens to universities in Pennsylvania and has several ideas (of questionable legality) about ways BioMax can partner with abortion clinics to make it worthwhile for them. He wants to help make connections with abortion providers doing a high volume of $2^{\rm nd}$ -trimester cases.

Lisa Harris, MD

Medical Director, PP Mid and South Michigan

Dr. Harris has experience supplying fetal tissue to university researchers and is happy to facilitate this at her Planned Parenthood clinic in Ann Arbor. She also believes that laws and regulations meant to protect pregnant women from being preyed on by unscrupulous researchers are "paternalistic."

Kristin Flood, JD

Associate Director and Counsel, Consortium of Abortion Providers (CAPS), PPFA Lawyer for the secretive PP CAPS committee which sets abortion policy for Planned Parenthood. She was interested in fetal tissue harvesting and offered to connect us to her colleagues.

Todd Buchaker, RN

Associate Director, Consortium of Abortion Providers, PPFA
Another PP CAPS member who was very eager to help BioMax connect to Planned
Parenthood abortion clinics. He is based in IA.

Erika Staub, RN

Planned Parenthood MN, ND, SD

This PP nurse indicated that her affiliate already has all their forms ready to go for fetal tissue harvesting and know what to do, they just don't have a middleman company to work with.

Whole Women's Health

Amy Hagstrom Miller, Dr. David Chang, Dr. Carrie Terrell

WWH is a Texas-based independent abortion chain that also operates clinics in MD and MN. The CEO believes it is illegal for them to supply at all in TX, but she and her doctors are excited to harvest tissue in MD and MN. WWH has been very active in opposing the new abortion laws in TX and has also been hit very hard by them, shutting at least 2 of their 5 TX clinics and possibly more in the future.

Video Highlights:

Lisa Harris, PP MI:

"I actually think we should be less about denying the reality of those [graphic] images, more about acknowledging that 'Yeah, that's kind of true.' So given that we actually see the fetus the same way, and given that we might actually both agree that there's violence in here, ask me why I come to work every day. Let's just give them all the violence, it's a person, it's killing, let's just give them all that! And then, the more compelling question is, so why is this the most important thing I can do with my life?"

"Our stories don't always have a place in the pro-choice movement. **The heads that** get stuck that we can't get out, the hemorrhages that we manage, the patients having their eighth abortion."

"We do dismemberment procedures."

"They've [PP MI affiliate] never charged for specimens before, if they were going to partner with a more commercial agency, they probably would think about it...All research projects pay for the effort...but they've had sort of like grants to the agency to cover my time."

NAF/PP Abortionist narrating 2nd-trimester procedure:

"An eyeball just fell down into my lap, and that is gross. But I'm saying to myself, this abortion is going well, it's going safely, so I'm fine." [audience laughter, applause]

Matthew Reeves, NAF/PPDC:

"One issue that clinics have is disposal for all their fetal tissue...If you said we'll take it all off your hands for free, as long as you give us X number that are for fetal tissue per month, and maybe you can pay more if you get more than that or something, you'd probably get a lot of interest."

"I think we could do that [discount abortions for "donating" women]. I would think maybe a more acceptable way to phrase that is to say there's a tissue disposal fee in your abortion and we'll waive if you donate. Instead of saying 'we're giving you a discount,' which has some questionable—might be a better way to phrase it, that if you donate, you don't have to pay for the disposal...just phrased differently. Gets the same result...But that'd be great."

Deborah Nucatola, PPFA/PPLA:

"Many, many, many more affiliates want to get involved and they just don't know how...different affiliates make different negotiations, we just want them to be

able to say on the back end, this is what we're compensated, and this is what it covers."

"Other than just it's an additional ask on the front end for the medical assistant staff, that's probably the hardest part about it, everything else is quite easy to deal with. It doesn't take up a lot of space...It's unfortunate when we're at a site where somebody asks and it's not a possibility, because then it's a lost opportunity for everybody."

"I let the tech tell me what they need, I usually don't let the trainee do those cases, I try to do everything as intact as possible, because I know it's a research case. She seems to be getting what she needs. Sometimes she'll tell me she needs brain, and so we'll leave the calvarium until last... There will probably be providers who just want to keep doing things the way that they do them, and others who kinda want to help facilitate the process."

Leslie Drummond, PP Mar Monte/Shasta Pacific:

PP: "I know you can't talk numbers but a person I spoke to said, you know, do these researchers pay a lot of money for this? And I said, yeah."

PP: "If you've got good dilation if you've got misoprostol on board sometimes you can get a lot of intact tissue and I get a lot of Oohs and Aahs from StemEx, they're wanting livers, they're wanting thymus. I just had the most interesting one recently, last week I was in Sacramento and she said I need 4 intact limbs. And I said, "You want what?" I don't know what the researcher wanted that for. But they wanted intact limbs. That was weird."

PP: "I'm not an administrative person, and if they're already contracted with these people then I would figure that you guys wouldn't have a chance getting in there." CEO: "Maybe if we made it a little financially favorable—"

PP: "Sweeten the pie?" [laughs]

CEO: "Exactly."

PP: "Well, I wouldn't—I, I, I could tell you who the people are."

Other Evidence:

-StemExpress was a silver-level sponsor of the NAF meeting and had a half-page ad in the conference program for clinics to supply fetal tissue, promising it was "Financially Profitable" and a "program that fiscally rewards clinics." (Appendix A)

-Presentation slides for a workshop on "The Basics of First Trimester Abortion" included photographs of typical aborted fetal remains at varying gestation. These are significant as they are graphic abortion images that come directly from abortion providers' own training materials, so no one can question their authenticity. (Appendix B)


-The NAF presenter during the final conference session on "Understanding the Needs of Girls and Young Women with a History of Abuse Seeking Abortion and Reproductive Health Care" encouraged the audience to disregard mandatory reporting laws:

Q: Could you speak to the mandatory reporting for minors? Do you think it's positive, negative, does it help, does it do more harm? Could you speak to that? A: The mandatory reporting I think in general takes more away from women than it helps girls and women...I think anything that's mandatory is more likely to be disempowering than empowering...We deal with this all the time in the sexual assault group where there's lots of leeway in reporting. Because we can't always assume that parents are a safe place, or foster homes. So I think reporting has lots of implications and that's what I hope you take away today is we need to look more at how the systems are causing harm than the harms of the abuse itself. Because that part we're not gonna stop, but we can stop all the additional harms that girls and women encounter...I think that idea of help and harm is very useful one overall for us to think about. Like maybe this is helpful to have mandatory reporting, maybe it came from good thinking, well somebody has to step in and do something, but what are the potential unintended harms? And we only know that by talking to the girls and women who are using the service.
