Phil, I asked my husband about your questions, since he is more familiar with corporate law than I am.

First, s for the third of the four requirements you listed he said that is just needs to be a "good" address for you. No one will fault you for going on vacation or otherwise not being there 8 hours a day, five days a week.

This is particularly so as David & Co. don't expect there to be anything served, because their corporation is not actually going to be conducting any business. They are going to toy with conducting business, but stop well short of signing any contracts or the like.

Here's what Bill said as to your questions 1 - 3:

- > Filing and costs, none that I've ever seen.
- > Termination of office -- I vaguely recall that agents can resign unilaterally. I believe I have done so by simply writing to the Secretary of State.
- > Civil liability -- none that I am aware of, other than to fail to notify the principal of papers served on you. It is just a ministerial role.
