## UNDERCOVER PROJECT TO EXPOSE FETAL TRAFFICKING

### EXECUTIVE SUMMARY

Fetal trafficking is the commercial buying and selling of aborted fetal body parts for use in scientific research. The commercial vending of fetal body parts is a felony under federal law with severe penalties, but Planned Parenthood and other abortion clinics are deeply involved in this bloody web of merchandized flesh, which, mediated by ambitious middle-man procurement companies, includes top university professors, the burgeoning stem cell industry, and millions of dollars in government funding.

The proposed project will use a variety of innovative undercover techniques to document fetal trafficking and associated crimes. The results of our investigation will be released online in a feature-length documentary, promoted by viral undercover videos posted to YouTube. Release is tentatively scheduled for Summer 2014. By exposing one of the most sickening abuses of the abortion industry, this project aims to ignite public outrage against the abortion industry, permanently damage Planned Parenthood's brand, and prompt defunding and criminal prosecutions.

Research for this project has been ongoing for the past three years. The project coordinators have a combined eight years' experience developing and executing investigative campaigns against the abortion industry. Project coordinators are establishing a new 501(c)3 non-profit, the Center for Medical Ethics, to orchestrate the project and are seeking \$120,000 in funding for the first year of operations.

## FETAL TRAFFICKING: THE PARADOX OF ABORTION

“‘If I wasn’t real,’ Alice said—half laughing through her tears, it all seemed so ridiculous—‘I shouldn’t be able to cry.’”

‘I hope you don’t suppose those are real tears?’ Tweedledum interrupted in a tone of great contempt.”<sup>1</sup>

The commercial exploitation of aborted children through fetal body parts trafficking is the horror that lies “Beyond Abortion.”<sup>2</sup> Experts estimate that there are nearly 2 million requests for fetal tissue processed each year in the United States alone.<sup>3</sup> Aborted children and their body parts have been used for live research, organ transplantation, and drug discovery, and their stem cells now undergird some of the biggest contemporary projects in regenerative medicine. In this ghastly, tax-payer funded, billion-dollar enterprise, abortion clinics—led by Planned Parenthood—sell the body parts of late-term children to middleman companies who in turn sell them to eager “end users”—liberal university professors and multi-million and -billion dollar medical and pharmaceutical companies.

Fetal trafficking is a heartbreaking paradox that exposes the injustice of abortion. Unborn children are aborted because they are deemed “inhuman,” but after death their broken bodies, rather than being simply discarded as medical waste, are sought like buried treasure because of the very humanity that was denied when their lives were taken. Their extreme youth, which made them disposable for society, also makes them invaluable for the academy. They are dehumanized and objectified first in their short lives by the murderous abortionist who kills them for money, and then dehumanized and objectified again in death by the corrupt scientists who exploit their murder for profit.

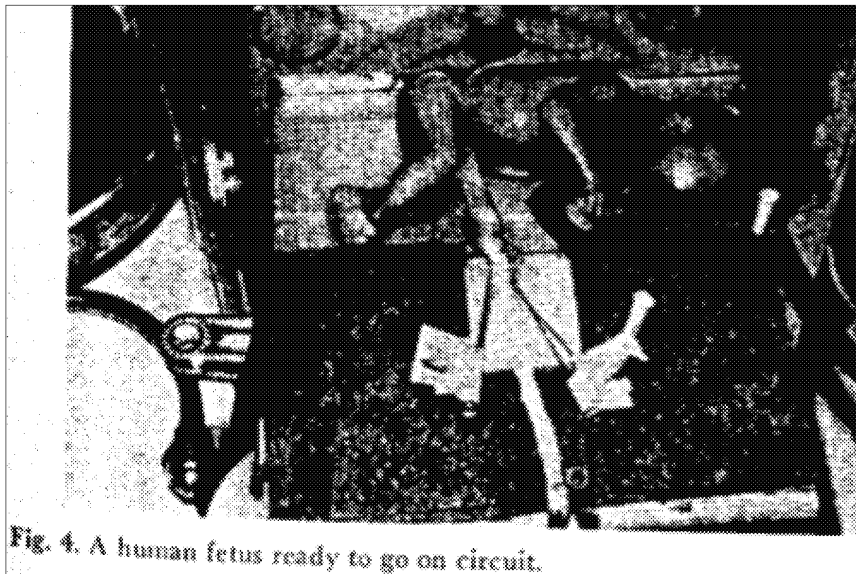


Fig. 4. A human fetus ready to go on circuit.

It is the value of the fetus to the scientific research community that proves its humanity. An expose of fetal trafficking reveals not only the sickening depths to which abortion naturally leads, not only the greed and corruption of the abortion industry, not only new justifications for the defunding, prosecution, and restriction of the abortion industry, but also, the paramount bone of contention at the heart of the abortion debate: the humanity and worth of the fetus.

The proposed project is a comprehensive and cutting-edge expose of the commercial exploitation of aborted children. Research preparing for this project has now been underway for three years. The project will be released as a feature-length documentary film, hosted on a central project website with interactive resources, and promoted by traditional “gotcha” undercover videos on YouTube. The preliminary release date is Summer 2014—before a midterm election, in the middle of regenerative medicine's push into the commercial mainstream. The project will investigate, document, and expose fetal trafficking on three levels (clinic, wholesaler, and end user), two dimensions (real-life/undercover stings), and multiple manifestations of corruption (laws broken, regulations violated, bioethics and moral/philosophical themes implicated). The project's goals are to trigger severe legal and financial consequences for the abortion industry and permanently damage abortion and stem cell research in the public eye.

**NODES OF INVESTIGATION:**

*The sale and purchase of fetal tissue for "valuable consideration" is a federal felony*

Fetal trafficking is a robust, multi-level industry with a grisly chain of supply and demand. Fetal tissue is eagerly sought after by academic and commercial researchers in the medical and biotech disciplines. The most convenient supply of fetal tissue is the remains of aborted children, which can be provided by the numerous abortion clinics across the country in nearly every major metropolitan area, who otherwise would simply dispose of the tissue as medical waste. However, since most researchers and scientists are loathe to think of themselves as “abortionists” and are

uncomfortable being directly involved in the practice of abortion, “middleman” tissue procurement companies most often bridge the gap between the world of the abortion clinic and the world of the university laboratory.<sup>4</sup>

This means there are three “levels” at which an investigation and expose of fetal trafficking can take place: 1) The Abortion Industry, 2) Middleman Companies, and 3) Fetal Tissue Researchers.

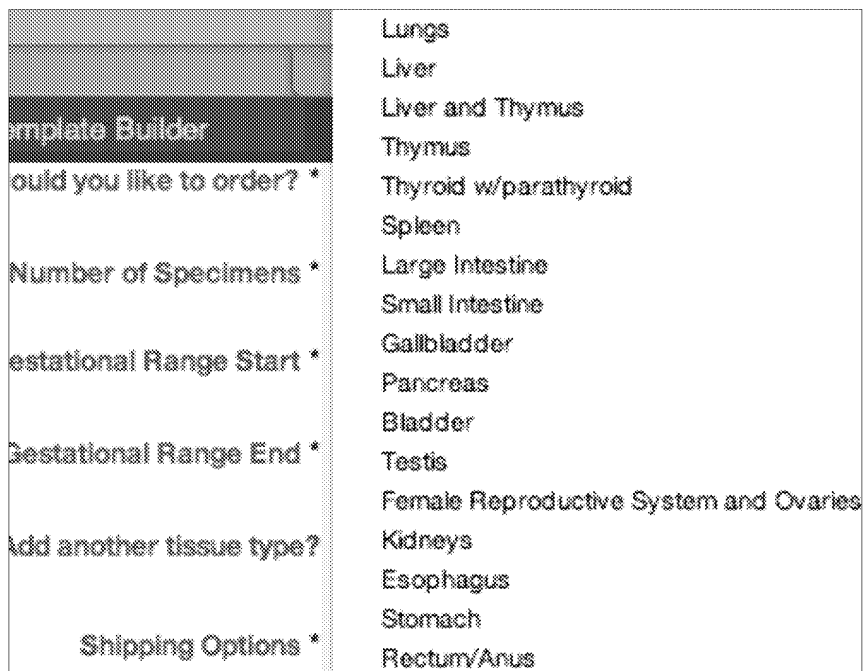
**Level 1: The Abortion Industry**

Abortion clinics practically exclusively supply the fetal tissue used in research in the United States. In the late 1990s and early 2000s, fetal tissue sale seemed to be heavily correlated to National Abortion Federation affiliates.<sup>5</sup> Today, Planned Parenthood seems to be **preeminent** among the tissue supply chain, mirroring its position within the abortion industry and also reflecting close personal ties between Planned Parenthood Mar Monte and StemExpress, the newest prominent fetal tissue procurement organization. It should be noted that all Planned Parenthood clinics are also NAF affiliates.

The abortion industry holds several conferences throughout the year, the most prominent being the NAF annual meeting and the annual meeting of the Association of Reproductive Health Professionals (ARHP), which is Planned Parenthood-affiliated. In the past, these conferences have been venues for tissue procurers to identify new supply clinics and may continue to harbor this sort of activity.

**Level 2: Middlemen**

Most medical professionals and researchers do not want to be involved directly in abortion and are loathe to think of themselves as “abortionists.”<sup>6</sup> Because of this, fetal trafficking is mediated by tissue procurement companies that act as “middlemen” or “wholesalers” between the abortion clinic and the scientific researcher. Fetal tissue procurement organizations advertised openly in the scientific research community in the 1990s, but largely went

underground, out of business, or stopped procuring fetal tissue after the Life Dynamic's Baby Parts expose in 2000. A notable exception is the “non-profit” Advanced Bioscience Resources, run by Linda K. Tracy out of Alameda, CA. ABR has been providing fetal tissue to researchers throughout the 2000s. In 2009, likely in response to the demand from researchers for more participation from middleman companies, Cate Dyer, a procurement technician from ABR, founded a new fetal tissue procurement start-up called StemExpress. StemExpress has grown in just a few years to become a multi-million dollar

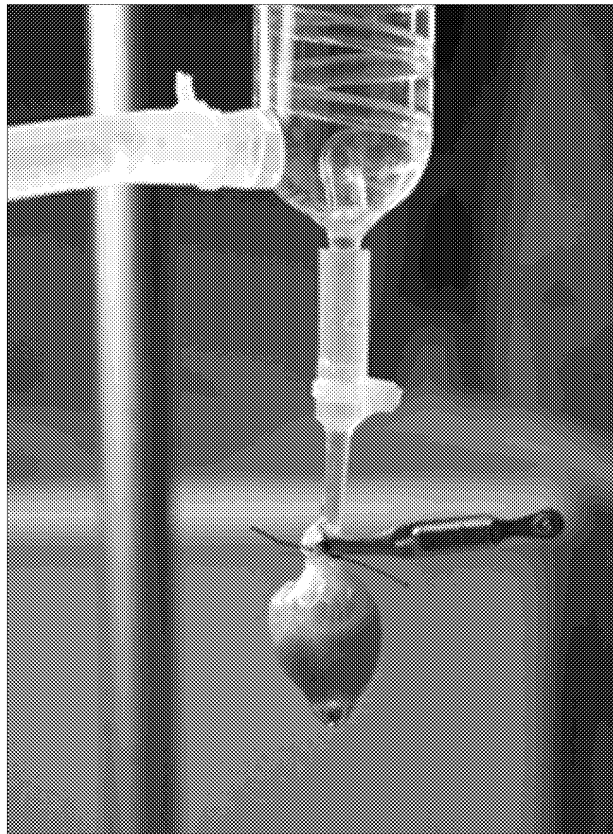

organization with bicoastal operations and deep collaboration with Planned Parenthood.<sup>7</sup> Other biotech supply companies, such as Lonza Group Ltd., also have limited fetal tissue procurement operations.

The American Association of Tissue Banks (AATB) is a national non-profit that accredits tissue procurement organizations and holds workshops, seminars, and conferences throughout the year. Fetal tissue procurers frequently participate in these meetings.

**Level 3: The Scientific Community**

Sadly, fetal trafficking does not only show the gruesome depths to which those who practice child-killing will sink. It also shows the best of modernity corrupted and at their worst—“enlightened” men of science, doctors seeking to heal suffering patients, cannibalizing the young and playing God with human life with a **shamelessness** that would make Victor Frankenstein blush. Every month, there are new studies published in prestigious peer-reviewed journals detailing stem cell experiments performed with the remains of aborted children. A May 2012 paper in *Circulation*, the journal of the American Heart Association, was particularly blatant: “In brief, human fetal hearts were collected after elective abortion by a commercial vendor (StemExpress, Placerville (*sic*), CA). Fetal hearts underwent Langendorff perfusion” before being mechanically masticated by Stanford researchers.<sup>8</sup> Langendorff perfusion is a technique to preserve the heart for transplantation or study, in which a whole, beating heart is excised and attached to a nutrient tap, in order to keep the heart beating outside of the body.

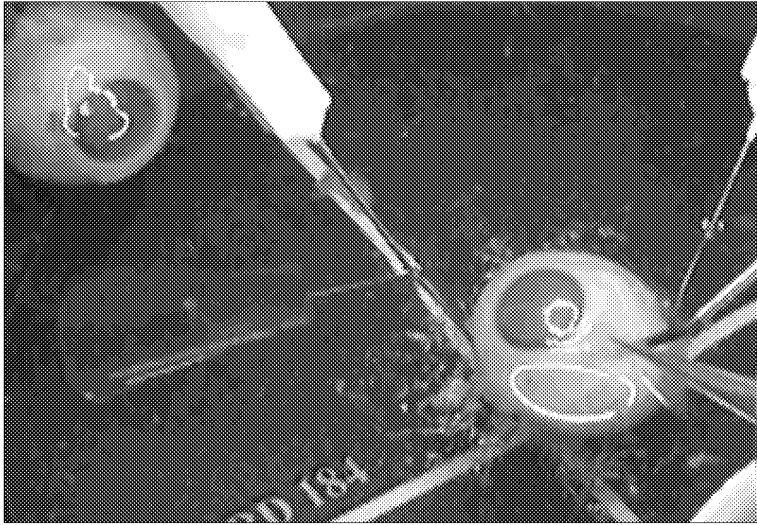
Scientists at nearly every major research university use organs, tissue, or cells from aborted fetuses in their work. UCLA, USC, Stanford, UC Davis, UNC-Chapel Hill, UW-Madison, and countless others, in addition to private researchers at biotech and medical companies, require a constant stream of aborted fetal tissue to carry out their experiments. Much of their work is government funded, through federal research grants or the \$3 billion *CIRM* endowment in the state of California. Under Obama, the NIH now spends nearly \$80 million each year on human

fetal tissue research alone<sup>9</sup>—this does not include the billions of dollars of NIH stem cell funding that frequently supports aborted fetal stem cell work.

After the failure of *embryonic* stem cell research, which even its once-ardent supporters now admit, the billion-dollar regenerative medicine industry is reinventing itself as “practical” and “lab-to-clinic” oriented, with success fueled largely by fetal stem cell research, deceptively labeled as “adult stem cell research.” Aborted fetal stem cells undergird some of the most clinically successful stem cell research to date by major regenerative medicine corporations. There are countless stem cell conferences across the

country and world each year, at which researchers openly talk about their work with and sourcing of aborted fetal tissue—and also confer with each other about how best to communicate their controversial work to a squeamish public. Fetal stem cell research is being cloaked as “adult stem cell research” to market it to an unsuspecting public, media, and politicians.

### **INVESTIGATIVE METHOD:**

There are two major methods of investigative journalism that will gather the strongest visual evidence for this project: real-life, long-term “moles” and informants, and creative scenario-based “gotcha” stings. These two approaches represent the two “dimensions” of this project: real-world documentation of fetal trafficking, and undercover illustrations of how it happens in real-life. Each method can inform the performance of the other, and when released, the information gathered from each strengthens and validates the other.

#### **Real-World Informants**

Some of the most damning information can be obtained only by long-term, real-life moles and informants within investigative targets. In the past, the majority of pro-life counter-intelligence on fetal trafficking has been obtained from moles working within abortion clinics and fetal tissue procurement companies. Today, we have several opportunities to repeat this successful investigative tactic. The strength of this method is that it obtains direct evidence of actual crimes and abuses committed by the investigative target, and it allows for long-term tracking of the plans, decisions, and operations of the enemy. This especially can inform the construction of undercover scenarios for short-term stings.

On the flip side, the abuses and corruption within the abortion industry, and by extension, in the business of fetal trafficking—can be most vividly depicted by recording undercover “stings” in which a trained actor interacts with a real-life abortionist or fetal trafficker according to a pre-determined “scenario” modeled after real-life, everyday occurrences in the industry. This method makes it possible to show in first-person what happens

when a pregnant woman is solicited (or coerced) for a “donation” of fetal tissue, or when a university researcher negotiates the price and age of fetal brains with a procurement company.

**POTENTIAL VIOLATIONS:**

*“That's what it was, you could see no end to what could be done. And imagine the extent of the raw material, a little nation of nonpersons by the millions. Of course there are laws against it. Do you know what he said? ‘There are laws against it because everybody knows it's going on.’”<sup>10</sup>*

There are many laws and regulations on the state and federal level that may be broken by those involved in fetal trafficking. These include:

**FEDERAL****Prohibition Against Fetal Tissue Purchase (42 U.S.C. 289g-2)<sup>11</sup>**

The sale or purchase of human fetal tissue “for valuable consideration” is a felony<sup>12</sup> under federal law and punishable by up to 10 years in prison, and/or a fine of up to \$250,000 (for individuals) or \$500,000 (for corporations).<sup>13</sup>

**Prohibition Against Human Organ Purchase (42 U.S.C. 274e)<sup>14</sup>**

The sale or purchase of human fetal organs “for valuable consideration,” including tissue, is a felony and punishable by up to 5 years in prison and/or a fine of up to \$50,000.

**Aiding and Abetting Federal Crimes (42 U.S.C. 2)<sup>15</sup>**

Anyone who aids, abets, or counsels a federal crime to be committed may be punished as if they had committed the crime themselves.

**Federal Funding of Live Fetal Research (42 U.S.C. 289g)<sup>16</sup>**

The Department of Health and Human Services may not conduct or fund any research or experimentation upon a live *ex utero* fetus unless the research will protect the life/health of the particular fetus. For research conducted on fetuses *in utero*, the risk standard must be the same for fetuses that will be carried to term and those who will be aborted.

**Federal Funding of Fetal Tissue Transplantation Research (42 U.S.C. 289g-1)<sup>17</sup>**

HHS may conduct or fund research on therapeutic transplants of aborted fetal tissue if the following conditions are met:

1. The woman signs a consent form donating the tissue for therapeutic research, regardless of who may benefit from its transplantation and without knowledge of potential transplant recipients
2. The abortionist signs a statement declaring that consent for the abortion was obtained before consent to donate the tissue, the timing and method of the abortion was not altered in order to obtain the tissue, the abortion was legal, the woman consented to donate, the woman was informed of the abortionist's interest in the research, and the woman was informed of any risks to her health or privacy arising from the donation.
3. The researcher signs a statement declaring they are aware they are acquiring human fetal tissue donated from an abortion, they have informed their fellow researchers of this, they will inform any transplant recipients of this, and they had no part in decisions about the timing or method of the abortion.

4. The head of the agency conducting the research certifies that the signed statements of the abortionist

and researcher will be available for audit by HHS.

5. The research does not violate applicable state and federal laws.

Also, HHS must submit a report each year to the House Energy and Commerce Committee and the Senate Labor and Human Resources Committee on the fetal research conducted or funded by the Department.

**Born-Alive Infant Protection Act (BAIPA) (1 U.S.C. 8)<sup>18</sup>**

This act defines an infant alive *ex utero* at any stage of development as a person under federal law.

**STATE**

Specific laws and regulations vary across all 50 states. However, the sort of state laws that may be implicated in a fetal trafficking expose include:

**Organ/Fetal Tissue**

**Purchase Statutes:**

Many states have their own laws criminalizing the commercial sale or purchase of human remains, including fetal tissue. Some have laws specifically addressing the sale of fetal tissue.

**Fetal Experimentation, Fetal Tissue, and Stem Cell Statutes:<sup>19</sup>**

Some states have banned fetal experimentation entirely, and some states have banned or have specific criminal restrictions surrounding the procurement and use of fetal tissue. Some states also have specific stem cell research laws that can apply to fetal tissue research.

**State Born-Alive Infant Protection Acts:**

State BAIPAs typically have more “teeth” than the federal law and can be enforced with specific criminal penalties. Many states also classify the killing of a fetus as homicide or manslaughter.

**State Abortion Laws:**

Every state has different and sometimes expansive abortion laws, which, if not complied with in the process of procuring fetal tissue, could affect the licity of the fetal research.

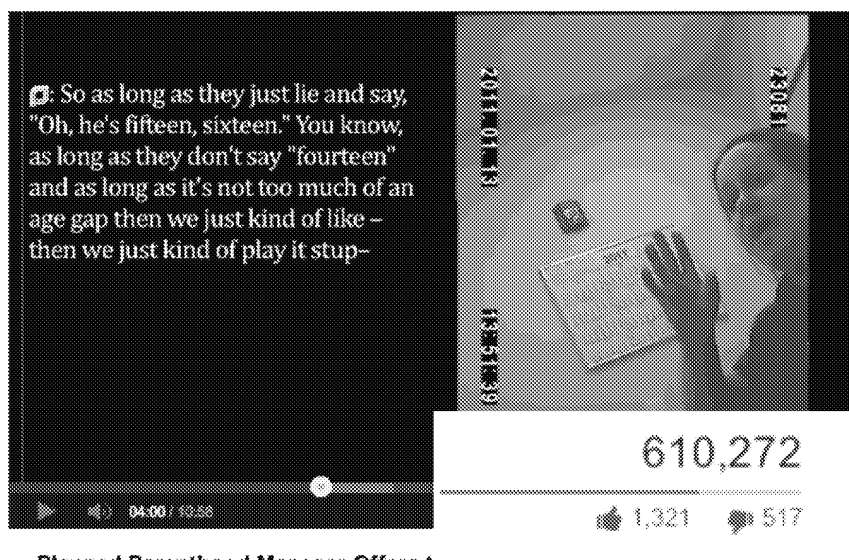

Most states have specific laws or regulations regarding the proper handling and disposal of human and fetal remains.

**PRODUCTION AND RELEASE:**

The research and **undercover work done in the next year and a half for** this project will ultimately yield a feature-length investigative documentary film exposing the commercial exploitation of dead unborn children that abortion makes possible. The documentary will feature undercover footage from real-life moles and orchestrated “stings,” expert interviews, and candid interviews with major players in the fetal trafficking industry, and will present a comprehensive picture of the phenomenon of fetal exploitation and commentary on the dehumanization of the unborn.

A month before the documentary is released, the **rollout of the project** will begin with the **release of short, viral, undercover “gotcha” videos posted to YouTube each week.** In essence, the public unveiling of the fetal trafficking project will begin with the release of **James O’Keefe/Live Action** style viral undercover videos. These 5 to 7 minute videos will spotlight some of the most damning “gotcha” undercover footage recorded by the project. It is almost

universally recognized that in media, “content is king,” and the content of our undercover videos—the commercial traffick of baby body parts—is more compelling than the worst James O’Keefe ACORN or Live Action sex trafficking videos. These videos should have a million views in just a few weeks and will achieve major media coverage and airplay on national news. Each YouTube video will end with a promotion for the soon-to-be-released documentary and direct viewers to the central project website.

In order to allow the final film to be seen by as many people as possible, when released, the film will be available freely streaming on the project’s main website. The website will include downloadable supplementary content, action items, and a running “body count” tracking the number and details of unborn children killed and their **organs pillaged for experimentation** as recorded in the Materials & Methods section of new studies as they publish.

**GOALS:**

The following are just some of the primary goals of a fetal trafficking expose:

1. Catch fetal traffickers, especially Planned Parenthood clinics, violating laws, regulations, and common decency
2. Create public outrage at Planned Parenthood and liberal university professors
3. Deliver a major public relations blow to Planned Parenthood
4. Promote state defunding efforts for Planned Parenthood
5. Initiate criminal prosecution of clinics and wholesalers
6. Initiate regulatory proceedings against clinics and doctors
7. Expose the ghoulish medical cannibalism that lies “beyond abortion”
8. Create public outrage over abortion and stem cell research
9. Rally the Church to stronger, more public action to protect unborn children

The foundational goal of the project (1) is to provide vivid, visual documentation of the both illegal and revolting deeds committed by Planned Parenthood and their associates in the world of abortion and fetal

exploitation, which will polarize them as “enemies” in the public eye and

generate a reaction against them (2, 3). From this foundation flow “hard” goals (4, 5, 6) that immediately hurt Planned Parenthood and the abortion industry and “soft” goals (7, 8, 9) that create and sustain an environment in which public policies and initiatives that hurt the abortion industry and restrict abortion will be more likely to be successful, and in which public sentiment is more pro-life and anti-abortion.

**THE TEAM:**

**David Daleiden**

David has been active in the pro-life movement since he was 15. From 2008 to 2013, David served as Director of Research for the new media investigative pro-life group Live Action. At Live Action, David provided the backbone of the undercover journalism program, from story

concept to media release. He designed and executed 5 major, multi-state undercover investigations which earned national media attention. These investigations included the Mona Lisa Project (2009) and the Sex Trafficking Project (2011), which led to prosecution of Planned Parenthood employees, probation of a Planned Parenthood clinic in Alabama, and state and federal defunding efforts against Planned Parenthood and the successful defunding of over \$61 million on the state level.

David has trained undercover investigators in novel undercover techniques and developed strategic relationships with policymakers, law enforcement, and informants. He has authored numerous investigative reports, articles, speeches, and press releases, and developed fact sheets used by members of Congress in floor debates.
