

1 AN ACT relating to public safety.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 500.080 is amended to read as follows:

4 As used in the Kentucky Penal Code, unless the context otherwise requires:

- 5 (1) "Actor" means any natural person and, where relevant, a corporation or an
6 unincorporated association;
- 7 (2) "Crime" means a misdemeanor or a felony;
- 8 (3) "Dangerous instrument" means any instrument, including parts of the human body
9 when a serious physical injury is a direct result of the use of that part of the human
10 body, article, or substance which, under the circumstances in which it is used,
11 attempted to be used, or threatened to be used, is readily capable of causing death or
12 serious physical injury;
- 13 (4) "Deadly weapon" means any of the following:
- 14 (a) A weapon of mass destruction;
- 15 (b) Any weapon from which a shot, readily capable of producing death or other
16 serious physical injury, may be discharged;
- 17 (c) Any knife other than an ordinary pocket knife or hunting knife;
- 18 (d) Billy, nightstick, or club;
- 19 (e) Blackjack or slapjack;
- 20 (f) Nunchaku karate sticks;
- 21 (g) Shuriken or death star; or
- 22 (h) Artificial knuckles made from metal, plastic, or other similar hard material;
- 23 **(5) "Emergency services personnel" means any person who is a paid or volunteer**
24 **emergency medical services personnel certified or licensed pursuant to KRS**
25 **Chapter 311A or a paid or volunteer member of an organized fire department;**
- 26 ~~(6)~~~~(5)~~ "Felony" means an offense for which a sentence to a term of imprisonment of
27 at least one (1) year in the custody of the Department of Corrections may be

1 imposed;

2 **(7) "Firework" means any composition or device for the purpose of producing a**
3 **visible or an audible effect by combustion, deflagration, or detonation, including**
4 **but not limited to bottle rockets, Roman candles, and firecrackers;**

5 **(8)**~~[(6)] "Government" means the United States, any state, county, municipality, or
6 other political unit, or any department, agency, or subdivision of any of the
7 foregoing, or any corporation or other association carrying out the functions of
8 government;~~

9 **(9)**~~[(7)] "He" means any natural person and, where relevant, a corporation or an
10 unincorporated association;~~

11 **(10)**~~[(8)] "Law" includes statutes, ordinances, and properly adopted regulatory
12 provisions. Unless the context otherwise clearly requires, "law" also includes the
13 common law;~~

14 **(11)**~~[(9)] "Minor" means any person who has not reached the age of majority as defined
15 in KRS 2.015;~~

16 **(12)**~~[(10)] "Misdemeanor" means an offense, other than a traffic infraction, for which a
17 sentence to a term of imprisonment of not more than twelve (12) months can be
18 imposed;~~

19 **(13)**~~[(11)] "Offense" means conduct for which a sentence to a term of imprisonment or to
20 a fine is provided by any law of this state or by any law, local law, or ordinance of a
21 political subdivision of this state or by any law, order, rule, or regulation of any
22 governmental instrumentality authorized by law to adopt the same;~~

23 **(14)**~~[(12)] "Person" means a human being, and where appropriate, a public or private
24 corporation, an unincorporated association, a partnership, a government, or a
25 governmental authority;~~

26 **(15)**~~[(13)] "Physical injury" means substantial physical pain or any impairment of
27 physical condition;~~

1 ~~(16)~~~~(14)~~ "Possession" means to have actual physical possession or otherwise to
2 exercise actual dominion or control over a tangible object;

3 **(17) "Riot" means a public disturbance involving an assemblage of five (5) or more**
4 **persons which by tumultuous and violent conduct creates grave danger of**
5 **damage or injury to property or persons or substantially obstructs law**
6 **enforcement or other government function;**

7 ~~(18)~~~~(15)~~ "Serious physical injury" means physical injury which creates a substantial
8 risk of death, or which causes serious and prolonged disfigurement, prolonged
9 impairment of health, or prolonged loss or impairment of the function of any bodily
10 organ. For a child twelve (12) years of age or less at the time of the injury, a serious
11 physical injury includes but is not limited to the following:

- 12 (a) Bruising near the eyes, or on the head, neck, or lower back overlying the
13 kidneys;
- 14 (b) Any bruising severe enough to cause underlying muscle damage as
15 determined by elevated creatine kinase levels in the blood;
- 16 (c) Any bruising or soft tissue injury to the genitals that affects the ability to
17 urinate or defecate;
- 18 (d) Any testicular injury sufficient to put fertility at risk;
- 19 (e) Any burn near the eyes or involving the mouth, airway, or esophagus;
- 20 (f) Any burn deep enough to leave scarring or dysfunction of the body;
- 21 (g) Any burn requiring hospitalization, debridement in the operating room, IV
22 fluids, intubation, or admission to a hospital's intensive care unit;
- 23 (h) Rib fracture;
- 24 (i) Scapula or sternum fractures;
- 25 (j) Any broken bone that requires surgery;
- 26 (k) Head injuries that result in intracranial bleeding, skull fracture, or brain injury;
- 27 (l) A concussion that results in the child becoming limp, unresponsive, or results

1 in seizure activity;

2 (m) Abdominal injuries that indicate internal organ damage regardless of whether
3 surgery is required;

4 (n) Any injury requiring surgery;

5 (o) Any injury that requires a blood transfusion; and

6 (p) Any injury requiring admission to a hospital's critical care unit;

7 ~~(19)~~~~(16)~~ "Unlawful" means contrary to law or, where the context so requires, not
8 permitted by law. It does not mean wrongful or immoral;

9 ~~(20)~~~~(17)~~ "Violation" means an offense, other than a traffic infraction, for which a
10 sentence to a fine only can be imposed; and

11 ~~(21)~~~~(18)~~ "Weapon of mass destruction" means:

12 (a) Any destructive device as defined in KRS 237.030, but not fireworks as
13 defined in KRS 227.700;

14 (b) Any weapon that is designed or intended to cause death or serious physical
15 injury through the release, dissemination, or impact of toxic or poisonous
16 chemicals or their precursors;

17 (c) Any weapon involving a disease organism; or

18 (d) Any weapon that is designed to release radiation or radioactivity at a level
19 dangerous to human life.

20 ➔Section 2. KRS 503.055 is amended to read as follows:

21 (1) A person is presumed to have held a reasonable fear of imminent peril of death or
22 great bodily harm to himself or herself or another when using defensive force that is
23 intended or likely to cause death or great bodily harm to another if:

24 (a) 1. The person against whom the defensive force was used was in the
25 process of unlawfully and forcibly entering or had unlawfully and
26 forcibly entered a dwelling, residence, or occupied vehicle, or if that
27 person had removed or was attempting to remove another against that

1 person's will from the dwelling, residence, or occupied vehicle; and

2 ~~2.[(b)]~~ The person who uses defensive force knew or had reason to
 3 believe that an unlawful and forcible entry or unlawful and forcible act
 4 was occurring or had occurred; or

5 **(b) 1. The person who uses defensive force does so during the course of a**
 6 **riot;**

7 **2. The person who uses defensive force would be justified in a use of**
 8 **defensive force under paragraph (a) of this subsection;**

9 **3. The person who uses defensive force does so in an attempt to escape**
 10 **the immediate vicinity of the unlawful and forcible entry; and**

11 **4. The person against whom defensive force was used was intentionally**
 12 **blocking or preventing the person from escape.**

13 (2) The presumption set forth in subsection (1) of this section does not apply if:

14 (a) The person against whom the defensive force is used has the right to be in or
 15 is a lawful resident of the dwelling, residence, or vehicle, such as an owner,
 16 lessee, or titleholder, and there is not an injunction for protection from
 17 domestic violence or a written pretrial supervision order of no contact against
 18 that person;

19 (b) The person sought to be removed is a child or grandchild, or is otherwise in
 20 the lawful custody or under the lawful guardianship of the person against
 21 whom the defensive force is used;

22 (c) The person who uses defensive force is engaged in an unlawful activity or is
 23 using the dwelling, residence, or occupied vehicle to further an unlawful
 24 activity; or

25 (d) The person against whom the defensive force is used is a peace officer, as
 26 defined in KRS 446.010, who enters or attempts to enter a dwelling,
 27 residence, or vehicle in the performance of his or her official duties, and the

1 officer identified himself or herself in accordance with any applicable law or
 2 the person using force knew or reasonably should have known that the person
 3 entering or attempting to enter was a peace officer.

4 (3) A person who is not engaged in an unlawful activity and who is attacked in any
 5 other place where he or she has a right to be has no duty to retreat and has the right
 6 to stand his or her ground and meet force with force, including deadly force, if he or
 7 she reasonably believes it is necessary to do so to prevent death or great bodily harm
 8 to himself or herself or another or to prevent the commission of a felony involving
 9 the use of force.

10 (4) A person who unlawfully and by force enters or attempts to enter a person's
 11 dwelling, residence, or occupied vehicle is presumed to be doing so with the intent
 12 to commit an unlawful act involving force or violence.

13 ➔SECTION 3. A NEW SECTION OF KRS CHAPTER 532 IS CREATED TO
 14 READ AS FOLLOWS:

15 **(1) A defendant shall be subject to an enhanced punishment under subsection (3) of**
 16 **this section if he or she is convicted of a crime and it is proven beyond a**
 17 **reasonable doubt that the defendant:**

18 **(a) Would not have committed the crime but for the riot, and**

19 **(b) Committed the crime:**

20 **1. During the course of a riot;**

21 **2. In reasonable proximity to the riot; and**

22 **3. With knowledge that a riot was occurring.**

23 **(2) Unless a jury trial has been waived, when a defendant is convicted of a crime and**
 24 **the defendant is charged with committing the underlying offense as described in**
 25 **subsection (1) of this section:**

26 **(a) The court shall conduct a hearing, separate from the proceeding that**
 27 **resulted in the defendant's conviction for the underlying offense, to**

1 determine whether the person committed the underlying offense as
2 described in subsection (1) of this section;

3 (b) The hearing shall be conducted by the same court and jury that convicted
4 the defendant of the underlying offense, unless the court for good cause
5 discharges that jury and impanels a new jury for that purpose; and

6 (c) The jury shall determine whether, beyond a reasonable doubt, the person
7 committed the underlying offense as described in subsection (1) of this
8 section.

9 (3) When a defendant has been found to have committed an offense during the
10 course of a riot or used the riot as an opportunity to engage in unrelated criminal
11 activity in reasonable proximity to the riot, his or her sentence for the underlying
12 offense shall be enhanced as follows:

13 (a) If the underlying offense is a Class B misdemeanor:

14 1. The person shall not be released on probation, shock probation,
15 parole, conditional discharge, or any other form of early release prior
16 to the expiration of forty-five (45) days; and

17 2. A fine of two hundred fifty dollars (\$250) shall be assessed,
18 notwithstanding KRS 534.040;

19 (b) If the underlying offense is a Class A misdemeanor:

20 1. The person shall not be released on probation, shock probation,
21 parole, conditional discharge, or any other form of early release prior
22 to the expiration of three (3) months; and

23 2. A fine of five hundred dollars (\$500) shall be assessed,
24 notwithstanding KRS 534.040;

25 (c) If the underlying offense is a Class D felony:

26 1. The person shall not be released on probation, shock probation,
27 parole, conditional discharge, or any other form of early release prior

1 to the person's initial parole eligibility date consistent with
2 administrative regulations promulgated pursuant to KRS 439.340; and

3 2. A fine of five thousand dollars (\$5,000) shall be assessed,
4 notwithstanding KRS 534.040;

5 (d) If the underlying offense is a Class C felony:

6 1. The person shall not be released on probation, shock probation,
7 parole, conditional discharge, or any other form of early release prior
8 to the person's initial parole eligibility date consistent with
9 administrative regulations promulgated pursuant to KRS 439.340; and

10 2. A fine of seven thousand five hundred dollars (\$7,500) shall be
11 assessed, notwithstanding KRS 534.040;

12 (e) If the underlying offense is a Class B felony:

13 1. The person shall not be released on probation, shock probation,
14 parole, conditional discharge, or any other form of early release prior
15 to the person's initial parole eligibility date consistent with
16 administrative regulations promulgated pursuant to KRS 439.340; and

17 2. A fine of ten thousand dollars (\$10,000) shall be assessed,
18 notwithstanding KRS 534.040;

19 (f) If the underlying offense is a Class A felony:

20 1. The person shall not be released on probation, shock probation,
21 parole, conditional discharge, or any other form of early release prior
22 to the person's initial parole eligibility date consistent with
23 administrative regulations promulgated pursuant to KRS 439.340; and

24 2. A fine of ten thousand dollars (\$10,000) shall be assessed,
25 notwithstanding KRS 534.040.

26 ➔SECTION 4. A NEW SECTION OF KRS CHAPTER 431 IS CREATED TO
27 READ AS FOLLOWS:

1 *Notwithstanding KRS 431.066 and 431.520, a person who has been charged with an*
2 *offense during the course of a riot shall not be released until forty-eight (48) hours*
3 *have passed since the time of arrest and the person appears before a judge.*

4 →Section 5. KRS 508.025 is amended to read as follows:

5 (1) A person is guilty of assault in the third degree when the actor:

6 (a) Recklessly, with a deadly weapon or dangerous instrument, or intentionally
7 causes or attempts to cause physical injury to:

8 1. A state, county, city, or federal peace officer;

9 2. An employee of a detention facility, or state residential treatment facility
10 or state staff secure facility for residential treatment which provides for
11 the care, treatment, or detention of a juvenile charged with or
12 adjudicated delinquent because of a public offense or as a youthful
13 offender;

14 3. An employee of the Department for Community Based Services
15 employed as a social worker to provide direct client services, if the event
16 occurs while the worker is performing job-related duties;

17 4. Paid or volunteer emergency medical services personnel certified or
18 licensed pursuant to KRS Chapter 311A, if the event occurs while
19 personnel are performing job-related duties;

20 5. A paid or volunteer member of an organized fire department, if the event
21 occurs while the member is performing job-related duties;

22 6. Paid or volunteer rescue squad personnel affiliated with the Division of
23 Emergency Management of the Department of Military Affairs or a local
24 disaster and emergency services organization pursuant to KRS Chapter
25 39F, if the event occurs while personnel are performing job-related
26 duties;

27 7. A probation and parole officer;

- 1 8. A transportation officer appointed by a county fiscal court or legislative
2 body of a consolidated local government, urban-county government, or
3 charter government to transport inmates when the county jail or county
4 correctional facility is closed while the transportation officer is
5 performing job-related duties;
- 6 9. A public or private elementary or secondary school or school district
7 classified or certified employee, school bus driver, or other school
8 employee acting in the course and scope of the employee's employment;
9 or
- 10 10. A public or private elementary or secondary school or school district
11 volunteer acting in the course and scope of that person's volunteer
12 service for the school or school district;
- 13 (b) Being a person confined in a detention facility, or a juvenile in a state
14 residential treatment facility or state staff secure facility for residential
15 treatment which provides for the care, treatment, or detention of a juvenile
16 charged with or adjudicated delinquent because of a public offense or as a
17 youthful offender, inflicts physical injury upon or throws or causes feces, or
18 urine, or other bodily fluid to be thrown upon an employee of the facility; ~~or~~
- 19 (c) Intentionally causes a person, whom the actor knows or reasonably should
20 know to be a peace officer discharging official duties, to come into contact
21 with saliva, vomit, mucus, blood, seminal fluid, urine, or feces without the
22 consent of the peace officer; or
- 23 *(d) Intentionally causes physical injury to a law enforcement officer or*
24 *emergency services personnel by means of chemical agents or fireworks.*
- 25 (2) (a) For violations of subsection (1)(a), ~~and~~ (b), and (d) of this section, assault in
26 the third degree is a Class D felony.
- 27 (b) 1. For violations of subsection (1)(c) of this section, assault in the third

1 degree is a Class B misdemeanor, unless **committed during the course**
 2 **of a riot, in which case it is a Class A misdemeanor.**

3 **2. If** the assault is with saliva, vomit, mucus, blood, seminal fluid, urine, or
 4 feces from an adult who knows that he or she has a serious
 5 communicable disease and competent medical or epidemiological
 6 evidence demonstrates that the specific type of contact caused by the
 7 actor is likely to cause transmission of the disease or condition~~, in~~
 8 ~~which case~~ it is a Class A misdemeanor, **unless committed during the**
 9 **course of a riot, in which case it is a Class D felony.**

10 (c) As used in **subparagraph**~~[paragraph]~~ **2.**~~[(b)]~~ of **paragraph (b)**~~[this~~
 11 ~~subsection]~~, "serious communicable disease" means a non-airborne disease
 12 that is transmitted from person to person and determined to have significant,
 13 long-term consequences on the physical health or life activities of the person
 14 infected.

15 ➔Section 6. KRS 508.030 is amended to read as follows:

16 (1) A person is guilty of assault in the fourth degree when:

17 (a) He **or she** intentionally or wantonly causes physical injury to another person;~~[~~
 18 ~~or]~~

19 (b) With recklessness he **or she** causes physical injury to another person by means
 20 of a deadly weapon or a dangerous instrument; **or**

21 **(c) He or she knowingly shines or aims a light, laser, or activated horn or other**
 22 **noise-making device towards the head of a law enforcement officer or**
 23 **emergency services personnel with the intent to affect their ability to safely**
 24 **and adequately perform their duties.**

25 (2) Assault in the fourth degree is a Class A misdemeanor.

26 ➔SECTION 7. A NEW SECTION OF KRS CHAPTER 511 IS CREATED TO
 27 READ AS FOLLOWS:

1 (1) As used in this section, "camping" means, at any time between 10 p.m. and 7

2 a.m.:

3 (a) Erecting, placing, maintaining, leaving, allowing to remain, or using a
4 piece of furniture, tent, raised tarp, or other temporary shelter, structure, or
5 furniture;

6 (b) Sleeping or making preparation to sleep, including laying down a sleeping
7 bag, blanket, or other material used for bedding;

8 (c) Placing or storing personal belongings for future use, including storing
9 food for consumption;

10 (d) Carrying on cooking activities, whether by fire or use of artificial means,
11 such as a propane stove or other heat-producing portable cooking
12 equipment;

13 (e) Making a fire or preparing to make a fire; or

14 (f) Doing any digging or earth breaking.

15 (2) (a) A person is guilty of unlawful camping on property owned by the
16 Commonwealth when:

17 1. He or she knowingly camps on an area which is not specifically
18 designated for use as a camping area by the department or agency
19 responsible for the land; and

20 2. He or she camps during the course of a riot or within twenty four (24)
21 hours following a riot.

22 (b) A person shall not be guilty of a violation of this section unless the person
23 received a warning not to engage in camping from an official responsible
24 for the protection of the property in question and continued to engage in
25 camping or returned within twenty-four (24) hours of the warning to
26 continue to engage in camping.

27 (3) Any items used to commit a violation of this section, including items abandoned

1 at the location of the offense, are subject to confiscation, seizure, and claiming in
2 accordance with subsection (4) of this section.

3 (4) (a) Any property subject to confiscation or seizure under subsection (3) of this
4 section, or left unattended after arrest or issuance of a citation for camping
5 in violation of subsection (2) of this section, and taken into custody shall be
6 held in a secure location for a period of ninety (90) days.

7 (b) Notice containing the contact information of the state agency or agent
8 holding the property shall be posted at the nearest reasonable location to the
9 place from which the property was removed.

10 (c) If the property is not claimed within ninety (90) days of being taken into
11 custody, the property is deemed abandoned and the agency or agent may
12 dispose of the property, unless the property is needed as evidence in a
13 criminal proceeding.

14 (d) If a person claiming any such property within ninety (90) days of the
15 property being taken into custody produces identification and signs a
16 release form providing such person's name and contact information and
17 swearing under oath that the property belongs to the person, the state
18 agency or agent shall return the property to the person, unless the property
19 is needed for evidence in a criminal proceeding, in which case it shall be
20 returned following the conclusion of that proceeding.

21 (e) The state agency or agent may charge such persons a reasonable storage fee
22 for storing the property. The state and state employees, agents, and
23 contractors shall be immune from liability for confiscation of property in
24 compliance with this subsection.

25 (5) Unlawful camping on property owned by the Commonwealth is a Class A
26 misdemeanor. Upon a second or subsequent offense, unlawful camping is a Class
27 D felony.

1 **(6) No person shall be convicted of unlawful camping on property owned by the**
 2 **Commonwealth when he or she is a homeless individual as defined in KRS**
 3 **198A.700.**

4 ➔Section 8. KRS 520.090 is amended to read as follows:

5 (1) A person is guilty of resisting arrest when he intentionally prevents or attempts to
 6 prevent a peace officer, recognized to be acting under color of his official authority,
 7 from effecting an arrest of the actor or another by:

8 (a) Using or threatening to use physical force or violence against the peace officer
 9 or another; or

10 (b) Using any other means creating a substantial risk of causing physical injury to
 11 the peace officer or another.

12 (2) Resisting arrest is a Class A misdemeanor **unless committed during the course of a**
 13 **riot, in which case it is a Class D felony.**

14 ➔Section 9. KRS 525.015 is amended to read as follows:

15 (1) As used in this section, "emergency responder" means state or local law
 16 enforcement personnel, fire department personnel, corrections officers, and
 17 emergency medical personnel and those contracted for official use by emergency
 18 responders.

19 (2) No person shall intentionally obstruct or disrupt an emergency responder from
 20 performing his or her official duties.

21 (3) Obstructing an emergency responder is a violation for a first offense, and a Class B
 22 misdemeanor for a second or subsequent offense **unless committed during the**
 23 **course of a riot, in which case it is a Class D felony.**

24 ➔Section 10. KRS 525.020 is amended to read as follows:

25 (1) A person is guilty of riot in the first degree when:

26 (a) **1.** He **or she** knowingly participates in a riot

27 **2.** **He or she knowingly provides supplies to a riot that can be used as**

1 *weapons or dangerous instruments*; and

2 (b) In the course of and as a result of such riot a person other than one (1) of the
3 participants suffers physical injury or substantial property damage occurs.

4 (2) Riot in the first degree is a Class D felony.

5 ➔Section 11. KRS 525.030 is amended to read as follows:

6 (1) A person is guilty of riot in the second degree when:

7 (a) He *or she* knowingly participates in a riot; *or*

8 (b) *He or she knowingly provides supplies to a riot that can be used as weapons*
9 *or dangerous instruments.*

10 (2) Riot in the second degree is a Class A misdemeanor.

11 ➔Section 12. KRS 525.060 is amended to read as follows:

12 (1) A person is guilty of disorderly conduct in the second degree when in a public place
13 and with intent to cause public inconvenience, annoyance, or alarm, or wantonly
14 creating a risk thereof, he:

15 (a) Engages in fighting or in violent, tumultuous, or threatening behavior;

16 (b) Makes unreasonable noise;

17 (c) Refuses to obey an official order to disperse issued to maintain public safety
18 in dangerous proximity to a fire, hazard, or other emergency;~~or~~

19 (d) Creates a hazardous or physically offensive condition by any act that serves no
20 legitimate purpose; *or*

21 (e) *Accosts, insults, taunts, or challenges a law enforcement officer with*
22 *offensive or derisive words, or by gestures or other physical contact, that*
23 *would have a direct tendency to provoke a violent response from the*
24 *perspective of a reasonable and prudent person.*

25 (2) Disorderly conduct in the second degree is a Class B misdemeanor.

26 ➔Section 13. KRS 525.140 is amended to read as follows:

27 (1) A person is guilty of obstructing a highway or other public passage;

1 (a) When having no legal privilege to do so he, alone or with other persons,
 2 intentionally or wantonly renders any highway or public passage impassable
 3 without unreasonable inconvenience or hazard; or

4 (b) Alone or with other persons, intentionally or wantonly prevents law
 5 enforcement officers from accessing an assembly, protest, demonstration, or
 6 other gathering of people on a highway or public passage.

7 (2) No person shall be convicted under this section solely because of a gathering of
 8 persons to hear him speak or otherwise communicate or solely because of being a
 9 member of such a gathering.

10 (3) An order to disperse issued by a peace officer or other public servant engaged in
 11 executing or enforcing the law and addressed to a person whose speech or other
 12 lawful behavior attracts an obstructing audience shall not be deemed lawful if the
 13 obstruction can be readily remedied by police control of the size or location of the
 14 gathering.

15 (4) Obstructing a highway or other public passage is a Class B misdemeanor unless
 16 committed during the course of a riot, in which case it is a Class D felony.

17 ➔Section 14. KRS 439.3401 is amended to read as follows:

18 (1) As used in this section, "violent offender" means any person who has been
 19 convicted of or pled guilty to the commission of:

20 (a) A capital offense;

21 (b) A Class A felony;

22 (c) A Class B felony involving the death of the victim or serious physical injury
 23 to a victim;

3 security risk, or needs protective custody beyond that which can be provided in a
4 jail. The commissioner of the Department of Corrections shall evaluate the request
5 and transfer the inmate if he or she deems it necessary. If the commissioner refuses
6 to accept the felon inmate, and the Circuit Judge of the county that has jurisdiction
7 of the offense charged is of the opinion that the felon cannot be safely kept in a jail,
8 the Circuit Judge, with the consent of the Governor, may order the felon transferred
9 to the custody of the Department of Corrections.

10 (7) Class D felons and Class C felons serving their time in a jail shall be considered
11 state prisoners, and, except as provided in subsection (5)(f) of this section, the
12 Department of Corrections shall pay the jail in which the prisoner is incarcerated a
13 per diem amount determined according to KRS 431.215(2). For other state
14 prisoners and parole violator prisoners, the per diem payments shall also begin on
15 the date prescribed in KRS 431.215(2), except as provided in subsection (5)(f) of
16 this section.

17 (8) State prisoners, excluding the Class D felons and Class C felons qualifying to serve
18 time in jails, shall be transferred to the state institution within forty-five (45) days of
19 final sentencing.

20 (9) (a) Class D felons eligible for placement in a jail may be permitted by the warden
21 or jailer to participate in any approved community work program or other
22 form of work release with the approval of the commissioner of the
23 Department of Corrections.

24 (b) The authority to release an inmate to work under this subsection may be
25 exercised at any time during the inmate's sentence, including the period when
26 the court has concurrent authority to permit work release pursuant to KRS
27 439.265.

1 (c) The warden or jailer may require an inmate participating in the program to pay
 2 a fee to reimburse the warden or jailer for the cost of operating the community
 3 work program or any other work release program. The fee shall not exceed the
 4 lesser of fifty-five dollars (\$55) per week or twenty percent (20%) of the
 5 prisoner's weekly net pay earned from the community work program or work
 6 release participation. In addition, the inmate may be required to pay for any
 7 drug testing performed on the inmate as a requirement of the community work
 8 program or work release participation.

9 (d) This subsection shall not apply to an inmate who:

- 10 1. Is not eligible for work release pursuant to KRS 197.140;
- 11 2. Has a maximum or close security classification as defined by
 12 administrative regulations promulgated by the Department of
 13 Corrections;
- 14 3. Is subject to the provisions of KRS 532.043; or
- 15 4. Is in a reentry center as defined in KRS 441.005.

16 ➔Section 23. KRS 525.200 is amended to read as follows:

17 (1) A person is guilty of assault on a service animal in the first degree when, without
 18 legal justification or lawful authority:

- 19 (a) He or she intentionally kills or causes serious physical injury to a service
 20 animal;
- 21 (b) He or she intentionally causes physical injury to a service animal by means of
 22 a deadly weapon or dangerous instrument; or
- 23 (c) He or she wantonly causes serious physical injury to a service animal by
 24 means of a deadly weapon or dangerous instrument.

25 (2) For the purposes of this section, "service animal" has the same meaning as in KRS
 26 525.010, except that "service animal" does not include assistance dogs as in KRS
 27 525.010(5)(~~6~~)(h).

- 1 (3) Assault on a service animal in the first degree is a Class D felony.
