

## SERVICE AGREEMENT

MADE THIS 18<sup>th</sup> day of November, 2020, by and between CSAU-1, LLC, 1068 Holland Road, Greenville, South Carolina 29607, EIN [REDACTED] (hereinafter referred to as "CSAU"), and the County of York, Pennsylvania, at the lawful request and authorization of the York County Prison Board, 3400 Concord Road, York, Pennsylvania 17402 (hereinafter referred to as "County").

WITNESSETH, "CSAU", as Seller, agree with "County", as Buyer, to the following terms of this Agreement.

1. "CSAU" shall provide confidential training for up to eighteen (18) York County Correction Officers, as selected by the "County".

2. The services shall include both training by Corrections Special Applicators Unit Development, Tier I, with instructors and the delivery of ancillary equipment to include:

3. Training includes all modules and lessons discussed in the "CSAU" proposal, with is listed and agreed herein as Corrections Confidential. In addition to the training, "CSAU" agrees to provide support and to defend "York County" and York County Prison and any of its Correction Officers, agents, or employees in any litigation, disputes, or arguments regarding the training tactics, and use of force application by providing expert witness testimony and guidance as needed. The cost associated with expert witness testimony and guidance shall be that of "CSAU".

4. The agreed amount for providing the training and ancillary equipment noted above is \$122,850.00. All weapon sales shall be accomplished through a certified FFL dealer. Payment shall be made upon approval of this Agreement.
