(COUNT 1) 21 O.S. 716

ROBERT CHARLES BATES, on or about 4/2/2015, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of MANSLAUGHTER--SECOND DEGREE, a Felony, by unlawfully, feloniously, and willfully cause and effect the death of a human being, to-wit: one Eric Courtney Harris by an act of culpable negligence on the part of the said Robert Charles Bates to-wit: the defendant shot the victim with a Smith & Wesson Revolver which at the time he shot it he believed it to be a Taser gun, which acts were the direct and proximate cause on the death of the said Eric Courtney Harris,
