ON FRIDAY 07/24/2015 UNITS WERE DISPATCHED TO SAVE-A-LOT FOR A REPORT OF A DISTURBANCE. ON SCENE I, SGT GIDEON CAME INTO CONTACT WITH MR. BRANDON JONES (08/28/1976) WHO STATED HE WAS ATTACKED BY HIS EX-WIFE, RALKINA JONES (04/18/1978).

BRANDON STATED HE WAS SITTING IN ONE OF THE LOCAL BUSINESSES WHEN SOMEONE CAME IN AND TOLD HIM THAT HIS CAR WAS BEING DAMAGED BY A FEMALE. BRANDON WENT OUTSIDE AND SAW HIS EX-WIFE HAVING BROKEN OUT THE DRIVER'S SIDE WINDOW OF HIS FORD EXPEDITION (OH PC/GLU6574) AND ATTEMPTED TO SMASH THE WINDSHIELD AS WELL. RALKINA THEN TURNED HER ATTENTION TO BRANDON SWINGING THE SLIVER TIRE IRON AT HIM. RALKINA STRUCK BRANDON ON HIS LEFT FOREARM CAUSING A CUT APPROXIMATELY 2-3 INCHES IN LENGTH. BRANDON ALSO HAD SCRATCHES TO THE LEFT SIDE OF HIS FACE. BRANDON WAS ABLE TO GET THE TIRE IRON AWAY FROM RALKINA AND THROW IT TO THE SIDE AS SHE CONTINUED TO STRIKE HIM.

BRANDON AND ANOTHER MALE HE WAS WITH, LONNIE T. WHITE (02/28/1977) WALKED AWAY (TOWARDS NOBLE ROAD) FROM RALKINA AND WHERE SHE HAD ASSAULTED BRANDON AND DAMAGED HIS CAR. RALKINA THEN GOT INTO HER VEHICLE (OH PC/FPJ5924) AND DROVE AT BRANDON AND WHITE. BOTH MALES SAID THEY HAD TO JUMP OUT OF THE WAY, AND WERE A COUPLE FEET FROM ALMOST BEING STRUCK BY RALKINA'S VEHICLE. WHITE ALSO STATED THAT RALKINA ATTEMPTED TO STRIKE HIM WITH THE TIRE IRON AS WELL. SHE WAS NOT ABLE TO STRIKE HIM WITH IT THOUGH.

DURING THE INCIDENT, RALKINA'S 12YO DAUGHTER, KAYLA TUCKER WAS IN THE BACK SEAT OF HER VEHICLE, WHICH SHE ATTEMPTED TO RUN BRANDON OVER WITH.

AN INDEPENDENT WITNESS, LUCRETIA ALDRIDGE (02/08/1972) CONFIRMED BRANDON'S AND WHITE'S VERSION OF EVENTS. ALDRIDGE STATED THAT RALKINA WAS "BANG UP A MAN'S VEHICLE. SHE THEN KEPT GRABBING HIM AND SHE TRIED TO RUN HIM AND ANOTHER MAN OVER WITH HER VEHICLE."

OFFICER REICHARD RESPONDED TO THE SCENE AND TOOK PHOTOGRAPHS OF THE INJURIES TO BRANDON, THE DAMAGE TO HIS VEHICLE AND THE TIRE IRON USED TO ASSAULT BRANDON WITH AND DAMAGE HIS VEHICLE.

RALKINA WAS ARRESTED AND RETURNED TO THE CLEVELAND HEIGHTS POLICE STATION WHERE SHE WAS BOOKED IN WITHOUT INCIDENT. I DID NOTICE BLOOD ON RALKINA'S ARM AND CHEEK. SHE DID NOT HAVE ANY INJURIES ON HER AT ALL.

THE TIRE IRON WAS RETURNED TO THE CLEVELAND HEIGHTS POLICE STATION, LOGGED INTO THE EVIDENCE COMPUTER AND PLACED INTO LOCKER #7.

BRANDON DECLINED TO PROSECUTE RALKINA. I SIGNED COMPLAINTS FOR FELONIOUS ASSAULT, DOMESTIC VIOLENCE AND CHILD ENDANGERING AGAINST RALKINA.
