The undersigned Affiant, being a Peace Officer under the laws of Texas and being duly sworn, on oath makes the following statements and accusations:

1. **There is in Dallas County, Texas, a suspected place and premises and located as follows:** A one story single family dwelling with multi-colored tan and brown brick, composition brown and white roof, tan molding, with the numbers 2000 above the entrance, specifically located at 2000 Spanish Trail, Irving, Dallas County, Texas.

2. **There is at said suspected place and premises property concealed and kept in violation of the laws of Texas and described as follows:** silver handgun, bullets, shell casings, human blood, red shirt, gray shirt, black pants, black T-shirt or sweater or any other item that might link a suspect to this offense.

3. **Said suspected place and premises are in charge of and controlled by each of the following persons:**

4. **It is the belief of Affiant, and he hereby charges and accuses, that:** the person(s) listed in number three above has at the location listed in number one above the items described in number two above that will assist in the investigation of the offense of Murder, P.C. 19.02

5. **Affiant has probable cause for said belief by reason of the following facts:**

A. On 8-29-15 at 10:37am the Irving Police Department started receiving calls about a shooting at 2024 Meadow Lark Drive, Irving, Dallas County, Texas. Callers reported seeing one male chasing another while shooting at him. Another caller stated that two people had been shot. It was reported that there were two Hispanic male suspects and callers reported hearing 2 to 3 shots. Officers with the Irving Police Department responded to 2024 Meadow Lark Drive, Irving, Dallas County, Texas and found victim Maurice Crawford and victim Demorius Ducking with gunshot wounds. The victims were transported to Parkland Memorial Hospital where Maurice Crawford was pronounced as deceased. Demorius Ducking is being treated for his wounds. The victims were shot in the front of 2024 Meadow Lark Drive.

B. On 8-29-15 Mary Ducking was interviewed and stated that she was inside her residence at 2024 Meadow Lark Drive when two of her children told her that victim Maurice Crawford (her boyfriend) was outside in a fight. Victim-Demorius Ducking ran out before her and when she got outside saw a Hispanic male chasing Demorius with a silver handgun around a car. The Hispanic male then shot Demorius. The Hispanic male, who she described as wearing a gray shirt, then ran away towards Meandering drive.

C. On 8-29-15 Irving Officers talked to witnesses that reported seeing two Hispanic males running from the area of Meadow Lark down Meandering Drive and into the house at 2000 Spanish Trail, Irving, Dallas County, Texas. Witnesses described one suspect as wearing a red shirt and black pants and one was wearing a black shirt. Officers set up a perimeter around the house at 2000 Spanish Trail. While setting up a perimeter around the house someone was seen going into a shed behind the house and then returning to the house. juvenile) came out of the house and was arrested. Miguel Martinez, date of birth 1-27-1998, came out of the house later and he was arrested also.

D. On 8-29-15 Irving Officer Ausen went to Parkland Hospital to check on the victims and was able to talk to victim-Demorius Ducking who stated that he saw _____ on the ground fighting with Maurice Crawford, _____ then hollered for Miguel to shoot Maurice. Demorius stated that Miguel then shot Maurice Crawford and then came over and shot him. Demorius stated that he knew both _____ and Miguel from school but did not know Miguel's last name.

Wherefore, Affiant asks for issuance of a warrant that will authorize him to search said suspected place and premises including all out buildings and curtilage for said property and seize the same and to arrest each said described and accused person.
