On Saturday, 09/05/2015 at 2106 hours, Berea Units were dispatched to Eastland Road in regards to a female reporting an assault that occurred in a home on The victim had left the home and the responding officers spoke to her on Eastland Road, while other officers spoke to the second party involved at his home at . Berea units investigated the initial incident and there were conflicting stories of what had occurred. There were no initial injuries observed and the case was going to be forwarded to the Berea Prosecutor. The victim was transported to a hotel in Middleburgh Heights at her request.

At approximately 0000 hours, on 09/06/2015, the victim contacted the Berea Police and stated she still wished to pursue charges, and had an injury from the incident, which was not originally visible. Sgt. Napaver responded to the hotel and an Assault (M1) complaint was signed by the victim as a result of the second call. At 0755 hours Sgt. Napaver responded back to the hotel again at the victim's request and spoke to the victim. The victim stated she now wanted to drop the assault charge. The victim completed a
