On September 15, 2015 I Officer Fielder arrived at 27034 JARVIS ROAD, I made contact with Deputy Faccilonga id # 05255, case number 15-393630. She had been called to the residence for an alarm call when she noticed two black canines that she believed to be very thin. She also spotted a cat in the house. She had spoken to the neighbors at 27040 Jarvis Rd who said they usually see someone going in and out of the house regularly but hasn't seen anyone in several days. The canines are not in distress at this time. At least the one canine I could see appeared thin and had some skin issues, however the dog was a senior dog and appeared to ok at that time. The older one came outside in the back yard to greet us and appeared to be alert, approachable and in questionable health but appeared in good spirits (see photos). The other canine would not come out and was hiding in a room we could not see. The dogs have doggie doors into the house, out on to the lanai and in the back yard that is fenced. The Deputy said they had a large bucket of water but no food that she could see. Since no one has seen anyone there in days I went ahead and left some dog food for the canines on the lanai.

I posted the property with three 24 hour notices and left a door notice to contact LCDAS.
