

Comments			
While driving on PCH and towing a dune buggy, suspect rear ended victim's vehicle causing the victim's car to veer into opposing traffic where victim's car was hit by a second vehicle, resulting in her death. Suspect was traveling at a speed slightly below posted speed limit and minimally slower than victim. At 4.2 seconds before impact, victim engaged her brakes and started to slow. Suspect disengaged gas pedal and his car started to slow. Suspect engaged brakes within 1.9 to 1.5 seconds before impact. Crime requires violation of misdemeanor or infraction. Only possible violation is VC 22350, a violation of the basic speed law. Crime also requires ordinary negligence. Based on facts, cannot prove beyond a reasonable doubt that suspect's conduct was unreasonable.
