NARRATIVE

On 10/21/15 at approximately 1317hrs, I, Officer Gualdoni #349 was dispatched to in Lake Forest in reference to a possible trespassing issue.
l arrived on location and met with the complainant identified informed me earlier in the day staff cut a player identified as pending further team disciplinary action.
informed me then returned a short time later, at which time security would not allow him to drive past the front gate of the property advised parked his vehicle at the gate and walked past security and up to the building advising he needed to get his belongings. yesterday, he felt like killing everybody in the building. gathered belongings and left the property without further incident.
advised returned to the property a short time later advising he needed his cell phone from the locker room. Security would not allow through the front gate. He again parked his vehicle and entered the property on foot. Informed me he made contact with on the property and was escorting to retrieve his phone, at which time told am the devil" and he wished staff member's children would die. Informed multiple times he is not to return to the property and must leave then left the property without further incident.
described as very angry and irrational and believed informed me he had concern for the safety of staff on the property due to behavior and statements also advised it is believed bwns multiple firearms informed me is known to drive a truck with black rims and dark tinting on the windows with possible I ran the provided registration through advised he did not have
any information or residence, as refused to provide that information to staff for their records.
concerning statements he made to staff. Informed me he believed was a credible threat to staff on the property.

When called, the number went straight to an automated message that did not allow voicemails to be left. A GPS ping of the cellular phone was conducted and showed a location in the state of Texas.
asked for police presence until staff left the property at 1800hrs that day (10/21). He also asked for police presence when staff began to arrive at 0500hrs the following day (10/22). Advised is not allowed on the property at Football Drive in Lake Forest, and he would sign a complaint for trespassing if returned to the property. LFPD provided a uniformed officer to stand by on the property during the requested time.
