RP#1, an employee of the VOA called the PSCC and advised that VI#1, a resident of the facility, was being combative. RP#1 advised that VI#1 appeared as if he was having a reaction to something. RP#1 further advised that the subject was trying to assault people and that they were having a hard time trying to control him.

Officers and MFD were dispatched to the location. Upon arrival the staff told the first responding Officer, Ptl. Hornback that he would need more Officers due to VI#1's violent behavior. Officers were able to make contact with VI#1 inside the facility in a day room area with the assistance of VOA staff and Officers from Adult Parole.

VI#1 was handcuffed without incident, and officers began to walk him to the front entrance of the facility to be checked by MFD. VI#1 was provided a chair to sit in while MFD began to evaluate him. While sitting in the chair, VI#1 became agitated and attempted to assault MFD staff. At this point, VI#1 had to be carried out of the building by his arms and legs as he continued to be combative and refused to walk so he could be treated further by MFD.

As Officers got VI#1 to the area of the cruiser he continued being combative and was able to break free from the handcuffs. Officers began to struggle with VI#1 as they attempted to regain control of him and Officers had to deploy the taser to attempt to subdue him.

Shortly after the taser was deployed, officers observed that VI#1 was unresponsive. MFD immediately began administering care to VI#1 and he was transported to MCM.

This Officer responded to the incident location and arrived as MFD was leaving for MCM. At this point the scene was already marked off with crime scene tape. I advised Ptl. Reed to begin a crime scene log. I then began to speak with officers on scene about the incident. I made contact with Captain Snavely via telephone as he was responding to the scene. Detective Sgt. Carroll then arrived on scene and the scene was handed over to him. Ptl. Webb and Ptl. Hornback were posted inside of the facility to secure the area where contact was initially made with VI#1.

Sgt. Garrick, Lt. Skropits, Detective Parella, A/C Porch, Chief Coontz, and Assistant Prosecutor Cliff Murphy responded to the scene.

Detective Bushong responded to MCM ER.

While on scene it was learned that VI#1 had been pronounced deceased at MCM ER.

Sgt. Carroll then advised the PSCC to contact BCI to respond. BCI responded and the scene was turned over to Agent Eric Lenhart.

Officers were dispatched to the incident location in reference to assisting the VOA with a disorderly resident. This officer responded after Officers on the scene requested a supervisor. Upon arrival VI#1 was already being transported by MFD to MCM. Sgt Brane was also on scene. Officers were contacted and they advised that VI #1 was handcuffed while inside the facility. Officers then advised that while attempting to bring VI #1 outside to the cruiser that he became disorderly, would not comply with orders and began fighting with Officers. Officers further advised that at some point either a handcuff malfunctioned or VI #1 "slipped" the handcuff and he was able to get an arm free. At some point while Officers were attempting to regain control of VI #1, VI #1 "tossed" Officer O. Chatman off of him and VI #1 also struck Officer P. Webb in the face, VI #1 was tasered at some point with no effect on him. This Officer assisted with securing the scene. This Officer took some photos/recordings of the scene and Officer Webb who had visible redness to the left side of his face where he was struck by VI #1. Contact was made with staff throughout the investigation and they advised that they were told that VI#1 had been smoking "posh." Staff advised that VI#1 had been "going off" and could not be controlled. Staff also advised that VI#1 assaulted another resident. Staff then advised that VI #1 "trashed" the day room. The day room was in visible disarray and there was damage to some of the property. The window to the door was broken and the clock that hangs above the door was on the floor and broken. Staff advised that VI #1 continued to "open and slam" shut the day room door resulting in the clock falling to the ground and breaking. The fire extinguisher was tilted on the wall and the exit sign was also crooked from VI #1 opening and closing the door numerous times. Contact was then made with David Dean, resident at the VOA. His home address is 4488 St Rt 598, Crestline, OH. His phone number is 567-307-8277. Mr. Dean advised that prior to Police being called that VI #1 walked up to him and grabbed his shirt. Mr. Dean then advised that VI #1 slapped him across the face resulting in Mr. Dean's glasses breaking. Mr. Dean stated that he could tell VI#1 "was on something because you could look at him and tell he wasn't really there." Mr. Dean then stated that he had not had any prior incidents with VI#1. After the assault and VI#1's continued disorderly actions MPD was called. Photos were taken of Mr. Dean. This Officer secured from the scene and transported Officers on station to assist with gathering their uniforms, etc. This Officer then transported some of the Officers to the hospital for a urine screen and then brought them back to MPD at which time we secured.

On March 10th at approximately 1550hrs I heard officers at the VOA on N. Main St. over the radio who sounded like they were in trouble. I went to the radio room to check on the nature of the call and the status of the officers. Once in the PSCC I heard Officer Hornback call for supervisors on scene and responded to the VOA. I arrived at the VOA at 1615hrs and observed crime scene tape cordoning off an area of the parking lot in front of the building and officers near the front of the building. I contacted Sgt. Brane and was told the basics of what had occurred. Sgt. Brane informed me that the scene of the RTR had been secured and that a crime scene log had been started. I told the sergeants they were still in charge of the scene in spite of my presence along with the assistant chief and Sgt. Carroll from major crimes being there. Sgt. Brane informed me that Mr. Moxley was being checked by MFD in the outer lobby when he tried to head butt or bite one of the paramedics and had been taken to the floor by officers. Officers then were taking him to the closest cruiser when he became dead weight and refused to walk. At the cruiser Mr. Moxley had broken, or slipped out of his handcuffs and during a struggle with officers had been tased twice in an effort to subdue and control him. Sgt. Brane advised Mr. Moxley seemed to be under the influence of drugs and that upon regaining control of him, officers noticed he was in medical distress and summoned MFD, who were standing nearby, over to render first aid. Mr. Moxley had left the scene in an ambulance prior to my arrival. Det. Bushong was heard to be enroute to MCM to check on his condition.

I was advised the incident started in a "day room" near the back of the facility next to a dormitory room where Mr. Moxley was bunking along with numerous other people. I suggested to Sgt. Brane that he immediately secure those areas and post an officer to keep them secure until they could be photographed and searched.

Det. Bushong reported via cell phone that MCM personnel were working on Mr. Moxley, and his condition was in question. AC Porch and I conferred and he had also spoken to the chief of police via cell phone. It was decided that we would hold the scene until Mr. Moxley's condition was known. Sgt. Brane was advised to have PSCC request mutual aid from RCSO and OSP until a determination was made on who would be handling the incident and its severity.

A short time later Det. Bushong reported that Mr. Moxley had been declared deceased.

A call was then placed to BCI&I for investigators and crime scene units to respond and take over the investigation. I instructed Sgt. Brane to make the call to PSCC to order night shift officers in early to assume street duties and to have at least two of them report to the VOA to assume guard duties so all officers involved could be relived from the scene and taken on station. There were insufficient officers working to cover both the street and the scene at the time and two robberies were called in to be investigated while the VOA incident was in progress.

AC Porch, Sgt. Carroll and I went to an office area and began viewing security video footage of the incident from

available camera angles. A copy of all footage was requested from the VOA as evidence.

As night shift officers and BCI&I agents arrived, BCI&I began processing the outside parking lot area which had been cordoned off. Involved officers were taken on station by Sgt. Garrick to be seperated. Some of the officers advised they had feces on their uniform from Mr. Moxley and were told they could remove their contaminated uniforms, but to each place them in a paper bag and turn them over to Sgt. Garrick until we knew if BCI wanted them for the investigation or not. All the officers were also advised we needed their Tasers to be submitted along with their uniforms. Each of the officers involved had already been photographed by Sgt. Carroll as they appeared at the time of the incident.

Once the parking lot area and been processed and released by BCI&I I advised Sgt. Brane to have two night shift officers who had been put out as a two man car respond to the scene and begin moving the cruisers which had been part of the scene, back to MPD.

Officers Soehnlen and Haines had arrived and had taken over the guard positions. Officer Haines took over the outside crime scene and log and Officer Soehnlen took over the position inside by the Day Room.

I left the scene at approximately 1940hrs and came on station where the chief and assistant chief and I watched portions of the video surveillance and counted Mr. Moxley slamming a steel door well over two hundred times. We also watched Mr. Moxley being led to the front of the building and MFD personnel trying to assess him. I observed Mr. Moxley swaying in the chair he was on and eventually learn way over towards the EMT with his mouth wide open. I could not determine if he was trying to bite the EMT, but it appeared as though he was. Mr. Moxley was clearly handcuffed behind his back when he left the building. Once at the cruiser a struggle could be observed and Mr. Moxley could be seen with his arms apart, meaning he had broken or slipped the handcuffs at some point. I could not clearly see when he escaped or when the Taser was deployed. Mr. Moxley`s body was partially obscured by the open back door of the cruiser and several bodies of MPD officers, APA officers and perhaps MFD personnel. The camera was also some distance from the parked cruiser.

After confirming various points I assisted the chief and assistant chief prepare a news release on the incident. At 2400hrs I secured for the night.

On 03/10/2015 I was advised by Sgt. Carroll that I needed to respond to the Volunteers Of America at 921 N. Main St. and I was told to bring a camera. I arrived at the scene at 1645 hours and the upper parking of the facility had been taped off. I parked and entered the building and was directed to an office by staff. Capt. Snavely, Assistant Chief Porch and Sgt. Carroll were in an office viewing security camera footage.

I was advised by Sgt. Carroll that Police were called to the facility as they had an out of control person inside the building and he was assaulting people and damaging the building.

I was advised to take photos of Officers' injuries and damage to their uniforms. The Officers' were sent into an office one at a time and I took the following photos; Photos # 21-25 are Ptl. Shane Gearhart and his uniform, photos # 26-31 are Ptl. Orlando Chatman and his uniform, photo# 32 came out blank, photos# 33-35 are Ptl Steve Hornback and his uniform, photos #36-43 are Ptl. James Reed and his uniform, and Photos # 44-49 are Ptl. Paul Webb and his uniform. Some of the Officers' also complained of having human feces on their uniforms.

We were advised that BCI was called to come and take the investigation. I was advised to prepare a search warrant for the facility. I left the facility and returned to the office and typed a search warrant and I had the Honorable Judge Jerry Ault sign the warrant.

I then returned to the facility and BCI had arrived. Agent Lenhart looked at the search warrant and he asked Det. Bushong and I to assist with the search. We searched the dorm room where Terrence Moxley was housed and we did not locate any contraband. We then went to a room to that appeared to be a recreation room. The door to enter this room was damaged and the glass and the frame from the door and been knocked out of the door. There was damage to the outside wall by the door frame. Inside of the room we found that a clock that had been mounted on the wall above the door and fallen off of the wall and it was broken on the floor. There was also a fire extinguisher that had been mounted on the wall and it was on the floor.

We searched this room and we did not locate any contraband. BCI had collected Officers'clothing and taser cartridges and probes and they took these items with them. I was given a copy of the evidence sheet showing what items BCI took.

BCI completed their search and interviews and we secured from the scene.

On 03/12/2015 I returned the search warrant and Magistrate Phil Naumoff signed the return and the motion to seal the warrant.

On 3/10/15 I overheard radio traffic involving Police Patrol units with a disorderly person who may be having medical problems and was being transported to the hospital by the Mansfield Fire Department. I advised Sgt. Carroll that I would go to the hospital and check on his condition. Minutes after my arrival the Rescue Squad pulled in to the Emergency Room entrance and I observed them doing CPR on an unresponsive black male. He was taken into trauma room #7 where CPR and medical attention was performed by employees of Ohio Health Med Central Hospital. I was asked by one of the nurses if I could remove the handcuffs from the male so they could do what they needed to do. His left arm was completely underneath his body and his right hand was at his right side. The handcuff on his right hand was black and it had a plastic cover on it that has ASP on it. It was difficult to remove the handcuff from his wrist as the key did not turn easily and it was very hard to remove my key from the hole. We were able to pull his left arm out from under his body where I was able to remove the handcuff from his left wrist. The handcuff on his left wrist was black and was still attached to the handcuff that had been attached to his right wrist. A third set of chromed styled handcuffs was also attached to the two that were hooked together. His clothing was cut off and his pants were removed and were bagged by hospital staff and the bags were all marked and taped shut as were the three sets of handcuffs. He had a sweatshirt, two tshirts, two pairs of boxers, blue jeans, and two pairs of socks. In the middle of treatment Dr. Midkiff removed two taser darts which I requested to keep and a nurse handed me a plastic container which he dropped the darts into a I put the lid on the container. I did not see where on the body the taser darts came from. Eventually he was pronounced deceased by Dr. Midkiff and the Coroner's Office was contacted. Richland County Assistant Coroner Tom Stortz arrived at the hospital and took control of the body and the bagged evidence that I had. I then came back to the Police Station and aided Det. Parrella with typing the search warrant for 921 North Main Street. After the warrant was signed I went with Det. Parrella to 921 N. Main Street where we were contacted by Lt. Skropits, Sgt. Carroll and several members of BCI&I. I assisted BCI&I with searching the dorm room at the northwest corner of the building and the day room that is directly beside it. I found nothing in the dorm area to suggest that any drugs were there or had been there. In the dayroom there was damage to the door, the door frame, the clock and the fire extinguisher had been knocked off of the wall and were laying on the floor. The window that came out of the door was leaning against the wall in the hallway next to the door. I found nothing in the dayroom to suggest that there were any drugs there. After the search was completed we left the scene and turned it over to the staff.

On 03-10-15 approximately 1539 I heard patrol get dispatched to the VOA at 921 N. Main St. in reference to a subject having a possible medical incident. I heard officers on the radio advise that staff at the VOA are advising that additional officers may be needed. A short time later officers are requesting that a supervisor be enroute for an RTR. A short time later radio traffic was heard that the male from the VOA had coded and MFD who was on scene had placed the subject in the squad and they were working on him while enroute to med-central. Myself and Det. Bushong left the city building I had Det. Bushong go to Med-Central and I would respond to the VOA to see what was going on. Upon my arrival at the VOA I was contacted by Sgt. Brane and noticed that the parking lot in front of the VOA was taped off with crime scene tape and two police cruisers were pulled in the lot one behind the other and evidence from a Taser deployment laying on the ground near the rear door a spent cartridge and two probes with the Taser wires still attached. The affids from the taser deployment were also visible in the area where the taser deployment occurred. I spoke with officers on scene to find out that Ptl. S. Hornback, Ptl. O. Chatman, Ptl. S. Gearhart, Ptl. P. Webb and Ptl. J. Reed were all involved in the RTR at different times. While speaking with them I also learned that Ptl. Gearhart and Webb were the ones who deployed the Tasers and Ptl. Gearhart also drive stunned the male now identified as Terrance Sgt. Brane took me to the area where this incident started and I found Ptl. Hornback, Chatman and Gearheart still guarding the day room where Terrance slammed the door over and over breaking the door window and causing damage to the frame due to his slamming of the door he knocked a clock and fire extinguisher off the wall. The dorm room where Terrance kept his belongs and slept was also taped off with crime scene tape and officers were posted to keep anyone from going in.

Assistant porch and Capt. Snavely were also on scene I Called Lt. Skropits and advised him of what had occurred and that he should also respond due to the nature of the call. A/C Porch advised me to call BCI and I called the radio room and had them contact BCI to start there SIU team as well as their Crime Scene unit. The radio Room advised they made the call at 1651 and it would take their team about an hour to respond to Mansfield. An employee of the VOA advised that the incident was captured on video and he showed myself A/C Porch and Capt. Snavely the video that showed what occurred prior to and during officers arrival at the VOA.

At 1721 Det, Bushong called from the hospital advising that Terrance Moxley had died and that the coroner's office had been contacted and they were in route. Det. Parella was called to the scene to assist as Lt. Skropits arrived on scene. The staff who were working were asked to write out statements and they did. Det Parrella took photos of the officers and what they were wearing and the conditions of their uniforms. Det. Parella and Bushong returned on station to start working on a search warrant for 921 N. Main St. while BCI was enroute.

BCI agents arrived at the scene and began to collect and document evidence and conduct interviews I sat in on several interviews Marquis Troche, Dillon Greer, Jeremy Robinett and Nicole Chinn For further see their statements.

On 03-13-15 Lt. Skropits and myself returned to the VOA and contacted Nicole Chinn to get a roster of Admin/Clinical staff, security personnel and those who are to be incarcerated/housed at the VOA the day of 03-10-15.

on 03-19-15 Jon Leiber and Charles Moran were in Mansfield to meet with MPD Officers and their attorney involved in the VOA incident. While in town I met with them at station 3 to interview firefifgter Ryan Landin who was present as officers contacted Mr. Moxley for further see his statement. While on station myself and Ptl. P. Webb and Ptl. Grimshaw retrieved Webb's OC spray from his belt and it was turned over to BIC Agent Leiber. A copy of the OC log was given to Agent Leiber along with the schedule of officers working that day and the MPD Taser log showing which tasers are assigned to what officers and they were given the Taser powerpoint disk we use to train officers.
