AFFIDAVIT OF KASHIF OSAGIE

I, KASHIF OSAGIE, under oath, having been duly sworn, herby deposes and says:

 On June 8th, 205 round 8:15am my aunt Ms. Geneice Lloyd and her boy friend Mr. Mario Ocasio went outside with my 8 month old son to obtain a cigarette from the store while I was asleep.

2. I was woken up by my aunt who informed me that Mr. Ocasio was acting strangely because "something got into Mario's system". Soon thereafter I noticed that Mr. Ocasio was acting strangely, throwing furniture about the room while saying things like, "I'm God!", "God is a Good God!" and "God is Good!" while kicking things across the room and breaking lamps in the apartment.

3. My aunt called 911 and asked for an ambulance, but two NYPD officers arrived first at the apartment.

4. When the NYPD officers first arrived they told Mr. Ocasio they were there to help him but then they suddenly jumped on top of him and began to beat him with their batons.

5. That's when I took out my Cell Phone and began to tape the officers but because my son was on the bed I handed the phone to my aunt and she continued to film the officers as the beat Mr. Ocasio.

6. At first there were just two officers, but then five or six more officers in blue uniforms rushed in and jumped ontop of Mr. Ocasio. They all wrestled with Mr. Ocasio on the ground.

7. They wrestled his arms behind his back by beating him with batons all over his body, stepping on his face and legs and macing him. Eventually they got Mr. Ocasio handcuffed face down with his hands behind his back.

8. After he was handcuffed, he was still screaming and saying "I'm God!!" "I'm God!!" NYPD officers continued to wrestle and beat him until an NYPD supervisor wearing a white shirt walked into the room and shot Mr. Ocasio in the back with a taser. Mr. Ocasio then went quite his last words were something like "I SEE GOD!"

9. After that, he stopped moving and did not make any further sounds.

10. Emergency Medical Services then came into the apartment and took Mr. Ocasio's blood pressure, and gave him a shot of an unknown substance. They then took Mr. Ocasio out of the apartment. NYPD then detained me to question me further.

11. The entire incident was video taped with my cell phone which my aunt had on her as she traveled with Mr. Ocasio to the hospital.

12. NYPD officers held me for almost 5 hours and then brought me to the 52^{nd} Precinct to question me about what happened. They made me call my aunt and told me I couldn't leave until she got to the Precinct.

13. When my aunt got to the Precinct she told them what happened and they confiscated my phone from her.

14. On June 12th 2015 I went back to the Precinct to get my phone, but officers threw me out and said that they had a warrant for the phone. I've requested the phone repeatedly, from NYPD and the Assistant District Attorney James Brennen but I have never received a warrant or voucher for my phone.

I, GENICE LLOYD, under oath, having been duly sworn, herby deposes and says:

1. Around 7:00am on June 8th, 2015, my boyfriend, Mr. Mario Ocasio, and I left his apartment with my grand niece to get some cigarettes. Outside I saw Mr. Ocasio meet one of his friends, however, I did not interact with this friend.

2. We then returned to the apartment, and Mr. Ocasio began to cut the filtered butts off of one of the cigarettes, roll a cigarette and then began to smoke.

3. Right then I started to smell something strange, like roach spray, and so I approached and asked Mr. Ocasio if he was alright.

4. Mr. Ocasio then jumped up and stated, "I'm God!!" and began to break furniture and lamps in the apartment. He was not himself so I called 911 for Emergency Medical Services.

5. Two NYPD officers arrived first at the apartment, however, by the time the officers arrived Mr. Ocasio had calmed down and was laying on the floor peacefully. When they approached him they called out to Mr. Ocasio but he only stared out the window and stated, "I'm God, I'm God".

6. The officers then grabbed him and attempted to place him under arrest yelling, "put your hands behind your back". When he didn't listen they used batons to beat him into submission.

7. The entire time Mr. Ocasio was unresponsive and just kept yelling "I'm God! I'm God!" repeatedly.

8. They continued to beat Mr. Ocasio while attempting to hand cuff him however he was not cooperative or coherent.

9. Additional officers arrived on the scene and continued to attempt to restrain Mr. Ocasio using their body weight, batons, mace, and handcuffs.

10. This continued with additional officers even after he was handcuffed.

11. At this time I began to tape the officers on my nephew's cell phone.

12. At this time about seven officers were on top of him beating him, and then an officer in a white shirt walked into the apartment and shot Mr. Ocasio in his back with a stun gun

Cpse 1: 15167 125825 shor, MRLM as Postanewords were of the stopped #: 84 moving or speaking and then he turned blue. He was completely unresponsive and his head movement had completely stopped.

14. The NYPD officers then asked if they should lay him face down or face up, before placing him on a stretcher. EMS services were there but they did not try to help Mr. Ocasio.

15. EMS then injected him with an unknown substance, and then carried him down the stairs to the ambulance.

16. Once in the ambulance the EMS workers stated, "this man has no pulse" and performed CPR for about 20 minutes.

17. I rode with Mr. Ocasio in the ambulance to the hospital while the EMT's then placed a tube down his throat. They did not use their sirens during the ride, and they stopped at red lights.

18. The emergency room physician called the time of death at 9:50am, but Mr. Ocasio died in his apartment.

19. After I spoke with the family I got a call from my nephew Mr. Kashif Osagie who was also in the apartment while this all occurred. He told me that he and my grand nephew were at the 52^{nd} Precinct and that I needed to come there for him to be released.

20. When I got to the 52^{nd} Precinct I told them everything that happened. The detectives then asked to see the phone so that they could make a copy. After I gave them the phone they told me I could not have it back and they told us to leave.

21. My nephew and I went to hit cell phone provider to transfer the files from the old phone to the new phone, however the video from the first phone did not transfer over.

22. I have tried with my nephew to get the phone back, but NYPD is not releasing it to me or him.
