TO ANY PEACE OFFICER OF TARRANT COUNTY, TEXAS, GREETING:

WHEREAS, an affidavit in writing, under oath, has been made before me by **Detective D. Blanco #1752** (“Affiant”), a police officer with the Arlington, Texas, Police Department, and said affidavit is attached hereto and is incorporated herein by reference for all purposes, and said affidavit has been filed before me anterior to the issuance of this warrant, alleging that:

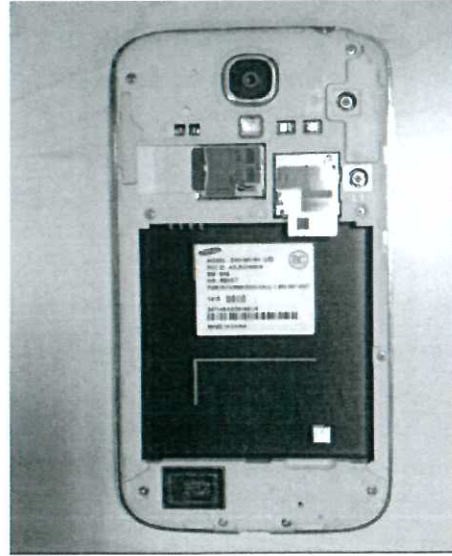
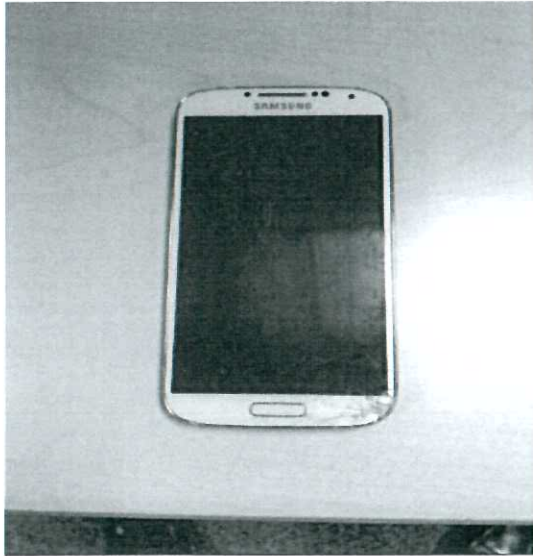
On or about November 17, 2015 in the City of Arlington, Tarrant County, Texas, **Shalaria Jones, a black female, born October 19, 1998** did then and there commit the offense of **Terroristic Threat- Impair Government Service a Felony**, in that the suspect did THEN AND THERE INTENTIONALLY THREATEN TO COMMIT AN OFFENSE INVOLVING VIOLENCE TO THE PUBLIC OR A SUBSTANTIAL GROUP OF THE PUBLIC, TO-WIT: Arlington Independent School District-Bowie High School, NAMELY Of Mass Murder, WITH INTENT TO PLACE Faculty and Students of Bowie High School IN FEAR OF IMMINENT SERIOUS BODILY INJURY. Said offense was reported to the Arlington Police Department by the Arlington Independent School District (“Victim”) on November 17, 2015 as Offense No. 150061448.

AND AFFIANT HAS GOOD REASON TO BELIEVE AND DOES BELIEVE THAT THE FOLLOWING INFORMATION IS STORED ON THE SUSPECTED ITEM, **a white, Samsung Galaxy S4 mobile device, model #SGH-M919N, FCC ID#A3LSGHM919, Base Band Version M919NUVUEMK5**, and any attached media (further described below):

- *Indicia of use, ownership, possession, or control of such media devices such as call logs of all incoming, outgoing, missed, received and sent calls, contacts (address book) of the suspected person, text message logs and text messages sent or received by the suspected person, instant messaging sent or received by the suspected person, chat messages sent or received by the suspected person, any and all other electronic transmissions sent or received by the suspected person, images, or video of the suspected person, and any other images or video which tend to reveal evidence of the above mentioned Terroristic Threat-Impair Government Service against Arlington Independent School District-Bowie High School and the identity of the suspects involved in the offense.*

WHICH was seized from **Sharlaria Jones** in said county and state and is currently located at THE PLACE AND PREMISES DESCRIBED AS FOLLOWS: **Arlington Police CID Office, South Arlington Bureau Police Department, 1030 South West Green Oaks Blvd, Arlington, Tarrant County, Texas.**

Now, therefore, you are commanded to search the suspected item **a white, Samsung Galaxy S4 mobile device, model #SGH-M919N, FCC ID#A3LSGHM919, Base Band Version M919NUVUEMK5**, and any attached media by any means necessary and analyze the same.



- Further, you are ORDERED, pursuant to the provisions of Article 18.10, Texas Code of Criminal Procedure, to retain custody of any property seized pursuant to this Warrant, until further order of this Court or any other court of appropriate jurisdiction shall otherwise direct the manner of safekeeping of said property. This Court grants you leave and authority to remove such seized property from this county, if and only if such removal is necessary for the safekeeping of such seized property by you, or if the provisions of Article 18.10, T.C.C.P. otherwise authorize such removal. You are further ORDERED to give notice to this Court, as a part of the inventory to be filed subsequent to the execution of this Warrant, and as required by Article 18.10, T.C.C.P., of the place where the property seized hereunder is kept, stored and held.

HEREIN, FAIL NOT, but have you then and there this Warrant to be executed within three days, exclusive of the day of its issuance and exclusive of the day of its execution, to be filed with the court your return therein, showing how you executed the same.

EVIDENTIARY SEARCH WARRANT AFFIDAVIT

THE UNDERSIGNED, **DETECTIVE D. BLANCO#1752** (“AFFIANT”), BEING A PEACE OFFICER UNDER THE LAWS OF TEXAS AND BEING DULY SWORN, ON OATH MAKES THE FOLLOWING STATEMENTS AND ACCUSATIONS:

**1. IT IS THE BELIEF OF YOUR AFFIANT, DETECTIVE D. BLANCO #1752 A POLICE OFFICER WITH THE ARLINGTON, TEXAS, POLICE DEPARTMENT THAT:**

On or about **November 17, 2015** in the City of Arlington, Tarrant County, Texas, **Sharlaria Jones, a black female, born October 19, 1998** did then and there commit the offense of Terroristic Threat-Impair Government Service a **Felony**, in that the suspect did THEN AND THERE INTENTIONALLY THREATEN TO COMMIT AN OFFENSE INVOLVING VIOLENCE TO THE PUBLIC OR A SUBSTANTIAL GROUP OF THE PUBLIC, TO-WIT: Arlington Independent School District-Bowie High School, NAMELY Of Mass Murder, WITH INTENT TO PLACE Faculty and Students of Bowie High School IN FEAR OF IMMINENT SERIOUS BODILY INJURY. Said offense was reported to the Arlington Police Department by the Arlington Independent School District (“Victim”) on November 17, 2015 as Offense No. 150061448.

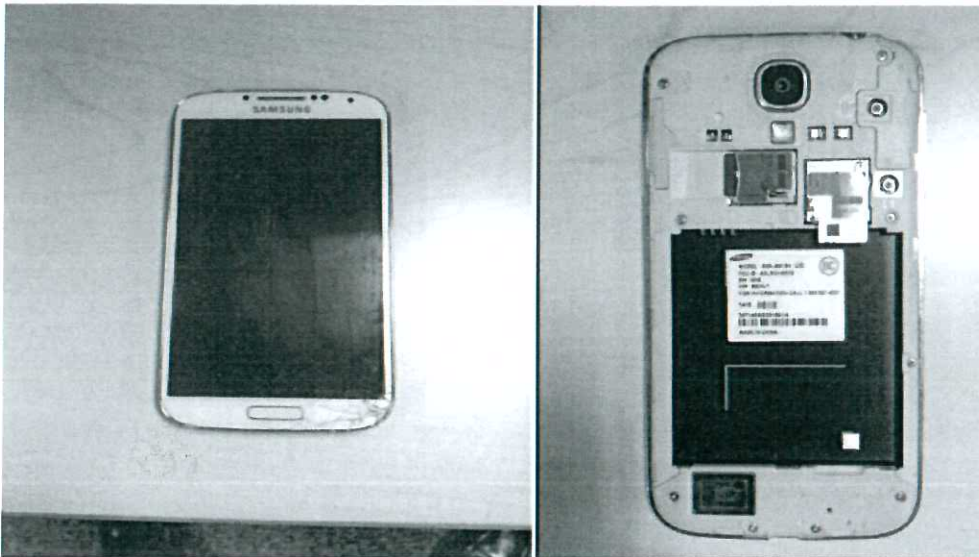
**2. AND AFFIANT HAS GOOD REASON TO BELIEVE AND DOES BELIEVE THAT THE FOLLOWING INFORMATION IS STORED ON THE SUSPECTED ITEM, a white, Samsung Galaxy S4 mobile device, model #SGH-M919N, FCC ID#A3LSGHM919, Base Band Version M919NUVUEMK5, and any attached media.**

- *Indicia of use, ownership, possession, or control of such media devices such as call logs of all incoming, outgoing, missed, received and sent calls, contacts (address book) of the suspected person, text message logs and text messages sent or received by the suspected person, instant messaging sent or received by the suspected person, chat messages sent or received by the suspected person, any and all other electronic transmissions sent or received by the suspected person, images, or video of the suspected person, and any other images or video which tend to reveal evidence of the above mentioned Terroristic Threat-Impair Government Service against Arlington Independent School District-Bowie High School and the identity of the suspects involved in the offense.*

**3. THERE IS AT SAID PLACE, PROPERTY BELIEVED TO CONSTITUTE EVIDENCE, AND SUBJECT TO SEIZURE AND FORFEITURE, AND IS SPECIFICALLY DESCRIBED AS FOLLOWS:**

**A white, Samsung Galaxy S4 mobile device, model #SGH-M919N, FCC ID#A3LSGHM919,**

Base Band Version M919NUVUEMK5, and any attached media



4. **THE SUSPECTED ITEM WAS SEIZED FROM Shalaria Jones** in said county and state and is currently located at **THE PLACE AND PREMISES DESCRIBED AS FOLLOWS: Arlington Police CID Office, South Arlington Bureau Police Department, 1030 South West Green Oaks Blvd, Arlington, Tarrant County, Texas.**
5. **AFFIANT HAS PROBABLE CAUSE FOR THE SAID BELIEF BY REASON OF THE FOLLOWING FACTS, TO WIT:**

On November 17, 2015, your AFFIANT was notified by Detective Sgt. Paschall #1795 that school resource officers were conducting an investigation at Bowie High School, located at 2101 Highbank Dr., Arlington, Tarrant County, Texas regarding a Terroristic Threat that was posted on a twitter account.

Your AFFIANT contacted Arlington Tactical Intelligence Sgt. Jeff Rogers #1396 who advised that they had identified the twitter account as whitebitch@whitebitchhoe that was created on the day of the offense. Sgt. Rogers contacted Twitter and completed an Emergency Disclosure request for the whitebitch@whitebitchhoe twitter account and the account returned to IP address - 172.56.7.184 with a T Mobile Phone #469-535-0099. Sgt Rogers conducted a search on CLEAR and it returned that telephone number 469-535-0099 showed to be associated with a Shalaria Jones. Shalaria Jones was determined to be a Bowie High School student. Jones was positively identified as **Shalaria Jones, a black female, born October 19, 1998**. The post was made at 0833hrs on November 17, 2015. The post consisted of a photograph of a black handgun that stated @12 be readie for bowie to hav a schoo shootin.

Sgt. Leonesio had made contact with Shalaria Jones at her residence, located at 230 Quail Crest Dr., Arlington, Tarrant County, Texas due to her leaving school early for the day due to the terroristic threat. Sgt. Leonesio made contact with Shalaria Jones who denied having any

involvement with the Terroristic Threat offense. Shalaria Jones identified a friend who was later identified as \_\_\_\_\_ the only other individual who had utilized her phone on the offense date.

School Resource Officer Clint Adam made contact with \_\_\_\_\_ who admitted to utilizing Shalaria Jones phone to contact her mother to advise her of the threat that had been made on Bowie High School. \_\_\_\_\_ utilized Shalaria Jones phone during second period class which starts at approximately 0910hrs. The terroristic threat via twitter was made at approximately 0833hrs, which was prior to \_\_\_\_\_ utilizing Shalaria Jones phone. This information provided by \_\_\_\_\_ was confirmed by Shalaria Jones.

Sgt. Leonesio, Sgt Paschal, Officer Frank Smith and your AFFIANT went back to 230 Quail Crest Dr., Arlington, Tarrant County, Texas where we met with Shalaria Jones. AFFIANT advised Shalaria Jones currently she was not under arrest and we were there in order to gather some additional information regarding this incident and to speak to her about her phone. Shalaria Jones confirmed her phone number to be #469-535-0099.

AFFIANT asked Shalaria Jones to explain what happened on this date. She stated she rode the bus to school and arrived at school at approximately 0712hrs and her first period class starts at 0735hrs. She stated in her first period class, Mrs. Dowells' class she is not allowed to have her phone out until they are allowed to pack up after class, however she advised that she received a notification on Twitter regarding Twitter threats. She screen shot the threat and sent it to her friend Armani Williams, and Armani Williams advised she received the text at 0847hrs which was during first period and only 14 minutes after the threat was posted on twitter. Shalaria Jones notified Mrs. Dowell of the threat and Mrs. Dowell notified the principal.

Sharlaria Jones advised that her personal Twitter account is thatgalshaay. She stated she does not exit out of the account due to her not knowing the password. Shalaria Jones stated she observed the post on her twitter and only remembers that the name of the post started with "white". AFFIANT advised Shalaria Jones that the IP address to the account whitebitch@whitebitchhoe, which the threat was made from returned to her IP address on her phone. She stated she does not know how the account came from her phone because she knows she could get in trouble and she would never do that. Shalaria Jones stated multiple times that she had her phone the entire time until she allowed \_\_\_\_\_ to utilize the phone.

Shalaria Jones provided us written consent to search her Samsung Galaxy S4 phone, model #SGH-M919, Baseband Version M919NUVUEMK5. She signed the consent and provided the passcode. We looked at her personal twitter account and denied creating a new account whitebitch@whitebitchhoe.

As AFFIANT looked through Shalaria Jones phone AFFIANT asked Shalaria Jones if she had googled anything regarding guns, knives, bombs and she denied it. Once we searched her google history search we located two searches for pictures of gun. There were two google searches, however Shalaria Jones denied searching for any information on guns. She stated she did make a search on face book. AFFIANT attempted to search on one of the search histories of pictures with gun and AFFIANT scrolled through numerous photographs of guns. Due to technical difficulties and difficulties in maneuvering through the phone it was decided that we would keep the phone for further investigation and Shalaria Jones agreed.

AFFIANT documented the mobile device as a white, Samsung Galaxy S4 mobile device, model #SGH-M919N, FCC ID#A3LSGHM919, and Base Band Version M919NUVUEMK5, and phone number 469-535-0099. The device was placed on airplane mode and the device was turned off.

Due to all the facts and circumstances of this offense a request for permission to analyze the Samsung Galaxy S4 mobile device for potential evidence located within the electronic mobile device related to Terroristic Threat-Impair Government Service related to Arlington Police Report #150061448.

**6. REQUEST FOR PERMISSION TO ANALYZE DIGITAL MEDIA:** Furthermore, Affiant is seeking to remove the items containing digital evidence for analysis by trained and/or experienced personnel.

Based on your affiant's knowledge, training, and experience, and the experience of other law enforcement personnel with whom your affiant has consulted on this issue, Affiant knows that effective searches and seizures of evidence from portable electronic devices such as cell phones commonly require law enforcement to seize the media devices and then have these items processed later by qualified personnel in a controlled environment.

Affiant also believes all logs, text message logs, contacts (address book), text messages, instant messaging, chat messages, e-mails and any other electronic transmissions, images or video may be stored in the cell phone which tend to show that the cell phone in this case may have been used as a criminal instrument in the commission of above described crimes.

**WHEREFORE,** Affiant asks for the issuance of a warrant that will authorize him to search said suspected item and to seize that for which he is directed to search.
