UNOPPOSED MOTION FOR ADMINISTRATIVE CLOSURE

Plaintiff Léone Meyer respectfully requests the Court enter an administrative order closing this matter for a period of ninety (90) days, or until February 28, 2016. This is the first such motion. In support, Plaintiff would state as follows:

1. On November 9, 2015, counsel for the parties met in New York to discuss the potential settlement of this matter and the parties signed a term sheet that night. Counsel for the parties agreed to a settlement, subject to the parties' successful negotiation of the terms and conditions of a proposed settlement agreement that would be acceptable to both parties and subject to final review and approval by the parties.

2. The parties expect to complete the process of signing a final settlement agreement over the next ninety (90) days, which, if successful, would avoid placing an undue burden and expense of time, resources, and effort on the Court and the parties.

3. The parties need time to finalize their negotiations regarding the terms and conditions of the proposed Joint Stipulation of Settlement and Proposed Order. Further, the parties need sufficient time to conduct the appropriate review and approval processes.

4. Should the Court require submission of the parties' Stipulation of Settlement, counsel will execute and file the Stipulation of Settlement and Proposed Order for the Court's review and determination.

5. Under the present circumstances, this request is submitted for administrative closure, so that the parties can continue to focus on completing their ongoing settlement discussions. This request will not harm or prejudice the rights and interest of either party in this case. Further, administrative closure will promote the goals of judicial efficiency and economy.

6. Based on the foregoing, the Plaintiff respectfully requests the Court to grant the following relief:

a. Grant an administrative closure of this case to and including February 28, 2016 without prejudice to the right of the parties to reopen the proceeding for good cause shown, for the entry of any stipulation or order should the Court require it, or for any other purpose required to obtain a final determination of the litigation; and

b. Order that this case will be subject to dismissal if it is not reopened by February 28, 2016.

WHEREFORE, the Plaintiff respectfully requests the Court grant the motion.
