2 D. SKELOS: Hello?

3 MARTINS: Hey, Dean, Jack. How are you?

4 D. SKELOS: Hi, Jack.

5 MARTINS: You have a sec?

6 D. SKELOS: Sure.

7 MARTINS: The County, Mangano, is proposing
8 putting up 100-foot billboards along the expressway, 48
9 feet wide by 14 feet high, lit. They're like video
10 screens.

11 Three or four of them are in my district, three
12 of them, I think, are in, are in Marcellino's district, and
13 I think two of them are in, are in Hannon's district. Just
14 got a heads-up on it. There's a Planning Commission
15 hearing tomorrow morning at 10 a.m. When the community
16 hears about this, they're probably going to go nuts.

17 D. SKELOS: Yeah, you're (indiscernible)

18 MARTINS: I gave Marcellino a heads-up.

19 D. SKELOS: What, is it on county property along
20 the LIE?

21 MARTINS: No. No, no, no. This is on the LIE
22 service road.

23 D. SKELOS: Oh, okay.

24 MARTINS: I believe, I believe that it's going to
25 require state authorization. I already called the regional

1 office at DOT and asked them to look into it. They said
2 that they may have already gotten a permit request from the
3 county. They're going to look into it, they're going to
4 get back to me.

5 D. SKELOS: Have they made a(indiscernible)
6 permit to the county?

7 MARTINS: I don't think they've given anything.
8 I don't think they've proceed it. That's at least the
9 impression that I got. They were aware of it but they
10 don't think they've actually moved on anything.

11 D. SKELOS: Good.

12 MARTINS: If, if they did, it becomes, obviously,
13 a bigger problem. But, you know, people, people in these
14 areas are going to go absolutely nuts, so I'm going to --

15 D. SKELOS: (Indiscernible)

16 MARTINS: I'm sending you a copy --

17 D. SKELOS: They would put up billboards
18 (indiscernible)

19 MARTINS: Dean, these are, these are -- you know,
20 the lowest one, I think, is 70 feet. The highest one's
21 102.
