7	actually give that to Ed Mangano.
8	Now, secretly, Ed Mangano's been pushing for P3s
9	with Cuomo and apparently he's been doing it pretty
10	heavily, and Cuomo wants to do it. So I just want to make
11	sure that the wording and you know, specifying it with

13	has to work off of.
14	But I'm allowed to have smaller municipal
15	leaders, like Ed Mangano or a town supervisor, reach out,
16	you know, to the state because it's in the interest of that
17	small municipality. I just can't do anything directly with
18	any of the senators.
19	WHITE: I see. Did, did you know that Ed was
20	pushing for P3?
21	A. SKELOS: No. I found I had to wait to tall
22	to my, my dad and
23	WHITE: Yeah.
24	A. SKELOS: I found out everything finally
25	when we sat down. I sat down with his attorney, too, who's
