PUBLIC INTEREST LITIGATION NO.106 OF 2013

ORDER: (per the Hon'ble the Chief Justice Sri Kalyan Jyoti Sengupta)

We have heard the learned counsel appearing for the parties.

In terms of the order dt.30.4.2013, a preliminary report dt.25.6.2013 has been filed. The said report is taken on record. Upon going through the report, it appears that it is very exhaustive to resolve the issue.

We, therefore, direct all the Vice-Chancellors of the Universities in the State to implement the suggestions and scheme given in the said report, as early as possible.

The public interest litigation is thus closed.

Consequently, pending implead application – P.I.L. M.P. No.252 of 2013 stands dismissed.

Let copies of the report dt.25.6.2013 be circulated to the Registrars of all the Universities in the State, by the Registry of this Court.
