Gerald Walker Jr. informed Officer Luffey and Humane Society Police Officer Ed Mitcheil that he is the owner of the severely emaciated female pit bull mixed dog. Gerald Walker Jr. surrendered ownership of the animal to the Western Pennsylvania Humane Society.

b) How the source of information knows this particular person committed the crime:

Gerald Walker Jr. surrendered ownership of his severely emaciated female pit bull mixed dog to the Western Pennsylvania Humane Society. Gerald Walker Jr. told officers that the dog belongs to him.

e) How both Affiant and/or source of information knows that a particular crime has been committed:

The dog given to Officer Christine Luffey and Humane Society Police Officer Ed Mitchell by Gerald Walker Jr. is severely emaciated. The dog is literally fur on top of a skeleton. Immediate veterinary care was needed.

Your affiant is Officer Christine Luffey. I have worked as a Pittsburgh Police Officer for almost 23 years. I have specialized in cruelty to animals cases for the past 18 years.

On January 21, 2016, Officer Ed Mitchell from the Western Pennsylvania Humane Society, met with me at Zone 3 station and asked for my assistance. Officer Mitchell informed me that on January 20, 2016, the property manager of 7301 Kelly Street, Apt. #1, had a pest control company at that residence to furnigate the apartment. While inside of the residence, the technician observed a brown/tan colored pit bull type dog that is severely emaciated. The dog was tethered to a wall with a red short leash. The technician took a photograph of the severely emaciated dog and sent it to the Western Pennsylvania Humane Society. The photograph shows the dog's ribs, back bones, and hip bones are protruded. The property manager advised the Western Pennsylvania Humane Society that the tenant of the apartment is Danielle Sims. Based on the photograph, and our professional experience and training, we believed this dog is in advanced stages of starvation and needed to be removed immediately for necessary medical attention.

I obtained a search warrant. The warrant was approved and signed by District Justice Richard King. Officer Mitchell and I then went to Zone 5 station for assistance. The following officers went to 7301 Kelly Street, Apt. #1 to execute the search warrant at about 10:25 am: Officer Colby Neidig, Officer Bryce Valencic, Lieutenant Matt Gauntner, Officer Ed Mitchell, and I. I knocked loudly on the front door and announced our presence. A few minutes later, a female opened the door and let us inside. I explained to Ashia Sims (412-583-7740) that we have a warrant to remove the dog. Ashia informed me that there is no dog inside of the house. I showed Ashia Sims the photograph of the dog that was taken by the technician on January 20, 2016. Ashia told me that the dog belongs to Gerald Walker (age 19). I explained to Ashia that the dog is in desperate need of medical attention and will die without help. Ashia then called her mother at 412-661-0698 and Danielle Sims at 412-290-2404 attempting to find Gerald Walker and the dog. Ashia told me that she believes that Gerald Walker is in school. Ashia stated that Gerald attends classes at the Student Achievement Center located at the corner of Brushton and Frankstown Road. Ashia gave me Gerald Walker's telephone number (412-736-5145). I continued to call him and I left a message for him informing him that I need to speak with him immediately. Ashia was very cooperative and I thanked her for her help.

Officer Neidig, Officer Valencic, Officer Mitchell, and I went to the Student Achievement Center. The school police officer informed us that Gerald Walker did not come to school that day, but she gave us the address that is on file for him. Officer Neidig, Officer Valencic, Officer Mitchell, and I then went to 1669 Broadhead Street. A male answered the door and told us that Gerald and the dog does not reside at the house and that he doesn't know their whereabouts. The male did not give us his name, but he said that he is married to Gerald's grandmother. I wrote down my contact information and asked the male to please inform Gerald that I need to speak with him immediately. I continued to call Gerald Walker on his cell phone. Gerald finally answered the telephone. I informed Gerald that his dog is in desperate need of medical attention. Gerald told me that he is at 419 Rebecca Street located in Wilkinsburg.

Officer Mitchell and I went to 419 Rebecca Street. We located Gerald Walker on the third floor of the residence. Gerald was waiting for us in the doorway leading to the third floor apartment. The dog was with him. The dog is a tan/brown female pit bull mix. The dog is completely and severely emaciated. I believe that we could see every bone in her body. The dog is basically fur on top of a skeleton. Gerald told us that the dog is emaciated because "she has worms". Gerald told us that the dog belongs to him. Gerald told us that the dog's name is "Lady". Gerald Walker surrendered the dog to the care and custody of the Western Pennsylvania Humane Society. The dog's toe nails were extremely overgrown and she could barely walk. Officer Mitchell took a few photographs of the dog and of the male who identified himself as Gerald Walker. I carried the friendly anmal to Officer Mitchell's truck. I held her during the ride to the Western Pennsylvania Humane Society. The dog is extremely friendly and continually licked my face.

We arrived at the Western Pennsylvania Humane Society and the dog was immediately admitted to the veterinary clinic for

#### treatment.

On January 22, 2016, I was informed by Officer Ed Mitchell that the dog, who is now referred to as "Effie", was not doing well. Officer Mitchell informed me that "Effie" consumed food and water on January 21, 2016, but shortly after eating and drinking began vomiting. Officer Mitchell told me that he is transporting "Effie" to PVSEC Animal Hospital for specialized treatment and care. During the early evening on January 22, 2016, I was contacted by Mary Kennedy Withrow from the Western Pennsylvania Humane Society. Mary informed me that "Effie" is in bad shape and that while "Effie" was at the Western Pennsylvania Humane Society that pieces of underwear, corn kernels, and plastic were found in her feces. Shortly after speaking with Mary Kennedy Withrow, I received another telephone call from Mary Kennedy Withrow. I was on speaker phone having a conversation with both Mary Kennedy Withrow and Joy Braunstein (the Executive Director of the Western Pennsylvania Humane Society). I was informed that the veterinarian at PVSEC Animal Hospital informed Mary and Joy that foreign material was palpable in the stomach and that surgery would be needed for "Effie" to survive. Joy Braunstein warned me that "Effie" may die during surgery because she is severely emaciated and extremely weak. We decided to give "Effie" a chance at survival and within the hour she had surgery. During the late evening of January 22, 2016, I was contacted by Mary Kennedy Withrow who informed me that "Effie" survived the surgery, but would have a long road to recovery. Mary informed me that the veterinarian at PVSEC Animal Hospital removed cioth, corn kernels, a few small bones, and several large pieces of orange peels from Effie's abdominal region during the surgery.

On January 25, 2016, I was informed by Officer Ed Mitchell that "Effie" was going to be discharged from PVSEC Animal Hospital on that day at 3:30 pm. I learned that "Effie" was picked up at PVSEC Animal Hospital by Officer Ed Mitchell and Mary Kennedy Withrow and transported to the Western Pennsylvania Humane Society where she would spend the night.

On January 26, 2016, I was informed by Officer Ed Mitchell that "Effie" was not able to maintain her body temperature. Officer Mitchell told me that he needed to transport "Effie" back to PVSEC Animal Hospital for care and treatment.

On January 27, 2016, Officer Ed Mitchell informed me that "Effie" was adopted from the Animal Rescue League on May 18, 2013 by Tonya Jennings - 412-969-2138 - 3432 Denny Street, Pittsburgh, PA 15201. This information was confirmed by Janice Bernard and Joe Tedesco from the Animal Rescue League. Janice Bernard faxed me "Effie's" adoption records. After confirming the information with the Animal Rescue League, Officer Mitchell and I telephoned Tonya Jennings. Tonya Jennings told us that she adopted the dog in May of 2013 from the Animal Rescue League. Tonya said that she changed the dog's name to "Lady". Tonya stated that she had the dog for about 3 1/2 months, but had to part with the dog because she had to move. Tonya told us that she gave the dog to her nephew, "G" (Gerald Walker) because she did not want to take the dog back to the animal shelter. Tonya began to cry and told us that she feels responsible for what happened to the dog because she violated the contract she signed with the Animal Rescue League by giving the dog to Gerald Walker instead of returning the dog to the shelter. Tonya stated that Gerald Walker, who was a minor at the time, really wanted the dog. Tonya told us that she gave the dog to Gerald Walker in August of 2013. Tonya told us that Gerald Walker is her sister's, Tia Matthew's son. Tonya said that for about a year she made sure that the dog was being cared for. Tonya told us that Tia Matthew's (Gerald Walker's mother), fell on hard times and was evicted from her North Side residence during the summer of 2015 and moved in with other family members. Tonya said that Gerald Walker moved in with her sister, Danielle Sims, in Homewood. Tonya told us that there is no excuse for Gerald Walker not to feed the dog, because he knows that she would have provided it. Tonya said that she believes that Cerald Walker severely neglected the dog because he moved back into his old neighborhood and began associating with bad people.

On January 27, 2016 at 1:25 pm. Officer Ed Mitchell and I telephoned Gerald Walker. I informed Gerald that we would like to talk to him about what happened with the dog. I asked Gerald to meet with us at Zone 5 station at a time that is convenient for him. Gerald said that he did not want to come to the police station but wanted us to hear what happened with the dog. Gerald began telling his story. Officer Mitchell and I listened. Gerald Walker said that the dog's name is "Lady" and that it was with him for 2 months because he was watching it for his Aunt because she is on vacation. Gerald said that the dog "got worms and I don't have

no money". Gerald told us that, "I see worms in her poop". Gerald then said that he didn't feed the dog for a week because he couldn't afford to. Gerald then told us that he was arrested for an incident that happened at the T station, but did not elaborate. Gerald said that he does not want to be in trouble for what happened to the dog because he was working on getting the dog medicine to treat the worms when we showed up.

On January 28, 2016, Officer Ed Mitchell and I went to 7301 Kelly Street, Apt. #1. While we were knocking on the front door, Rich Worley (412-657-5379) stopped his truck and approached us. Rich Worley told us that he maintains rental units owned by AHRCO located at 7021 Kelly Street. Rich said that 7301 Kelly Street is also maintained by him. Rich asked us if there is something that he could help us with. I informed Rich that we wanted to speak with the tenant of the apartment (Danielle Sims). Rich confirmed that Danielle Sims is the tenant of that apartment. No one answered the door at 7301 Kelly Street, Apt. #1 while we were standing outside. I informed Rich that I would leave a notice asking Danielle Sims to contact me. Rich Worley then told us that he saw the news and said, "It is a shame about that dog". I asked Rich Worley who the person was who was fumigating the apartment and took the photo of the dog. Rich told me that person's name is Bill Stewart.

After leaving 7301 Kelly Street Apt. #1, Officer Ed Mitchell went to 1669 Broadhead Street in the hope of talking to some family members of Gerald Walker to obtain additional information about the dog. We knocked on the door at 1669 Broadhead Street and met Danielle Sims (412-290-2404) Danielle Sims invited us inside of the house. We spoke to Danielle for about an hour. Danielle told us that her nephew. Gerald Walker, moved in to her basement in the middle of the summer of 2015 when her sister (Tia Matthews) got evicted from her North Side apartment. Danielle said that she legally is not permitted to allow anyone to move into her apartment so she has to say that Gerald Walker was only "staying" at the residence. Danielle told us that "G" (Gerald Walker) "stayed in the basement" with the dog. Danielle said that during the summer of 2015 that she discovered that the residence was infested with mice. Danielle told us that she was not comfortable with the dog being at the residence because she has a very young son. Danielle said that she would let the dog out of the basement when she saw a mouse, hoping that the dog would get it. Danielle informed us that she and her son moved out of the house on December 26, 2015 because she discovered bed bugs. Danielle said that she moved in to 1669 Broadhead Street with her mom and her mom's boyfriend because of the bed bug infestation. Danielle said that she would visit the house often to retrieve belongings that she and the baby needed. Danielle remembers viewing the dog on Christmas Day of 2015. Danielle told us that the dog was "thin, but not that bad". Danielle stated that when she saw the dog on the news, "I was like, wow, I can't believe it". Danielle informed us that the day before we took the dog that Gerald "wrapped her up (the dog) in his coat and carried her to his mom's house on Rebecca Street". Danielle told us that Gerald told his mother that "She is shaking and is about to die in my arms". Danielle said that she can't believe that all of this happened because she offered to give Gerald Walker cereal from her WIC benefits to feed the dog.

On January 29, 2016, I received a telephone call at Zone 3 station from Kimberly Maloney (412-780-2145). Kimberly Maloney informed me that she is a former friend and co-worker of Gerald Walker's mother (Tia Matthews). Kimberly reported that Tia Matthews and her family were evicted from 5 Cemetery Lane on the North Side during the summer of 2015. Kimberly told me that Tia would constantly ask her for money to buy food for the dog. Kimberly Maloney said that she watched the dog at her house when Tia needed to deal with problems in her life. Kimberly told me that she would have the dog for days at a time. Kimberly said that the dog was never treated properly and that she believed that the dog was being neglected. Kimberly informed me that the dog was always thin and that she begged Tia several times to give the dog to her. Kimberly said that Tia refused to give her the dog saying that her kids love the animal. Kimberly told me that she believes that Tia Matthews has some involvement with the neglect of the dog than we are aware of. Kimberly told me that she believes that Tia Matthews and her family are trying to "throw G (Gerald Walker) under the bus". Kimberly informed me that Tia complained to her that police were at her house at some point to do a wellness check.

I asked Animal Friends Police Officer Rob Fredley and Humane Society Police Officer Ed Mitchell to check their data base for information about 5 Cemetery Street, North Side. Officer Fredley e-mailed me the record of a complaint received about a dog inside

of 5 Cemetery Street received on May 8, 2015. According to the complaint: A female named Melissa (724-986-5600) who is a realtor reported that she just visited 5 Cemetery Street and saw a tiny Pit Bull dog locked in a crate on the third floor. The records states: It is very hot up there. Dog is skin and bones. Comp. thinks dog weighs maybe 25 lbs., but should be 60 lbs. Dog has eaten his food/water bowls. On May 12, 2015, Animal Friends Police Officer Kathy Hecker went to 5 Cemetery Street. Officer Hecker spoke to Tia Matthews. Tia told Officer Hecker that "Ladybug" came from the Animal Rescue League about 6 months ago. Tia said that the dog was thin when adopted and the dog has since gained weight. Officer Hecker asked to see the dog and where it was being crated. Tia told Officer Hecker that the dog is crated when she has to leave because the dog was not housebreaking easily, but she just got the crate from her sister two weeks ago. Tia said that the crate is helping and the dog gets a walk in the morning and again when her son gets home from school. Tia let the dog out of the crate and Officer Hecker found her to be on the thin side. Tia told Officer Hecker that this is her first dog ever and she had always been terrified of dog's and didn't want her children to be. Officer Hecker told Tia to call the ARL to arrange to have a stool sample taken if the dog does not gain weight. Tia was on her way to pick up her kids, so Officer Hecker didn't get to counsel her much more on dog care. Officer Hecker wrote, I think there is a lack of knowledge on her part and I will deliver some high quality puppy food to her with specific instructions. There are no violations at this time.

On February 1, 2016, Officer Ed Mitchell and I went to 419 Rebecca Street (third floor apartment) in Wilkinsburg. We met with Tia Matthews (412-580-6771/412-608-8474) for about an hour. Tia informed us that her sister, Tonya, gave her son (Gerald Walker) the dog a few years ago. Tia said that Gerald really wanted the dog and she permitted the animal to live in her home. Tia told us that she is "petrified" of animals and that it took her about 3 months to get used to the dog. Tia stated that she moved from her house at 5 Cemetery Street during the middle of June, 2015 and was "basically homeless". Tia stated, "I hit rock bottom for a moment". Tia said that she, her young daughters, and the dog lived for a while at her mom's house, Aunt's house, and sister's house. Tia told us that she and her daughters moved into their apartment at 419 Rebecca Street on January 16, 2016. Tia stated that Gerald Walker moved in with her sister, Danielle Sims, in the basement of 7301 Kelly Street, Apt. #1 when she was evicted. Tia told us that the dog went to live with Gerald in September of 2015. Tia said that she last saw the dog on December 28, 2015 and that the dog looked like she lost weight. Tia stated that Gerald is always late in telling her things and that she is upset that she lost communication with her son. Tia informed us that Gerald was incarcerated for about 4 days to a week before Christmas. Tia said that Gerald was home for Christmas. Tia told us that Gerald brought the dog to her apartment on January 20, 2016 and that she was "shocked" to see the dog in the emaciated condition it was in. I asked Tia why she believes that Gerald would starve the dog. Tia told me that "my son got caught up in the streets". I informed Tia that charges will be filed against Gerald Walker. Tia offered to cooperate fully. She told me that Gerald Walker would also fully cooperate and do whatever we ask. When I arrived back at the station, later in the day on February 1, 2016, there was a voice mail from Tia Matthews informing me that Gerald Walker was shot in the buttocks on Tioga Street earlier in the day. Tia stated that Gerald was admitted to Presbyterian Hospital. I confirmed the information Tia provided to be true, as it was verified by Zone 5.
