***FELONY COMPLAINT  
FOR ARREST WARRANT***

The undersigned is informed and believes that:

**COUNT 1**

On or about December 16, 2008, in the County of Los Angeles, the crime of SEXUAL BATTERY - MASTURBATION, in violation of PENAL CODE SECTION 243.4(d), a Felony, was committed by JAMES CHRISTOPHER NICHOLS and LUIS GUSTAVO VALENZUELA, who did willfully and unlawfully, for the purpose of sexual arousal, sexual gratification and sexual abuse, cause JANE DOE #1 against his/her will while unlawfully restrained by the defendant(s) and an accomplice to masturbate and touch an intimate part of John Doe #1.

"NOTICE: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq. Willful failure to register is a crime."

It is further alleged that in the commission and attempted commission of the above offense a principal in said offense was armed with a firearm(s), to wit, , said arming not being an element of the above offense, within the meaning of Penal Code section 12022(a)(1).

COUNT 2

On or about December 16, 2008, in the County of Los Angeles, the crime of ATTEMPTED FORCIBLE ORAL COPULATION, in violation of PENAL CODE SECTION 664/288a(c)(2), a Felony, was committed by JAMES CHRISTOPHER NICHOLS and LUIS GUSTAVO VALENZUELA, who did unlawfully attempt to participate in an act of oral copulation with JANE DOE #1 and did accomplish said act against said victim's will by force, violence, duress, menace, and fear of immediate and unlawful bodily injury to said victim and to another.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

"NOTICE: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq. Willful failure to register is a crime."

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). Penal Code section 1202.1."

"NOTICE: Being charged with this criminal offense can result in mandatory pre-conviction HIV/AIDS testing and disclosure of the results to a victim and the Chief Medical Officer of the jail or prison facility where you are incarcerated pursuant to Penal Code Section 1524.1 and Health and Safety Code section 121055 following a probable cause hearing resulting in a court order."

### COUNT 3

On or about December 16, 2008, in the County of Los Angeles, the crime of ATTEMPTED ORAL COPULATION UNDER COLOR OF AUTHORITY, in violation of PENAL CODE SECTION 664/288a(k), a Felony, was committed by JAMES CHRISTOPHER NICHOLS and LUIS GUSTAVO VALENZUELA, who did unlawfully commit an act of oral copulation upon JANE DOE #1 against his/her will by threatening to use the authority of a public official to incarcerate, arrest and deport someone and said JANE DOE #1 had a reasonable belief that the defendant was a public official.

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). Penal Code section 1202.1."

"NOTICE: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq. Willful failure to register is a crime."

"NOTICE: Being charged with this criminal offense can result in mandatory pre-conviction HIV/AIDS testing and disclosure of the results to a victim and the Chief Medical Officer of the jail or prison facility where you are incarcerated pursuant to Penal Code Section 1524.1 and Health and Safety Code section 121055 following a probable cause hearing resulting in a court order."

### COUNT 4

On or between July 10, 2009 and August 9, 2009, in the County of Los Angeles, the crime of ASSAULT WITH A FIREARM, in violation of PENAL CODE SECTION 245(a)(2), a Felony, was committed by LUIS GUSTAVO VALENZUELA, who did willfully and unlawfully commit an assault on JANE DOE #2 with a firearm.

It is further alleged that, pursuant to Penal Code section 1203.095, there is a presumptive minimal jail time required if you are convicted of this charge.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

It is further alleged that in the commission and attempted commission of the above offense, the said defendant(s), LUIS GUSTAVO VALENZUELA, personally used a firearm(s), to wit: semi-automatic handgun, within the meaning of Penal Code sections 1203.06(a)(1) and 12022.5(a) also causing the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(8) and a violent felony within the meaning of Penal Code section 667.5(c)(8).

#### COUNT 5

On or between July 8, 2009 and November 4, 2009, in the County of Los Angeles, the crime of FORCIBLE ORAL COPULATION, in violation of PENAL CODE SECTION 288a(c)(2), a Felony, was committed by JAMES CHRISTOPHER NICHOLS and LUIS GUSTAVO VALENZUELA, who did unlawfully participate in an act of oral copulation with JANE DOE #2 and did accomplish said act against said victim's will by force, violence, duress, menace, and fear of immediate and unlawful bodily injury to said victim and to another.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

"NOTICE: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq. Willful failure to register is a crime."

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). Penal Code section 1202.1."

"NOTICE: Being charged with this criminal offense can result in mandatory pre-conviction HIV/AIDS testing and disclosure of the results to a victim and the Chief Medical Officer of the jail or prison facility where you are incarcerated pursuant to Penal Code Section 1524.1 and Health and Safety Code section 121055 following a probable cause hearing resulting in a court order."

On or between July 8, 2009 and November 4, 2009, in the County of Los Angeles, the crime of ORAL COPULATION UNDER COLOR OF AUTHORITY, in violation of PENAL CODE SECTION 288a(k), a Felony, was committed by JAMES CHRISTOPHER NICHOLS and LUIS GUSTAVO VALENZUELA, who did unlawfully commit an act of oral copulation upon JANE DOE #2 against his/her will by threatening to use the authority of a public official to incarcerate, arrest and deport someone and said JANE DOE #2 had a reasonable belief that the defendant was a public official.

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). Penal Code section 1202.1."

"NOTICE: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq. Willful failure to register is a crime."

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). Penal Code section 1202.1."

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

It is further alleged, within the meaning of Penal Code sections 667.61(a) and (e), as to defendant, JAMES CHRISTOPHER NICHOLS and LUIS GUSTAVO VALENZUELA, as to count(s) 5, 7, 9, 11, 13, 15 and 17 that the following circumstances apply: multiple victims.

**NOTICE:** Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.

**NOTICE:** The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and *Cunningham v. California* (2007) 549 U.S. 270.





## FELONY COMPLAINT -- ORDER HOLDING TO ANSWER -- P.C. SECTION 872

It appearing to me from the evidence presented that the following offense(s) has/have been committed and that there is sufficient cause to believe that the following defendant(s) guilty thereof, to wit:
