

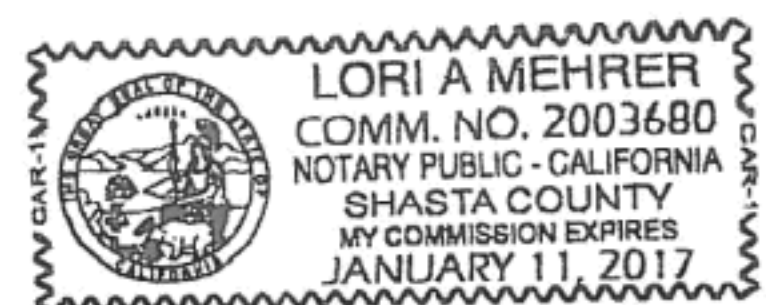
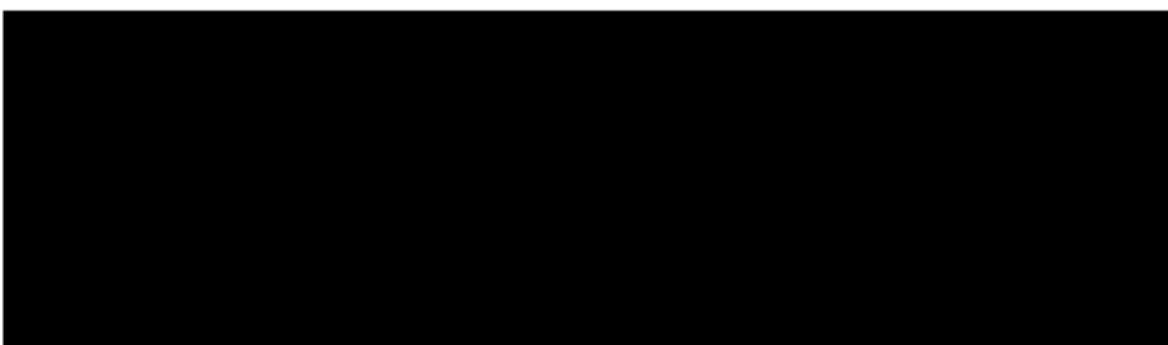

I bought and moved in to this home in Jan. 2014 as I was parking my cargo trailer to unload there was a bloody brawl directly across the street from me. Because of my concern I attended the HOA meeting in which it was decided to cancel the security service and start a neighborhood watch program which Earl Boek volunteered to do. We in the community started to see a difference in the criminal activity gradually decline. I did not recognize or appreciate the difference until Earl went on vacation. There was a drastic increase in drug trafficking across the street from me, noticed by loud cars moving fast, coming and going all night (from about 10:p.m to 5: a.m.) every night waking us up in spite of the ear plugs and running fans. One night in particular at midnight a fast and loud vehicle came and left waking me up, and in an agitated state, I went out with my flashlight and could not see the loud vehicle as it had turned the corner but I could still hear it as I was standing at the end of my driveway a newer vehicle which I had never seen before pulled in to the same house and a nice looking young man, well dressed, got out and went in to the house and left about 7 minutes later. A typical pattern of those frequenting this house. At the time I did not know that Earl had been gone on vacation. Suddenly the traffic slowed and we were getting some rest again as I wondered why I discovered that Earl was back and out on patrol once again. I am very thankful that he is willing to do this task for us on a nightly (and sometimes daily) basis. I shudder to think what we would do or what the community would become without him.

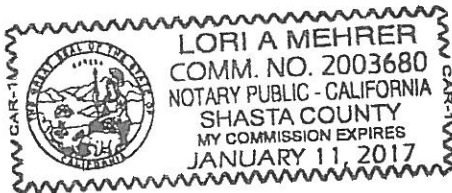

- 2).....I'm sure you've heard Judge....'when seconds count, the police are just minutes away'.

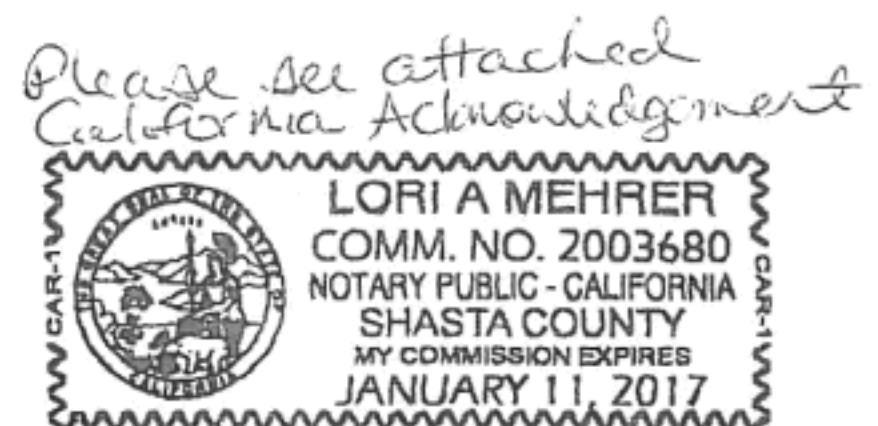
Well.....that's if they even show up. I don't know the reasons for this, but I pay my taxes so, where are they when you need them?

As a resident of Mt. Vista Homeowners Association of 8 years, I (and a number of other HOA members) for years felt it was necessary to security. Approximately 4 years there had been of talk about purchasing the security for our subdivision as a trial run. During this “trial” I had never seen the security patrolling our streets. Apparently, the HOA had a contract for 5 months. Displeased by the cost associated and their lack of ability of handle any crime-like activity, the security had ended.

Not long after that, I received an invite in the mail for ‘next door’ I did not recognize the name of who referred me, so I waited a few weeks before signing up. After I signed up, I was VERY pleased. I had viewed blogs from Mr. Boek which he had started months prior to my sign up.

Over the recent years Mr. Boek has helped out substantially by providing me with ‘up the minute news and urgent messages’ in our subdivision. Mr. Boek also notified when there were visuals of cougars, lost dogs, or wild animals in certain parts of the subdivision. He also helped significantly with some known drug houses—keeping an eye on the trafficking to and from those houses; at times stopping and questioning them, then kindly notifying them of who he was and most importantly his purpose. Something law enforcement cannot do as regularly as he is able.

Years previous to his patrols and on-going, we’ve had a number of people speeding through on one of our streets, one of which is White River. For many years this has been a hot topic. Over the years the street has been surveyed and monitored infrequently by law enforcement. One time I was crossing the 4-way stop, someone speeding down White River toward the stop, ran the stop sign, and nearly broad-sided my car. Mr. Boek randomly parks at this very same 4-way stop, to monitor the traffic. Mr. Boek has blogged seeing people run the stop sign, speed down the streets and people on bikes; throughout the subdivision carrying (what turns up later as), stolen property. Touching briefly on the speeding cars down White River, I’ve walked down that street with my children and people are speeding in cars. Not that there is a lot of traffic, but when there is a car is usually speeding.

Many of the times I see Mr. Boek on patrols I see neighbors chatting with him. When I see him patrolling I flag him down to chat. He has been professional, friendly, and knowledgeable. One night there had been an ‘urgent alert’ of cougar sightings in the subdivision; so I could get my cats inside, he came over to help me. He has also blogged and told me in person, if I needed him that he would be there and he’s only a phone call away. I like the fact of having someone there for people who are scared of confrontation, someone like Mr. Boek who take initiative to help others in situations like that.

Although, very LITTLE have complained about his manners, it DOES NOT outweigh the courageous and honorable things Mr. Boek has done to keep my family safe and notify us of any

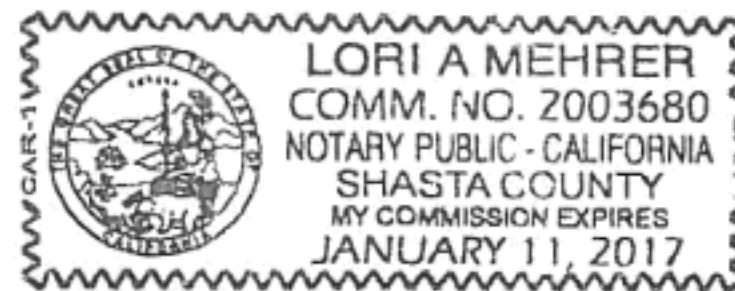
danger. It wasn't for him we wouldn't have a clue about ANYTHING happening in the subdivision. And some of these drug houses may have not been addressed and monitored as well without his help.

Lastly, since most of the subdivision is on 'next door,' which we can thank Mr. Boek for. I use it (as well as others) to communicate with people in the subdivision (and surrounding subdivisions) about work, yard sales, caregiving, volunteering, safety and security, general blogs, and urgent messages. Most importantly if crime is happening we all have a connecting network to share and someone willing to take the step others are afraid to take to make this a safer place. Thank you, Mr. Boek for your superior help and careful handling of unlawful activity, I support you.

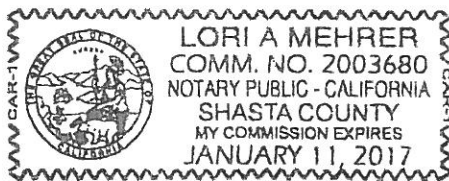

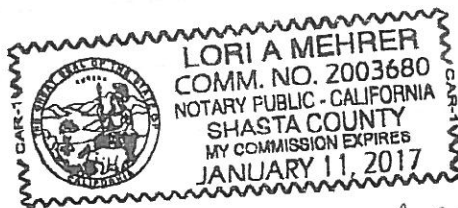
One night I heard a noise that sounded

We should be ashamed for our failure to help him in his efforts in any way we can. Some do, but most don't.

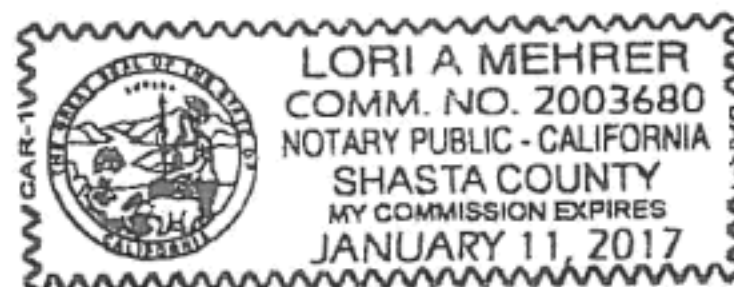

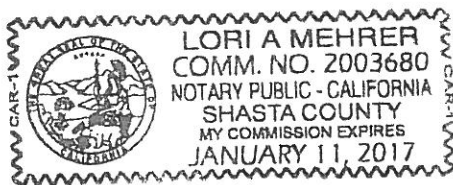

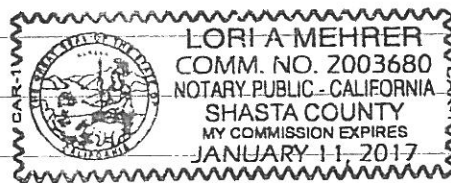
Ⓞ a large amount of traffic and there were also needles found in scrubs. People seem to be better when they know someone is watching and the ones complaining are the ones that really should be watched.

Earl goes out his way to help our community to be safer - Carl is kind, helpful, polite,

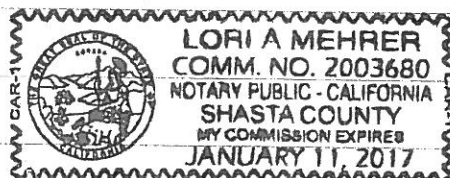
and TRUSTWORTHY. Also has helped us
