**COUNT 13: ASSAULT WITH INTENT TO MURDER**

did make an assault upon A.K., a minor child, with intent to commit the crime of murder; contrary to MCL 750.83. [750.83].

FELONY: Life or any number of years. DNA to be taken upon arrest. A consecutive sentence may be imposed under MCL 750.506a if the assault was committed in a place of confinement.

**COUNT 14: WEAPONS - FELONY FIREARM**

did carry or have in his/her possession a firearm, to-wit: a pistol, at the time he/she committed or attempted to commit a felony, to-wit: Assault with Intent to Murder; contrary to MCL 750.227b. [750.227B-A]

FELONY: 2 Years consecutively with and preceding any term of imprisonment imposed for the felony or attempted felony conviction; Mandatory forfeiture of weapon or device [See MCL 750.239]

**COUNT 15: ASSAULT WITH INTENT TO MURDER**

did make an assault upon Tiana Carruthers with intent to commit the crime of murder; contrary to MCL 750.83. [750.83].

FELONY: Life or any number of years. DNA to be taken upon arrest. A consecutive sentence may be imposed under MCL 750.506a if the assault was committed in a place of confinement.


**COUNT 16: WEAPONS - FELONY FIREARM**

did carry or have in his/her possession a firearm, to-wit: a pistol, at the time he/she committed or attempted to commit a felony, to-wit: Assault with Intent to Murder; contrary to MCL 750.227b. [750.227B-A]

FELONY: 2 Years consecutively with and preceding any term of imprisonment imposed for the felony or attempted felony conviction; Mandatory forfeiture of weapon or device [See MCL 750.239]

Upon conviction of a felony or an attempted felony court shall order law enforcement to collect DNA identification profiling samples.

The complaining witness asks that defendant be apprehended and dealt with according to law.
