Tsygankova made several mentions of a bad dream that she had that night, but was unable to elaborate fully about the dream. Tsygankova had been going through some difficult times because of the divorce. Tsygankova's sister was very concerned and asked Grevtseva to stop by and check on Tsygankova, because she wasn't answering her phone. Tsygankova has a history with MHMR.
