Streamlined Application for Restoration of Citizenship Rights (Right to Vote and Hold Public Office)

| General Information: | A restoration of citizenship restores the right of a person to vote and hold public office. <u>This is</u> <u>not an application for pardon, commutation or a special restoration of citizenship rights</u> (firearms). If you would like to apply for pardon, commutation or a special restoration of citizenship rights (firearms), you must submit a different application, which can be found on the Governor's website at <u>www.governor.iowa.gov/</u> . There is no application fee for clemency. | | | | |

| Who may apply: | An individual convicted in Iowa State Court, Federal Court, and a court outside of Iowa may apply to have their right to vote and hold public office restored. | | | | |

| □ <u>Step 3</u> - | Enclose Proof of payment of court costs, fines, and restitution Submit documentation of your court costs, restitution, and fines. Completed payment: If you have completed your payment of court costs, restitution, and fines you must submit documentation verifying your payment. Still working on payment: If you are current on your payment of court costs, restitution, and fines and continue to pay these costs in good faith, you must submit documentation of your payments along with an explanation of your payments and why they are not completed.
