Re: Discovery: United States v. Michael Marr, et al., CR 14-00580 PJH

Dear Counsel:

On April 3, 2015, the government voluntarily provided you an Audio-Video Recording List of the recordings the government intended to draw from in its case-in-chief to assist in your review of discovery. Since then, the government has refined that list and will not introduce any audio from stationary recordings. For your convenience, we have attached a revised list of recordings that the government intends to draw from in its case-in-chief. (**Attachments 1 and 2**).

In addition, the government is voluntarily disclosing the location of the stationary recording devices in Alameda and Contra Costa County that recorded audio material without an agent or confidential source in possession of the device at the time of the recording. Again, the government will not introduce any of these recordings in its case-in-chief. The chart in **Attachment 3** lists the date the recording was taken, the county, the 1D number, the location of the device, the type of recording that was captured, as well as a key that details the location of the recording devices. All the recordings listed on the chart captured audio. In some instances, the devices captured both audio and video.

Furthermore, six of the stationary recordings that were previously identified in the government's Fed. R. Crim. P. 12(b)(4) disclosure were inadvertently mislabeled. On the Alameda County Audio-Video Recording List, 1D164 and 1D402 were mislabeled in the

description as consensual recordings created by S-0003687 and SA Wynar. 1D164 is actually a Lower Light Box recording and 1D402 is a Fallon Bus stop recording. On the Contra Costa Audio-Video Recording List, 1D522 was mislabeled as a consensual recording created by S-00027622. This recording is actually a Hedge recording. In addition, the recordings 1D491, 1D508, and 1D517 were mislabeled as recordings captured by vehicles parked near Ward Street and Las Juntas Street in Martinez, California. These recordings were actually captured by vehicles parked by the Contra Costa County Finance Building on 625 Court Street, Martinez. All of these recordings have been removed from the Alameda and Contra Costa County Audio-Video Recording Lists and will not be introduced in the government's case-in-chief.
