Probable Cause Narrative

Deputy's Summary: On 04/09/2016 I was assigned to write a report regarding Malicious injury to property and Assault & Battery on a Detention Officer. While on J5 David Pulps (DLM#1160864) assaulted Officer Tyler Perry with a chair as well as broke a monitor on the officers station. The monitor was still operational but no longer could be connected to the base which it stands on. While being escorted to medical Pulps also assaulted Officer Jesse Winfield with personal weapons.

Witness Summary Tyler perry: Officer Perry states that he witnessed Pulps pick up a chair from the day room and charge the officers station. Pulps then threw the chair hitting me in the right arm. Pulps attempted to climb
