

The release of Tiger Temple

2. Deposit tiger into a civil legal action to complete, Department of national parks, wildlife and Plant Conservation also not to sue payback but to use of force stretching back without a court order. Nor lead to enforcement officers and are required by law. Because the animals in the temple is a property which is in charge

of the office of forestry, Sai Yok Branch having a contract with a party on June 12, 2001 (B.E. 2544) giving the 275 wildlife animals (217 jungle fowls, 3 Peacock Pheasants, 2 Mountain Goats *Cervus unicolors*, 20 *Cervus eldies*, 2 leopard, 7 tigers, 8 Fea's muntjacs, 2 Thai Hog Deers, 3 Asiatic black bears) to the temple's caretakers. Not all animals were illegally raised illicitly or trade in any way, But all of the check and contract deposits kept properly. The troops were seized immediately is action inappropriate and action is excessive.

3. Wat Pa Luang ta Bua Yanasampanno sue the Department of national parks, Wildlife and Plant Conservation (DNP) to claim alimony case is right the court of appeals.
4. Tiger Temple company limited licensed public zoo in order to solve the problems of the tiger in the long run. The actions of the authorities at this time as the block overlooking of Tiger Temple co., Ltd? Tiger Temple company Limited has availability of raising tigers and other animals.
5. Department of national parks, wildlife and Plant Conservation (DNP) to relocate the 137 tigers acts, regardless of the state budget will be lost unnecessarily.

7. The action of the Department of national parks, Wildlife and Plant Conservation (DNP) affect the overall business of the country, **Because** during the recession, there are tourists to visit the tigers 200 - 300 people a day.
8. Department of national parks, Wildlife and Plant Conservation does not respect the Buddhist temple. **Wat Pa Luang ta Bua Yanasampanno is Buddhist Temple.** It was their territory as a sanctuary. Whether humans or animals in the temple area shall be merciful as the same. Over the past Wat Pa Luang Ta Bua

Yanasampanno didn't find a wild animals but is subject to state and nation to rely on religion altogether. Temple raised tiger and wildlife with the budget available himself did not receive support from the government.

9. The action of Department of national parks, Wildlife and and Plant Conservation has made the performance of monks could not continue due to temple reputation.
10. Action of Department of national parks, Wildlife and and Plant Conservation make workers more than 100 family to unemployed.

As respectfully from the start. Wat Pa Luang Ta Bua notice that the Department of national Park wildlife and Plant Conservation (DNP) has extensive damage and was excessive. Wat Pa Luang Ta Bua do not bring animals to hide or related to wildlife trade in any way.
