Officer's Report Supplement
Rape

On 01/17/12, S. Sgt. Wilson asked me to assist Officer Mynde Heil with this case. I spoke with Officer Heil and she stated that had possibly been raped by Patrick Swilling. Officer Heil said this started with an e-mail that mother sent to the head coach of the CSI basketball team. It was then forwarded to the Twin Falls Police Department.

It should be noted that neither nor her mother contacted the police department directly. Officer Heil contacted Officer Heil said she spoke with and she wrote a statement, which I read. I called and asked if she would come to the police station and visit with me, which she did.

During the interview with she told me the same thing she wrote in her statement pretty much verbatim. I then contacted the next day, 01/18/12. She stated she did not want me talking to Mr. Swilling. She just wants to forget this. said she never once felt like she had been raped; she was a willing participant in the sexual activity.

I am closing this case as inactive and changing it to an officer's report. No crime has occurred.
