On the date and time indicated I was standing on the west side of Abbott next to the old MSUFCU watching Conrad's as the bars were closing for the night.

All of the sudden myself and Officer Horn heard a loud slap sound. I could immediately see the crowd disperse into two sides as Green went one way and Edmonson went the other way.

The crowd then began to get very loud as people were arguing back and forth.

At this point Sgt. Pride was sitting at the light on Grand River and Abbott and had called out a fight at Conrad's. Officer Horn and I immediately ran over to Conrad's.

Sgt. Pride during this time was talking to Edmonson who identified Green as the one that had slapped him across the face.

ARREST/TRANSPORT

Officer Horn and I then ran over to Green and handcuffed him per departmentally policy, as he was walking North on Abbott road.

Once Officer Horn and I hand placed handcuffs on Green, we walked him over to Officer Horn's patrol vehicle where he searched Green before entering his vehicle.

Officer Horn then transported Green to ELPD's Jail.

On 7/10/16 at approx. 0228 hrs., Ofc. Humphries and I were on foot at the NW corner of Grand River and Abbot. There had just been an altercation in front of Rick's Bar and a handful of the subjects involved in the altercation walked to Conrad's at 101 E Grand River at which time we did stand in the NW corner watching Conrad's.

We did observe several subjects come out the front door closest to Grand River and begin talking in a large group. ROs were watching the group when I observed a taller, b/m, wearing a white t-shirt, open handedly slap another b/m across the face with his R hand to the victim's

L cheek area. The sound of the slap was very loud.

RO at that time immediately began to cross Abbot Rd. towards Conrad's. At that time, Sgt. Pride did call out that he would be out with some subjects in front of Conrad's. RO then immediately made contact with the victim who was later ID'd as Jermaine LuRule Edmondson, Jr., b/m, 7/10/94.

I at that time asked Edmondson if he wanted to press charges for the assault that had just occurred. He indicated he did at which time RO did observe the same b/m inside of Conrad's beginning to exit on the Abbot side.

CONTACT WITH SUSPECT

RO at that time did make contact with the suspect and it became immediately known that the suspect was Draymond Green who is known to be an ex MSU basketball player and current NBA basketball player.

I advised Green at that time that he was going to be placed under arrest for the simple assault and battery.

ARREST/SEARCH

I did handcuff Green with his hands behind his back, double checking the handcuffs then double locking the handcuffs. Green was then walked over to my patrol vehicle which was across from Rick's. He was searched and secured in the rear seat of the patrol vehicle.

It should be noted while walking Green over to my patrol vehicle, he did say some excited utterances, indicating that he was sorry for slapping the subject and wanted to speak with him to make things right.

ELPD JAIL

Green was transported to ELPD jail without incident. He was booked and lodged in ELPD jail.

BOND

Bond was set at \$200.

CITATION

RO did issue a misd. citation for Simple A&B on citation 43792.

PBT

While back in the jail, Green did submit to a PBT on PBT 24 which resulted in a .10 BAC.

Green had to remain in ELPD jail until completely sober.

entrance of Conrads restaurant.. RO could only observe one subject who was later ID'd as Jermaine LuRule Edmondson, DOB 7/10/90. RO did not see the second individual until later. That subject was subsequently placed under arrest by Ofc. Horn.

As RO exited the patrol vehicle, RO started walking up to the area where the individuals were pushing each other. RO later heard a loud "smack" noise and observed an arm come from the area near the front door of the Conrad's Restaurant. This arm was outside of the door as though it was standing on the exterior of the restaurant.

RO heard the loud smack noise and at that time, RO walked up to the individual Edmondson who was holding the L side of his face. RO asked him what had happened and he stated he had just gotten hit.

At that time, as RO was walking and talking to Edmondson, Edmondson's girlfriend who was later ID'd as Bianca Monette Williams, came up to RO and said Draymond Green just hit him. Williams at that time also indicated that "He should not be able to get away with that."

RO observed Ofc. Horn who had crossed the street, coming from the W side of Abbot Rd. to the E side of Abbot Rd., walk up to the victim Edmondson and asked him if he wanted to prosecute reference the assault. At that time, Edmondson stated yes.

Ofc. Horn then went NB on Abbot towards PT's with Ofc. Humphries where they then placed the suspect under arrest.

EDMONDSON'S STATEMENT

Edmondson stated that he was an MSU student and an MSU football player. He indicated on 7/9/16 he had contact with the suspect Green inside of Rick's on Abbot Rd. Edmondson stated that while they were in the bar, Draymond had bumped into him.

Edmondson stated that he turned around and told the subject to watch where he was going. Edmondson stated that at that time, Draymond stated, "Do you know who I am?" Edmondson stated he did know who the suspect was however he didn't care that he bumped into him.

Edmondson stated that while they were in the bar, someone had grabbed Edmondson by the throat after he had contact with Green reference the bumping into him. Edmondson couldn't provide any information of who the subject was that had actually grabbed Edmondson by the throat.

Edmondson stated that he then observed the subject again on 7/10/16 when this incident occurred. Edmondson stated he was standing outside of Conrad's when the suspect Draymond Green walked up to him. He indicated that Draymond put his hand on him and started to talk to him. At that time, Edmondson stated that he told Draymond Green to take his hands off of him. Edmondson stated that they started to verbally argue and at that time, Draymond Green punched Edmondson with his R hand on the L side of his cheek. Edmondson indicated to RO the subject then walked away.

Edmondson stated he did want to press charges reference to this incident. Edmondson indicated that he did not have any injuries. RO asked him if he wanted to seek any medical attention or see medics and he indicated no. Edmondson was holding the L side of his jaw as RO was talking to him.

BIANCA WILLIAMS' STATEMENT

Bianca Williams did tell RO after speaking with Edmondson, that Edmondson and Draymond had gotten into an incident the day prior at Rick's. Williams indicated to RO that as they were standing outside of Conrad's, Draymond Green had walked up to Edmondson. She indicated that she then saw Draymond Green hit Edmondson in the side of the face.

Bianca Williams indicated that she does not believe that is right just because he is an NBA player, he shouldn't be able to hit people.

Williams also indicated that reference to the Rick's American Café incident on 7/9/16, that an unknown subject had grabbed Edmondson by the throat inside the bar and also grabbed her by the throat.

Again, Williams could not provide RO with any description of the subject that had grabbed her or Edmondson by the throat in Rick's.

WRITTEN STATEMENTS

RO did request both individuals to write out statements and email them to RO. RO did give both of them RO's business card. They indicated they would write out statements and send it to RO by the end of the day on 7/10/16.

Hello Sergent Chad Pride.

My name is Jermaine Edmondson and I am making a statement on the incident that took place last night.

Friday, July 8th I went out to the bar Ricks and came across Draymond Green and two other males that were with him who followed everywhere he went. I was talking to one of my teammates when Draymond bumped into me and I said "hey bro you can at least say excuse me" he looked at me and continued to talk to my teammate asking him who I was. I told him don't worry about who I am and I asked who he was to think that it's okay to bump into somebody without saying excuse me. He then said I pay for n*ggas like you scholarships, I then started to say you have me messed up before I was choked out by 2 guys who were with him. I was taken downstairs by 3 of Ricks employees to calm the situation until I heard my girlfriend yell. So I run over to her to see what was going on and she said she was choked by another one of the guys who were with Draymond for trying to calm the situation down. This is wrong on so many levels for someone to think that something like this is okay. Me and my girlfriend were both choked in front of our peers and we couldn't do anything about it.

Saturday, July 9th (the night of my birthday) Me, my girlfriend, and a couple of other friends went back to Ricks to celebrate and enjoy my night. As the bar was closing my girlfriend and I went to Conrad's. I noticed Draymond was in there, I didn't pay him any mind until he walks all the way across the line to look my girlfriend up and down and smirks at her. I still did not say a word to him. About 5 minutes later when everyone is outside, I see my roommate and Draymond talking, I walk over and I tell Draymond that last night wasn't cool. As he responded to me he began to poke me on my shoulder and I tell him that he doesn't need to put his hands on me, we can just talk. As I started to talk again, boom, I'm punched in my jaw. In front of all of my peers and friends.

As far as today, I'm not feeling the best. My neck and my jaw still hurts along with the headache that I've had since I was hit. I would like to take further action on this situation and I am willing to fully cooperate to get this situation taken care of.






