Comes now, Petitioner, JOHN WAYNE CONNER, by and through undersigned counsel, and prays that an Order be entered staying the execution of his sentence of death until further Order of this Court, and in support of his application, respectfully states as follows:

MOTION FOR STAY OF EXECUTION

- 1. Petitioner filed the instant action on July 14, 2016, requesting that this Court grant review of the Georgia Supreme Court's denial of relief as to his claims under the Eighth Amendment regarding the constitutionality of his death sentence and pending execution in light of the length of time (34 years) Petitioner has already spent on death row.
- 2. Georgia has now scheduled Petitioner's execution for July 14, 2016, at 7:00PM. Petitioner requests that the execution be stayed by this Court until the Petition for Writ of Certiorari is considered and finally acted upon.

- 3. The Superior Court of Telfair County, State of Georgia, set from noon on July 14, 2016, through noon on July 21, 2016, as the period during which Petitioner's execution may be carried out. *See* Exhibit A (execution warrant), attached. The execution is currently scheduled for today, July 14, 2016, at 7:00PM. The Georgia Board of Pardons and Paroles denied clemency yesterday, July 13, 2016.
- 4. A stay of execution is justified on the grounds that having already served 34 years in prison and witnessed as many of 65 of his fellow inmates go to their deaths, along with having endured other unique stresses of solitary confinement in the maximum security carceral environment of Georgia's death row, his execution in addition to this punishment would constitute a cruelty in violation of the Eighth Amendment.
- 5. A stay of execution will not prejudice the State of Georgia or interfere with Petitioner's custodial status.
- 6. A stay of execution is necessary to ensure that Petitioner is not executed before this Court is able to resolve the matters contained in the Petition for Writ of Certiorari. The execution of Petitioner would obviously inflict irreparable harm.

WHEREFORE, Petitioner respectfully requests an Order staying Petitioner's execution, pending resolution of the proceedings and further Order of this Court.
