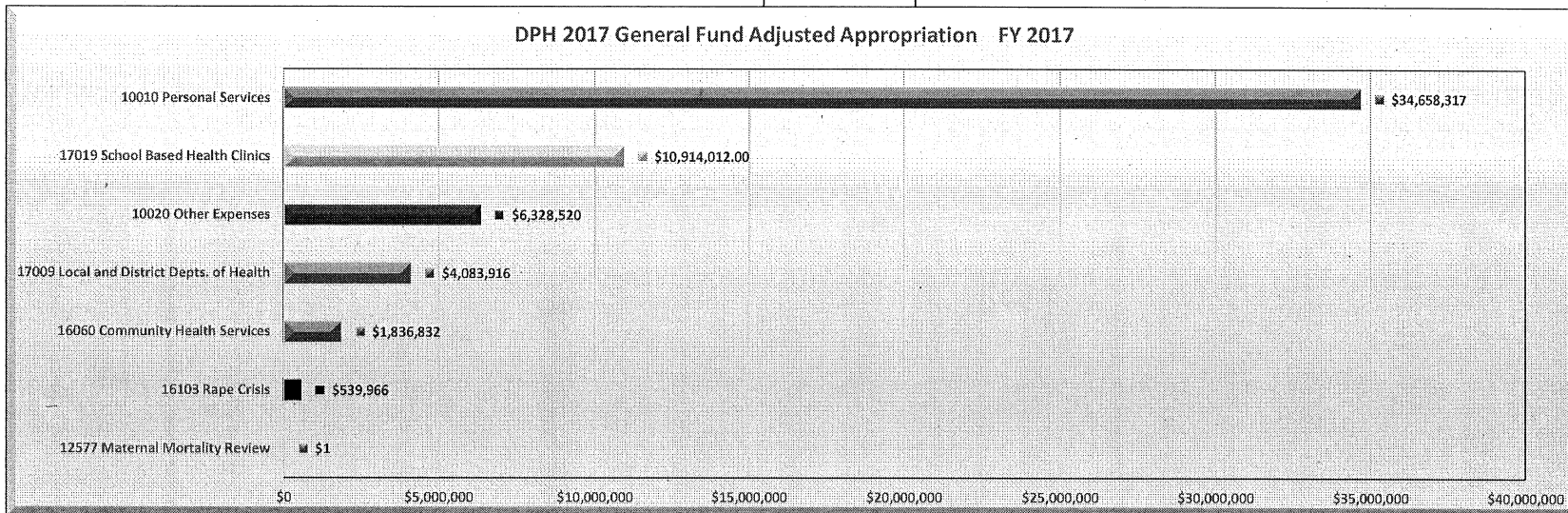

16060 Community Health Services	(\$171,683)	<p>Access New Haven Health Program: Funds are used to develop and administer a coordinated system of physicians, hospitals, and community organizations to provide donated specialty care for low-income, uninsured individuals. Patient navigation services help consumers access specialty care and diagnostic testing; includes translation services and assistance with completion of enrollment forms, reimbursement and other paper work. Program aims to reduce health inequities and support health reform while providing access to high quality specialty care immediately.</p> <p>Community Health Centers: Provide preventive and primary health care services to vulnerable community populations.</p>	<p>Reduction will result in reduced staff time by contractor performing patient navigation; fewer consumers will have access to free donated specialty care. 16103 Rape Crisis	(\$18,138)	<p>The Rape Crisis Services funds are use to reduce the annual rape or attempted rapes in Connecticut by providing free and confidential services such as: crisis intervention, support and advocacy, survivor groups, 24-hour hotline both in English and Spanish, emergency transportation, and medical, police and court accompaniment for sexual assault victims and their families through 9 statewide community-based rape crisis centers. The funds are also used to conduct training and technical assistance for Connecticut's colleges and university system for addressing sexual violence.</p>	Decreased funding will result in the reduction of services to victims of sexual violence.	Conn Alliance to End Sexual Violence -\$18,138.
17019 School Based Health Clinics	(\$366,621)	<p>School Based Health Centers: Funds are used to develop and administer School Based Health Center and Expanded School Health programs consisting of the provision of prevention, primary care and/ or behavioral health services and/or dental health services for students on the school site. School Based Health Centers serve a large Medicaid and underserved population, and allow students to access care while facilitating an immediate return to class. School Based Health Centers allow for the provision of primary care, behavioral health, and dental health services without the need for parents to miss time from work. Services consist of management of chronic conditions as well as urgent needs.</p>	Decreased funding will result in a combination of reduced staff, hours, services or sites.
