(COUNT 1) 21 O.S. 1685

SIMON MICHAEL MARTINEZ, on or about 12/23/2013, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of CRUELTY TO ANIMALS, a Felony, by unlawfully, feloniously, willfully, maliciously and cruelly shoot and kill an animal, to-wit: a German Shepherd named Sarge, in subjugation and the property of Lisa Dawn Martinez,

(COUNT 2) 21 O.S. 644(G)

SIMON MICHAEL MARTINEZ, on or about 12/23/2013, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of DOMESTIC ASSAULT & BATTERY IN THE PRESENCE OF A MINOR CHILD, a Misdemeanor, by unlawfully, willfully and wrongfully, commit an assault and battery upon the person of one Lisa Dawn Martinez a current spouse of the defendant by then and there pushing her to the ground with force and violence and with the unlawful intent to do her corporal hurt and bodily injury, while there was present then and there a minor child who could see or hear an act of domestic violence,

(COUNT 3) 21 O.S. 1289.11

SIMON MICHAEL MARTINEZ, on or about 12/23/2013, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of RECKLESS CONDUCT WITH FIREARM, a Misdemeanor, by unlawfully, willfully and wrongfully in conscious disregard for the safety of his family, did then and there engage in reckless conduct while having in his possession loaded Glock 9mm Semi-Automatic firearm in the following manner, to-wit: by discharging the firearm inside his home with children present, conduct creating a situation of unreasonable risk and probability of death or great bodily harm to the said family,
