	Speaking with resident, she stated that on Friday night, approximately 2030 hrs, she was in front of her apartment when her son, approached her and stated that he seen clowns in the woods whispering and making strange noises. advised that she went over to the area that her son mentioned and observed several crowns in the woods flashing green laser lights then ran away into the woods. Her eldest son, stated that he heard chains and banging on the front door of the residence on Saturday approximately 2030 hrs.														
	Speaking with another resident, stated that she was walking to her residence 0230 hrs this morning and saw a large-figured clown with a blinking nose, standing under a post light near the garbage dumpster area. She stated the suspect waved at her and she waved back while she made her way to her residence safely. The suspect did not approach her or harm her.														
l	Several children of the community stated that several clowns have been appearing in the woods behind building "D" and try to persuade them into the woods further by displaying large amounts of money. They advised that they believe the clowns stay in a house located near a pond at the end of a man-made trail in the woods.												ed
