Hey Guys,

Per your request, Attached is a revised Wisconsin budget pushed to the max. Below are my thoughts on why it is necessary.

There are a couple realities that we still face in Wisconsin even beyond the stand with Walker effort. Democrats are looking at all of their options to try to beat what he is doing and here's what they are.

1) Supreme Court - Right now there is 4-3 conservative majority on the Court. Justice David Prosser is up for reelection on April 5th. While he did very well in the primary (55%), there will now be a renewed fight for the spot because unions know that if they take their fight to the current court, they will lose. If they take it to a court with Joanne Kloppenberg, a liberal, on it, they will win. This could stop everything that Walker is trying to accomplish and they know it. Goes without saying, that would be a bad thing.

3) Recall elections - We are hearing that unions are prepared to dump millions into the recall efforts of 4 Republican seats that they believe they can flip. One thought is that Democrats will stay in Illinois until this can happen. As many as 9 recall efforts against republicans have been launched. They have 60 days to collect signatures, the Government Accountability Board then will certify within 31 days, then 6 weeks later you will have an election. If they are able to flip 3 seats, they will control the Senate. To put it into perspective, a typical State Senate budget in Wisconsin is roughly \$250,000-\$300,000 because they have a max donation of \$1,000 per person. This gives outside groups incredible influence in an election. If the unions spend \$2 million without a counter, they can likely buy a race.

On the Republican side - there have been recall efforts launched in virtually all the districts of senators who are eligible for recall. Bottom line, the most likely for recall would be Jim Holperin, Dave Hansen, and Bob Wirch (these are the three we have been running radio ads against).

4) 94th Assembly District - This is the seat vacated by the new Department of Administration Secretary. While it's not integral to the number of votes in Madison, it would effectively be the equivalent of Scott Brown, Chris Christie, or Bob McDonnell to send a message to Scott Walker and Republicans in the Legislature. A typical targeted Assembly seat will have a budget of \$100,000-125,000. Again, outside influence can go a very long way. This seat is in the La Crosse media market, which has per point cost of roughly \$25-30.

5) Budget fight - New word is that Dem Senators will only come back if they get amendments as part of the Budget Bill that Walker introduced this week and will likely get final passage in June. That gives us roughly 4 months of fights over similar issues. Walker put \$1 billion in cuts to local aid (counties, municipalities, and school districts) in this budget. You can already hear the words, "draconian" "it will

kill our schools." etc. We need to be ready to continuously get the word out about this budget. The liberals will not be done if the budget repair bill is passed.

On a Federal Level:

Despite all of the attention that is currently on Madison, we have one of the brightest and strongest conservative minds in America in Paul Ryan. A poll just released today shows him with an approval rating at 38 percent in his district. While he is doing the heavy lifting for our cause in Washington, we can't let him slip back home. Supporting him through educational efforts across the state will help him and our two vulnerable freshman members of Congress (Duffy, Ribble) to vote for the bill and be a champion for Congressman Ryan's Budget bill.

And don't forget, we have a chance to send a message to 76 year old Herb Kohl that it is time to retire. My guess is he will run again unless he really has to work at it. That's why letting citizens know who Herb Kohl is and what his voting record has been can be a great way to pick up another seat in Washington. Kohl can self fund, but just like Congressman Obey did at the last minute, when faced with a tough reelect after a long career, he will have to ask himself, "Is it worth it?"

And one more thing...Wisconsin's 8 electoral votes could actually go for a Republican. While Obama won handily, Gore and Kerry won by roughly 1%. Now you have a Republican Gov, a Republican Senator, Republican Legislature...this state is at worst, a purple state and at best, slightly red. The Republican candidate for president will have to make inroads in the midwest to win. With all of the focus on Wisconsin, why not put the resources into this state and kill two birds with one stone.

From an AFP Organization perspective:

We can keep pushing hard because the conservative side is fired up. Let's keep them active by constant communication and giving them things to do. There is a common theme from the people attending the bus tour, "Thank you for doing this, we only wish we could do more." Let's arm them with the facts through education means, let's keep them involved through regular meetings, tours, rallies, etc. These things are labor intensive and costly, but as we have seen in just the past two weeks, people are engaged and ready to go. With additional staff and resources, we can make the AFP chapter in Wisconsin twice as large as it was before Scott Walker became Governor.

Bottom line: It's storming in Madison. If conservatives can't weather this storm, it will only make the other side emboldened. If they can, their will be a shock wave across the nation about reducing the size of government and enacting long-term reforms that put our state and nation, back on a path to fiscal health.

I just locked in Eric O'Keefe to head up our national fundraising operations with donors we know from the Koch seminar and across the country as we discussed at the residence. As far as Fitzgerald, I would tell him the Governor will be raising 5 million plus under Wisconsin control.

After having been totally screwed by the U.S. Chamber I am more convinced than ever that we cannot put our fate in the hands of others. Their first negative add is finally going up this morning. 1.5 million in media available and it stalled. They likely have cost us any chance we had at keeping the court. They all start with "we are here to help." The problem is it's as much helping themselves as us, both in terms of skimming dollars for other efforts and skimming off of the buys. And then it's where when and how it is spent. That's reality. I have seen it happen on at least six occasions this year. The only way to succeed is as Reagan said trust but verify. Verification is we control the resources. As far as Reince entering the fray, in terms of the meeting suggested this week with them, us and Gillespie, ask yourself where the RNC has been on resources to underwrite the recall effort. Better yet, ask Jefferson. It's zero. Same story different day. Reince has raised a ton of dough on this for the RNC here. It may be as much as 7 figures.

With Eric now on board, I need the Governor on probably 7-8 trips to get us where we need to be along with some in-state stuff. It's the answer I have been waiting on and couldn't pressure time wise because I needed to raise half a million last week to run a flight of TV on Kloppenburg and try to do what the chamber was failing to do. That ad is up now under Citizens for a Strong America. Given that we have already raised 3 million for efforts in state from a variety of sources for the court, senate, and budget, I am not concerned that we can make our targets. What we don't need is donor confusion by the RSLC.

If you can't wait until we have an understanding with Nick and the RSLC, you are in effect committing to their program and control of our destiny. As I told you yesterday, the donors in the room will see our Governor, get the major ask for our program here, and will be off the table. Pretty simple math.


