BE IT REMEMBERED:

That STEVE KUNZWEILER, the duly elected and qualified District Attorney for Tulsa County, Oklahoma, who prosecutes in the name and by the authority of The State of Oklahoma, comes now into the District Court of Tulsa County, State of Oklahoma, and gives the Court to understand and be informed that:

(COUNT 1) 21 O.S. 711

BETTY JO SHELBY, on or about 9/16/2016, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of MANSLAUGHTER - FIRST DEGREE - HEAT OF PASSION, a Felony, The Defendant Betty Jo Shelby, a Tulsa Police Officer encountered Terence Tafford Crutcher in the vicinity of 2300 East 36th Street North in the City and County of Tulsa Oklahoma, and based upon Terence Tafford Crutcher's non-compliant actions and behavior, the Defendant's fear resulted in her unreasonable actions which led her to shooting Terence Tafford Crutcher with a handgun which thereby caused his death.

AND/OR IN THE ALTERNATIVE:

21 O.S. 711

BETTY JO SHELBY, on or about 9/16/2016, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of MANSLAUGHTER - FIRST DEGREE -RESISTING CRIMINAL ATTEMPT, a Felony, the Defendant, Betty Jo Shelby, a Tulsa Police Officer encountered Terence Tafford Crutcher in the vicinity of 2300 East 36th Street North in the City and County of Tulsa Oklahoma, and based upon Terence Tafford Crutcher's refusal to comply with her lawful orders, the Defendant unlawfully and unnecessarily shot Terrence Tafford Crutcher with her handgun which thereby caused his death.

Contrary to the form of the statutes in such cases made and provided, and against the peace and dignity of the State.
