

# Request for Proposals and Eligibility Criteria Focus area: District-Governed School Replication

Great Public Schools Now (GPSN) is a new independent nonprofit organization whose mission is to accelerate the growth and expansion of high quality public schools while significantly reducing the number of students attending chronically low performing schools in greater Los Angeles. GPSN will support the replication of successful public schools in communities of need, regardless of school governance type (charter, magnet, traditional, etc.). The organization is deeply rooted in the pursuit of educational equity – the belief that every child, irrespective of the zip code they live in, deserves a high-quality education that prepares them for college, career, and life. GPSN has undertaken discussions with potential partners, including the Los Angeles Unified School District as well as leaders in the nonprofit community, to serve students in poverty and communities of color.

GPSN investments will focus on four core areas:

- Community Engagement across Los Angeles
- Supporting Teachers and Leaders
- Replication of High Quality Schools Charter and District-Governed,
- Facilities Support for High Quality Charters that are expanding or adding schools

In the coming weeks, we will continue to issue clear guidelines on all of our investment areas, with the intention of providing grants to a wide variety of schools with diverse governance models. This set of guidelines is focused only on the area of supporting the replication of district-governed (LAUSD) schools.

### What is "Replication"?

GPSN is issuing this RFP for investment in up to five projects, to include planning and implementation funding in support of school leaders that have an established record of success serving high needs students (at least 80% FRL) and with a record of high performance, **to do more of what works**. That is, to open a second school, or significantly expand enrollment in their existing program, in order to serve more students in high quality learning environments.

This does not mean 'new' designs/programs, or integrating selected practices from successful schools into an existing school, or layering a successful model onto a struggling school as a 'turnaround' effort.


Examples: a successful magnet wants to expand from serving 500 students to 1000 students; a successful magnet in one area of town wants to open a second magnet in a different part of town within our target geographies; a successful pilot or traditional school wants to open a second school.

#### **ELIGIBILITY CRITERIA**

#### Geography

GPSN is focused on serving the academic needs of the approximately 160,000 students who are attending schools where 80% of the students do not meet grade level standards (based on 2015 CAASP data). The attached maps show ten geographic areas where students are most economically challenged, and the number of high quality education choices is the least accessible within LAUSD.

## **School Academic Performance**

GPSN will invest in replicating high quality public *schools that are adding significant enrollment capacity by expanding or adding new campuses.* At a minimum, the achievement thresholds are the following for the prior academic year for which data is available:

- 50% of the students in the existing school met or exceeded proficiency in ELA **OR** Math in the latest CAASPP school wide results, or
- The existing school scored significantly better than charter and district operated public schools that the students would otherwise attend in both Math and ELA, but no fewer than 25% of its students are performing at proficient levels.

#### **Student demographics**

GPSN will focus on investing in schools where at least 80% of the students qualify for a Free or Reduced Price Lunch (FRPL).

## TO APPLY FOR FUNDING

Great Public Schools Now will fund up to FIVE projects in this initial year of funding, with a target opening date of Fall 2017. The selection process and timeline are as follows:

# Funding Parameters for District-Governed School Replication – 2017 Round

- GPSN will award up to five **implementation grants** ranging from \$50,000 to \$250,000 annually for up to three years, based on meeting annual outcomes. The funding difference depends on whether it is an expansion of an existing program or replicating/opening a whole school. GPSN's mission is to accelerate the creation of the greatest number of high quality seats as fast as possible, and therefore projects that will serve a greater number of students will receive higher priority
- Implementation Grant applications will be evaluated by an independent Advisory Committee comprised of education leaders in Los Angeles; the Committee will make funding recommendations to the GPSN Board. Final decisions on funding will be made by the GPSN Board of Directors
- GPSN is agnostic about any particular model of governance, programmatic design or labor agreement
- Our aim is to ensure that the projects that advance are genuinely desired by the leaders wishing to replicate
- Grant monies must be allocated as directly to the schools and leaders as possible
- Magnets, pilots, traditional campuses are all welcome to apply
- GPSN will fund schools where leaders will have the autonomy to select and retain their teaching staffs while also staying aligned with state education law and previous agreements.
- GPSN will establish separate processes/funds to support district-governed and charter public schools, in recognition of the very different regulatory processes and logistical hurdles required to open charters, and to ensure equitable access to resources
- GPSN will only fund programs that are non-selective, and enroll SPED and ELL students at rates comparable to LAUSD averages.

In order to support applicants more fully, GPSN will fund up to five **Planning Grants** of \$20,000 to assist school teams in securing time to prepare applications, hire professional support, or support community outreach efforts. The instructions for submitting an application for a planning grant are included below. **Schools that do not receive a planning grant may still submit a full application for an implementation grant, if they meet the eligibility criteria and follow the guidelines for the full application, that will be published on November 21.**
