Good Afternoon Director Shiu,

I'm writing on behalf of a coalition of organizations including the Human Rights Campaign, the National Gay and Lesbian Task Force and the Center for American Progress to request a meeting in early January 2013 – depending on your schedule and availability I would suggest either January 7th, 8th or 9th as preliminary possibilities – to discuss what the Department is doing/plans to do to ensure that transgender employees of federal contractors are protected from workplace discrimination consistent with the EEOC's ruling in *Macy* and the sex discrimination prohibition in Executive Order 11246.
