Pursuant to the U.S. Freedom of Information Act ("FOIA") (5 U.S.C. § 552), please provide copies of:

- 1. All emails, memoranda, and (type- or handwritten) notes produced by the Office of Public Affairs between April 20, 2012 and present regarding media inquiries from Chris Geidner (a journalist for Metro Weekly and BuzzFeed) regarding OFCCP's enforcement of Executive Order 11246, specifically as it pertains to transgender workers and the Equal Employment Opportunity Commission's decision in *Macy v. Holder*, Appeal No. 0120120821 (EEOC April 20, 2012); and
- 2. Any type- or handwritten notes from the OFCCP's 2012 "Headquarters Committee" meetings* regarding the decision in *Macy v. Holder. Id.*
- * According to the *Memorandum of Understanding Between U.S. Department of Labor and Equal Employment Opportunity Commission*, 76 Fed. Reg. 71029 (Nov. 16, 2011), representatives from OFCCP and the EEOC's

headquarters are required to "meet not less than biannually to discuss topics of mutual interest to both agencies."

Should you determine that any records, or portions thereof, are responsive or potentially responsive to this request, but exempt from disclosure, I expect the release of all segregable portions of otherwise exempt material.

While not explicitly required by statute and as a matter of good faith, I ask ask that you provide an itemized, indexed inventory of every agency record or portion thereof responsive to this request which you asserts to be exempt from disclosure, accompanied by a detailed justification statement covering each refusal to release records or portions thereof in accordance with the indexing requirements of *Vaughn v. Rosen*, 484 F.2d 820 (D.C. Cir. 1973), *cert. denied*, 415 U.S. 977 (1974), as well as the name and address to whom an administrative appeal may be directed. Failure to do so may result in commencement of a FOIA action and a formal motion requesting production of a Vaughn index.

Because I am a member of the news media and this information is sought as part of a news-gathering effort and not for commercial use, I ask that you please waive any fees associated with this request.

As you know, there has been considerable attention recently toward the Labor Department's interpretation of EO 11246 and the *Macy* ruling (See: http://www.buzzfeed.com/chrisgeidner/obama-labor-department-officials-prevent-off-topic-questions-at-pu, http://www.buzzfeed.com/chrisgeidner/obamas-labor-department-refuses-to-say-if-its-protecting-tra, and http://www.buzzfeed.com/chrisgeidner/labor-department-refuses-to-answer-questions-on-transgender). To the extent that you are unable to produce copies of or otherwise make available all records requested immediately, please furnish whatever records are immediately available and the remainder of the records on a "rolling" basis as they become available for production. If your office has received other FOIA requests seeking any of these records, I ask that you please make those commonly requested records available concurrently.

Since I am a journalist and this information is of timely value, please provide records responsive to this letter in digital format and by e-mail, rather than in hard copy or by postal mail. Likewise, any questions or correspondence regarding this request should be directed to me by e-mail or telephone, rather than by routine mail or fax.

I look forward to your response within twenty (20) working days as required by statute.
