#### CITY COUNCIL 2016 ANSWERS TO QUESTIONS | Roger Flygare

1. Please identify the experience, knowledge and skills you believe that you possess which you could use in working as a City Councilmember, and specifically how they uniquely qualify you for this position. (150 Word Max.)

I have served on many boards and committees for private and non-profit corporations over the years. In so doing, I have developed a great respect for working collegially with fellow board members which I will take to the city council. However, it's okay to disagree but do so in a way to not lose sight of the working relationship that must exist in order to do the work for the citizens of the community. It's not about me, it's about the community. (see attached CONFIDENTIAL Exhi bits 1, 2 & 3)

#### 2. What is your understanding of the role of a council member? (150 Word Max.)

The City Council in their legislative role establishes law and policy by passing ordinances and resolutions. A council member must do the appropriate research to ensure compliance with any existing rule, regulation and law. They should share those results with council members in the sense of council economy in an open and transparent fashion. A city council member needs to be visible in the community at the numerous events that are held in Federal Way. As a resident of Federal Way since 1968, I have seen a tremendous change in our city. It's gone from rural to urban and is now headed towards becoming a 1<sup>st</sup> Class city. There is still plenty of challenge ahead but a city council that works together can make magic happen.

# 3. What ideas and suggestions do you have to enhance economic development in our downtown and around the City? (150 Word Max.)

The City of Federal Way is in the middle of reinventing itself from a bedroom community, what could be perceived as a Class B City, to a more core like city, like Kirkland for example, and turn itself into an Class A City. I support the idea of enticing a college or university to establish a branch campus here. Looking at the general makeup of Federal Way, I would think an institution of higher learning that embraces the themes that are found with Gonzaga, Seattle University, Pacific Lutheran University, might just be the avenue to pursue. Working with the City Council, I would like to find the exact place for such campus, whether it be the former Weyerhaeuser Campus or another suitable location. The city core as envisioned would be a great venue for a college campus, with the PAEC and associated amenities.

- 4. Please identify what you feel are the top opportunities and priorities for the future of the City how would you rank such issues, and how would you proceed with developing ideas and/or implementing them? (150 Word Max.)
- 1. University/College campus, Federal Way fits a certain demographic of higher education that is available and unique. See my previous comment on this subject.
- 2. Work with the new owners (IRG) of the Weyerhaeuser Campus to find a high tech and/or medical research organizations to locate in the campus. The tech and medical industry is booming once again and this would be a great opportunity.

3. If the Sonic sports arena being proposed for Seattle doesn't happen, perhaps the City of Federal Way could pursue aggressively the involved partnerships of that endeavor to look at Federal Way.

# 5. If appointed to the Council, what changes would you like to see? How would you go about making any change? (150 Word Max.)

Federal Way needs to rebrand itself...something that pops and resonates with people considering moving into the Puget Sound Region. Federal Way is poised to be the leader in new and relocating Washington residents with our favorable residential pricing of new, existing, and planned housing. However, there is one concern that I have and that is the rising crime rate. Having worked for over 30 years in the civil criminal justice system, we are seeing a rise in crime everywhere coupled with increasing mental illness, drug dependency, homelessness, et cetera. I would work hard with the police department to make sure we have the capability to not only respond but to eventually capture criminals who break into our homes, cars, steal mail, personal crimes such as assault and so forth.



# SETTING THE RECORD STRAIGHT!

This is a long explanation and if you get bored, go have a beer or something and come back!!

In 2011, I ran for the Federal Way City Council. I enjoyed my campaign, truncated as it was, for the Federal Way City Council. It provided a great look at the good and bad of our city. It was truncated because I fractured a bone in my left foot. No more doorbelling for me...that was around June, as I recall.

I met a lot of people that I hadn't previously known. The experience provided for some insightful conversations about what my neighbors, close by and far away, thought was important. My opponent, Susan Honda, was a better-known person than I was as I had pulled away from working on community issues to focus on my family and my career.

I knew my chances of winning were slim but the purpose of running was multifold. Winning wasn't necessarily the "be all, end all," of the experience. I wanted to reengage myself with the people of Federal Way...you know, feel the buzz!!

Running for office requires a modest amount of money that you're willing to throw away. I had saved up some money to do whatever I wanted to do with it, buy a new car, go on a long trip, do some home improvements...my choice. I decided to run for city council and use that money as seed money and feel out the process, et cetera.

Reflecting back on years gone by and issues that were important to me, my friends and their families, I had worked hard to stop a LEVEL FIVE SEXUAL PREDATOR TRANSITION HOUSING facility from being built in Federal Way in a family-oriented neighborhood. I wasn't going to let that happen.

I enlisted the support of neighbors and friends to write letters, attend meetings, and in a general sense PROTEST this potential hazard from being built in Federal Way.

We won!! It wasn't built in Federal Way. As I remember, they found a location in a more industrial-type zone in South Seattle, the SODO area as I recall.

YAY...one for the good guys!!

Before that, though, I had the wonderful opportunity to be a coach for my son's Steel Lake Little League (SLLL) team for several years. While coaching, it came to the league's attention that the ballfields they had used for many, many years was going to lose its lease.

They had reclaimed a former gravel pit that had played out its gravel deposits and turned a blight into something fun for families. But as time went on, the 99-year lease turned out not to be 99 years. I was informed that there was a clause that if the owner of the property determined that a use of higher value presented that the owner, with proper notice, could terminate the lease. We had roughly a year to find replacement fields.

Working with SLLL Board of Directors, I and others suggested that we work with the Federal Way Public Schools to update their meager ballfields to a standard that would meet Little League standards. We went to work remodeling, upgrading several elementary school ball fields and, in the end, we were successful. I think we used those ball fields for two years, maybe longer at some of the schools.

In the meantime, Mary Stanfield, Ron Brown and I worked with the County Council to see if they could help with finding suitable property. Peter von Reichbauer, other council members and Ron Sims put their heads together with the owner of the reclaimed gravel pit, another property owner, and the owner of what would be developed as ballfields off Military Road.

The complexity of deal I don't remember but I do know took a lot of work. Mary and I were at the so-called ribbon cutting with Pete and Ron. It was a day that I will never forget.

By the time the South County Ball Fields opened, I was no longer serving as coach or on the board, but attended a few games that my nephews played in at the new park. I like the new ball fields. Some of my former players went on to coach which made me feel like a proud father. But I will tell you that my involvement left me feeling good about our community. I still from time to time run into family members of those long ago little league teams.

YAY...another one for the good guys!!

Moving forward, in 2012, I was approached by people from the community, some friends with the local Democrats, to run for the State House of Representatives. Running for this office was an experience in and of itself as it required getting out into surrounding communities, not just Federal Way, which included some of Auburn, Algona, Pacific, Des Moines, Milton...in other words, a very large land mass.

I wasn't too daunted by the task because I had family in Auburn, Algona, Des Moines and friends in Milton and Pacific. I knew the area as I had lived here in South King County, Federal Way specifically, since 1968. My wife and I had briefly lived in Auburn before relocating close to her parents in unincorporated King County which is now Federal Way.

When you are involved in this level of local politics, it takes on a different sense of importance but to me it was still about community, bigger community, but still community of people I had a strong sense of belonging to, friends and family, and willing to make more friends as every day went by.

I will share with you that knocking on doors is terrifying for some office seekers but I am not afraid to make new friends. My wife Karla has always accused me of making friends on an elevator going from the 1st floor to the 10th floor of a building...sad but true. I like people. Everyone has something unique to offer and listening to people is something I enjoy...I guess it should because that's what I do for a living.

I am a trained professional court reporter and my job is to listen and write down every word that someone says. Sometimes they're mad, sometimes they are crying and visibly upset. I think it's those

people who feel like they've lost everything that jerk hard on my soul. I want to say something to calm them down but I can't. I just have to sit there and write down those sad stories.

Back to politics: When you run for a legislative office, everybody wants to talk to you and find out what you think about particular issues. Do you support this? Do you support that? Some of those issues had never occurred to me that I should or shouldn't support them...controversial issues...like minimum wage, gay marriage, and so on. It became apparent that I had a lot to learn. I met with HR people from companies, labor leaders, nonprofit entities that support alternative lifestyles, the list seemed endless.

If any of those groups liked you as a person and felt that you would have an open door to listen to their issues, you would get an endorsement and along with the endorsement comes a donation or a series of donations for your campaign.

Today, candidates for the State House will be spending over a quarter of a million dollars and the independent expenditures will be easily double that.

Back to my campaign: When interviewing with the King County Democrats, you had to fill out a questionnaire. I believe the same is true for the King County Republicans. They ask a lot of generic questions but there is usually one or two that will take you to the next level if you answer them correctly.

One of the questions had to do with military service. I listed that I had served two tours in Vietnam and had been given a Purple Heart for injuries sustained in a combat zone.

You would think that a good thing, right? I did. But little did I know that my Democratic opponent would make a really BIG DEAL out of the two tours statement. It turned out I used the wrong word.

After all, I was only in the military for a brief period, less than three years, March 1969 to September 1971, roughly 30 months. In that time, I had risen in rank from private to E-5 Specialist/Sergeant. I went through Basic Training at Fort Lewis for eight weeks, where I received a Certificate for Outstanding Trainee.

I was transferred to Fort Rucker, Alabama, where I was trained to be a helicopter mechanic also known as door gunner, roughly eleven weeks of intensive training, learning basic helicopter mechanics and how to use a 60-caliber machine gun. I was deployed to Germany where I was stationed at a World War II German Fighter Base. I was attached to the Commander's helicopter. I was there for a period long enough, evidently, to qualify for an Over Seas Bar, which I didn't know at the time. It seemed like a short time. It was an interesting time in Germany with many US Army personnel rotating out of Vietnam and bringing with them stories of the Vietnam War.

I deployed for Vietnam and arrived in early April 1970 and when I left it was sometime in March 1971. When I arrived at my duty station in Pleiku, Vietnam, at Camp Holloway (I was told it was named after the first helicopter pilot casualty in Vietnam), when checking in at battalion headquarters the personnel sergeant asked if anyone knew how to type as they needed help processing our large contingency in. I and several others helped out.

After the completion of getting everyone signed in, took most of the day, the sergeant seemed impressed with my typing skills and asked if I would like to be reassigned to Battalion Headquarters and attached to the personnel department. I was somewhat resistant to that as I wanted to do what I was trained for but after being told I would still be able to do some helicopter duty at Headquarters and that the Battalion Commander had already ordered that I was staying, I caved and said yes. That was the end of my helicopter duties as a mechanic or door gunner, if you will; however, I did get to ride in helicopters several times on battalion business, like to Saigon and Da Nang and other larger military bases in the Central Highlands.

The sergeant (Sergeant E-7 Royce X. Owen) that oversaw personnel, after he got to know me, asked if I would like to take on some additional duties which would take me to places off our base like over to the Air Force base...everybody wanted to go there as they had air conditioning, iced beer, a real restaurant, real food, real everything, even Vietnamese waitresses. I said sure, what would you like me to do. He said I want you to take over battalion payroll activities, which meant I had to crawl into a heavily armored vehicle and traipse over to the US Armed Forces Payroll Station which was like an hour's drive away. Well, that resulted in a pay raise too...I was now an E-4, corporal rank. I did that for a while and then he asked if I would like to become an E-5 and take on Sergeant of the Guard duties. I asked what that entailed and he explained that I would make sure everyone in our company turned out for their turn on the elevated towers and bunkers that were stationed around our base and check my guard squad to make sure they weren't asleep and if they needed anything, like coffee, water, whatever. Most of the time, it was coffee and cigarettes. I got another pay raise. I was now an E-5 sergeant.

It was during one of these night patrols was my job as Sergeant of the Guard where an airborne projectile of some sort exploded nearby and I was hit with shrapnel. I wasn't going to die but it was bleeding pretty good. My left arm was the worst. I went to the clinic, got stitches and pretty much resumed my regular duties except my little finger on my left hand was kind of messed up. It's still numb to this day.

Back to the "two tours" issue: I thought when I filled out the form that I had served two tours in Vietnam; well, in reality, I served two campaigns in Vietnam. I simply used the wrong word and there are still people today who think I embellished my military record. I can tell you I have no reason to embellish my record. I am proud of my military record and service in the US Army. I will apologize for inadvertently using the wrong word. They took that issue and blew it up to that I faked my Purple Heart. I can't tell you the sadness that hit me. It took a long while to overcome that sense of what had just happened to me. They had just driven an arrow through my heart. I wanted to crawl into a hole. I had no way to rebut this nefarious and hurtful false allegation that went into the entire universe of people where I live. People still bring it up today. It really hurts deep inside when I hear it. It brings on rage and anger. I have to calm myself and rationalize that my true friends know those area all lies.

Today, I serve as the Judge Advocate General and Service Officer for Veterans of Foreign War Post 1741 helping veterans with legal and medical problems.

So that, in a very long nut shell, is the truth, the whole truth and nothing but the truth SO HELP  $\mathsf{ME}$ GOD!!
