DIRECT COMPLAINT

COUNT 1: FIRST DEGREE MURDER, A
CLASS 1 DANGEROUS FELONY

COUNT 2: ARMED ROBBERY, A CLASS 2
DANGEROUS FELONY

The complainant herein personally appears and, being duly sworn, complains on information and belief against JASON DEREK BROWN, charging that in Maricopa County, Arizona:

COUNT 1:

JASON DEREK BROWN, on or about the 29th day of November, 2004, intending or knowing that his conduct would cause death, with premeditation caused the death of ROBERT KEITH PALOMARES, in violation of A.R.S. §§ 13-1101, 13-1105, 13-703, 13-702, 13-702.02, and 13-801.

The State of Arizona further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a .45 CALIBER SEMI-AUTOMATIC GUN, a deadly weapon or dangerous instrument, and/or the intentional or

knowing infliction of serious physical injury upon ROBERT KEITH PALOMARES, in violation of A.R.S. § 13-604(P).

OR IN THE ALTERNATIVE ~

JASON DEREK BROWN, on or about the 29th day of November, 2004, acting either alone or with one or more other persons, committed or attempted to commit Armed Robbery and in the course of and in furtherance of such offense, or immediate flight from such offense, JASON DEREK BROWN or another person caused the death of ROBERT KEITH PALOMARES, in violation of A.R.S. §§ 13-1105, 13-1101, 13-702.01, 13-702, and 13-801.


The State of Arizona further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a .45 CALIBER SEMI-AUTOMATIC GUN, a deadly weapon or dangerous instrument, and\or the intentional or knowing infliction of serious physical injury upon ROBERT KEITH PALOMARES, in violation of A.R.S. § 13-604(P).

COUNT 2:

JASON DEREK BROWN, on or about the 29th day of November, 2004, in the course of taking property of another from ROBERT KEITH PALOMARES and DUNBAR ARMORED SERVICES person or immediate presence and against ROBERT KEITH PALOMARES and DUNBAR ARMORED SERVICES will, used threats or force against ROBERT KEITH PALOMARES and DUNBAR ARMORED SERVICES, with the intent to coerce surrender of the property or to prevent resistance to JASON DEREK BROWN taking or retaining the property while JASON DEREK BROWN or an accomplice used or threatened to use a deadly weapon, dangerous instrument or simulated deadly weapon against ROBERT KEITH PALOMARES and DUNBAR ARMORED SERVICES, in violation of A.R.S. §§ 13-1901, 13-1904, 13-1902, 13-701, 13-702, 13-702.01, and 13-801.

The State of Arizona further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a .45 CALIBER SEMI-AUTOMATIC GUN, a deadly weapon or dangerous instrument, and\or the intentional or

knowing infliction of serious physical injury upon ROBERT KEITH PALOMARES and DUNBAR ARMORED SERVICES, in violation of A.R.S. § 13-604(P).
