NOTICE OF CONCERN

This is a Notice under *The Defamation Act 2005, Queensland*. This Concerns Notice informs Google Inc (the publisher) of the defamatory imputations about myself, Michael Ross Roberts (the aggrieved person) published in the Google search results. The imputations also pertain to my businesses, Rexxfield Pty Ltd and Masters & Jacks Pty Ltd doing business as Page1.me.

Imputations of Concern

The Google snippets and the cache of those snippets contain the following imputations that are defamatory:

- I am a murderer;
- I am a hangdog (i.e. guilty appearance; shamefaced.)
- I hired people to frame my ex-wife for murder;
- I am a bad father;
- I possessed and disseminated child pornography;
- I possessed and disseminated child torture material;
- I sexually abused minors;
- I committed rape;
- I am “on the lam” (i.e. on the run; a fugitive)
- I threatened to use liquid explosives to silence people;
- I engaged in charity scams;
- I harassed individuals online;
- I engaged in computer hacking;
- I engaged in extortion;
- I committed perjury;
- I am a liar;
- I am liar for the purposes of obtaining profit;
- I use my businesses to engage in extortion;
- I conspired to pervert the course of justice;

- I scammed women out of money;
- I am psychiatrically unstable;
- I engaged in cyber-terrorism;
- I engaged in witness tampering;
- I committed fraud;
- I committed adultery;
- I am stupid;
- I made death threats to Darren M Meade and to other people.

Harm Caused From the Publication of the Defamatory Imputations

The defamatory imputations are of the most serious nature and continue to cause harm to my reputation, cause hurt feelings and seriously affect my businesses, employment opportunities and ability to care for my children.

Offer to Make Amends

Provision is made for the publisher to make amends under *The Defamation Act 2005, Queensland, Division 1*.

15 Content of offer to make amends

(1) An offer to make amends--

(a) must be in writing; and

(b) must be readily identifiable as an offer to make amends under this division; and

(c) if the offer is limited to any particular defamatory imputations--must state that the offer is so limited and particularise the imputations to which the offer is limited; and

(d) must include an offer to publish, or join in publishing, a reasonable correction of the matter in question or, if the offer is limited to any particular defamatory imputations, the imputations to which the offer is limited; and

(e) if material containing the matter has been given to someone else by the publisher or with the publisher's knowledge--must include an offer to take, or join in taking, reasonable steps to tell the other person that the matter is or may be defamatory of the aggrieved person; and

(f) must include an offer to pay the expenses reasonably incurred by the aggrieved person before the offer was made and the expenses reasonably incurred by the aggrieved person in considering the offer; and

(g) may include any other kind of offer, or particulars of any other action taken by the publisher, to redress the harm sustained by the aggrieved person because of the matter in question, including (but not limited to)--

(i) an offer to publish, or join in publishing, an apology in relation to the matter in question or, if the offer is limited to any particular defamatory imputations, the imputations to which the offer is limited; or

(ii) an offer to pay compensation for any economic or non-economic loss of the aggrieved person; or

(iii) the particulars of any correction or apology made, or action taken, before the date of the offer.

Requested Amends

I request the following:

1. Google removes within a period of 28 days from receipt of this notice of concern all the defamatory matter from all its domains accessible in Australia.
2. Google permanently blocks all of the material containing the defamatory imputations from publication on ALL local domains of its search engine that are accessible in Australia.
3. Google publishes a retraction and apology in its search engine index.

4. Google makes an offer of financial compensation for injury to my reputation and feelings to be agreed upon through negotiation.
5. Google pays legal and submission expenses incurred through the preparation of this Concerns Notice.

Further Action

Correspondence for a *further particulars notice* can be sent to my physical address or email as listed on this Notice of Concern.

I will commence legal proceedings against Google for defamation if this notice of concern is ignored or if adequate amends are not made.

I look forward to a prompt response from Google.
