My argument about this is, according to their own policy 309.45.02 they are only allowed to take 50% of income once! Not pay off one debt and then take 50% for the next? For instance example A on other side. 50% of 20.80 is 10.40. You take the 50% (10.40) pay off the 9.64 then use the remainder for the next? As you can see not only do they keep pulling crap like this they simply claim a computer glitch & nothing we can do! To me it seems like straight up theft. If I were a store and I kept charging your credit card \$20 every week after you only made one purchase from me; then told you I won't refund your money because it has already been distributed or because there was a computer glitch; are you going to just roll over and say Oh well, my loss?

I hope you can see where my frustrations are coming from and can help me and many others here when we ask for your help? We can try to battle this from in here but it costs money. I know this sounds dumb but copies cost .154 a piece, and we must follow the chain of command. Now the chain of command can be 4-6 levels of chain. Now multiply that by 2-5 copies you must have for each level, and you can see how fast it becomes costly? When you only make 2let an hour and they take most of it, or whatever of it they feel

In writing & sending you this information I would like to express to you my gratitude for your time in this matter? I also want you to know I do not expect for you to get my money back for me or to perform some sort of miracle that will change prison life forever? I simply hope that if there is wrong doing, or blatant illegal activity going on here you can expose it and bring it to the spotlight it deserves. As I am being held accountable for my actions, I believe that if the DOC is ~~doing the same~~ ^{wrong doing,} they should be held to the same standards as anyone else in this state! They should not be allowed to put themselves above the law.

Also, and finally, I am writing this in cooperation with fellow inmates Jordan Berg, & Jeff Leiser. (and hopefully others who are writing you) I had sent a copy of one of my JOC's in a letter sent by Jordan Berg. I did not cover much of the JOC topic in this letter, because I felt Jordan & Jeff's correspondence covered that issue better? I am just trying to give a bigger picture or another angle to the ongoing situations going on here? Again, thank you for your time, and if you have any questions for me please ask?
