Count of Unsubmitted Sexual Assault Kits by Agency**

The Wisconsin Department of Justice’s Sexual Assault Kit Initiative (WiSAKI) has been working with local agencies to conduct a statewide inventory of sexual assault kits (SAKs) that were never sent to the Wisconsin State Crime Laboratory (WSCL) for forensic evidence testing. The following table provides the preliminary total of unsubmitted SAKs identified through this inventory process. These SAKs are currently held by Wisconsin’s law enforcement agencies and some hospitals with active sexual assault nurse examiner (SANE) programs. Final numbers of unsubmitted SAKs and SAKs to be tested will be available as the process of receiving SAKs from agencies and preparing to send them for testing at the external lab is completed.
