- 3. Should the Utah Education and Telehealth Network (UETN) charge public and higher education customers directly via a service fee rather than get funded by the state through the appropriations process?
- 4. Should the state's independent entities be required to adopt policies similar to the:

- a. Funds Consolidation Act; State Money Management Act; Revenue Procedures and Control Act; Budgetary Procedures Act; Procurement Code; Administrative Services Code; and the State Personnel Management Act?
- 5. The retirement systems and plans administered by the Utah Retirement Systems (URS):
  - a. An overview of the current benefits available for public employee URS members; and
  - b. A review of the Legislature's significant retirement reforms of 2010, including the creation of Tier II systems and plans and enactment of post-retirement reemployment restrictions.
- 6. Updates from URS and its consulting actuaries on:
  - a. Contribution rates;
  - b. Funding status;
  - c. Assumed investment rate of return; and
  - d. Investment performance.

## **Transportation**
